the otherwise lawful carrying or possession of a firearm under the provisions of Chapter 53 of this title shall not be punishable by any municipality or other political subdivision of this state as disorderly conduct, disturbing the peace, or similar offense against public order.

4. A public or private school may create a policy regulating
 the possession of knives on school property or in any school bus or
 vehicle used by the school for purposes of transportation.

B. No municipality or other political subdivision of this state
shall adopt any order, ordinance, or regulation concerning in any
way the sale, purchase, purchase delay, transfer, ownership, use,
keeping, possession, carrying, bearing, transportation, licensing,
permit, registration, taxation other than sales and compensating use
taxes, or other controls on firearms, knives, components,
accessories, attachments, ammunition, and supplies.

C. Except as hereinafter provided, this section shall not prohibit any order, ordinance, or regulation by any municipality concerning the confiscation of property used in violation of the ordinances of the municipality as provided for in Section 28-121 of Title 11 of the Oklahoma Statutes. Provided, however, no municipal ordinance relating to transporting a firearm or knife improperly may include a provision for confiscation of property.

D. When a person's rights pursuant to the protection of the preemption provisions of this section have been violated, the person shall have the right to bring a civil action against the persons, municipality, and political subdivision jointly and severally for injunctive relief or monetary damages or both.

E. As used in this section, air powered pistol or air powered rifle is any pistol or rifle that uses compressed air or other

1 compressed gas to project plastic BB-like or pellet-like projectiles
2 at a speed not exceeding 400 four hundred (400) feet per second.

<sup>3</sup> SECTION 2. NEW LAW A new section of law to be codified <sup>4</sup> in the Oklahoma Statutes as Section 1289.31 of Title 21, unless <sup>5</sup> there is created a duplication in numbering, reads as follows:

A. This act shall be known and may be cited as the "Firearm
 7 Accessory Protection Act".

B. Certified peace officers of this state shall not confiscate
 nor enforce any ban on the sale, transfer, use, or possession of
 bump stocks, arm braces, or any other attachment or accessory added
 to a firearm.

12 C. Any person who has had his or her ability to sell, transfer, 13 use, or possess a bump stock, arm brace, or any other attachment or 14 accessory impeded by a certified peace officer may file a civil 15 action against the agency, department, or organization responsible 16 for the conduct of the certified peace officer for damages incurred 17 due to the impediment.

SECTION 3. This act shall become effective November 1, 2024.
