19	election conducted by any county election board unless such person								
20	is a registered voter, unless otherwise provided by law.								
21	B. Beginning with the 2025 election cycle, all eligible voters								
22	shall reregister to vote and provide proof of United States								
23	citizenship and proof of current residence to the appropriate county

3	C. Any voter who fails to reregister pursuant to subsection \underline{B}							
4	of this section but who meets the requirements set forth in the							
5	National Voter Registration Act of 1993, shall be placed on a							
6	Federal Election Only list and shall not be eligible to vote in any							
7	local or state election.							
8	D. As used in this section, "proof of United States							
9	citizenship" means one of the following documents:							
10	1. An original birth document issued by a state, the District							
11	of Columbia, or any commonwealth or territory of the United States							
12	or a certified copy thereof;							
13	2. An original birth certificate issued by the federal							
14	government or a certified copy thereof;							
15	3. An original Consular Report of Birth Abroad or certified							
16	<pre>copy thereof;</pre>							
17	4. An original Certificate of Citizenship (Form N-560 or N-561)							
18	or certified copy thereof;							
19	5. An original Certificate of Naturalization (Form N-550, N-570							
20	or N-578) or certified copy thereof; or							
21	6. A valid United States passport.							
22	Copies of such documents shall be made by the appropriate county							
23	election board and kept available for public inspection pursuant to
