This section does not prohibit or diminish the rights of 4 5 private parties to enact regulations as created by valid private covenants or other contractual agreements among property owners 6 7 relating to residential building design elements including restrictive covenants and declarations such as those maintained by 8 9 owners' associations in real estate developments as created under 10 Section 851 et seq. of Title 60 of the Oklahoma Statutes or under 11 Section 501 et seq. of Title 60 of the Oklahoma Statutes.

12 SECTION 2. It being immediately necessary for the preservation 13 of the public peace, health or safety, an emergency is hereby 14 declared to exist, by reason whereof this act shall take effect and 15 be in full force from and after its passage and approval.
