7	An Act relating to motor vehicle taxes and fees; amending 47 O.S. 2011, Section 1132, as amended by
8	Section 2, Chapter 337, O.S.L. 2012 (47 O.S. Supp. 2016, Section 1132), which relates to registration
9	fees; creating specific fee schedule for motorcycles used on public roads; clarifying in lieu status of
10	certain registration fee; and providing an effective date.

13	BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:
14	SECTION 1. AMENDATORY 47 O.S. 2011, Section 1132, as
15	amended by Section 2, Chapter 337, O.S.L. 2012 (47 O.S. Supp. 2016,
16	Section 1132), is amended to read as follows:
17	Section 1132. A. For all vehicles, unless otherwise
18	specifically provided by the Oklahoma Vehicle License and
19	Registration Act, a registration fee shall be assessed at the time
20	of initial registration by the owner and annually thereafter, for
21	the use of the avenues of public access within this state in the
22	following amounts:
23	1. For the first through the fourth year of registration in
24	this state or any other state, Eighty-five Dollars (\$85.00);

1 2. For the fifth through the eighth year of registration in this state or any other state, Seventy-five Dollars (\$75.00); 2 3. For the ninth through the twelfth year of registration in 3 this state or any other state, Fifty-five Dollars (\$55.00); 4 5 4. For the thirteenth through the sixteenth year of registration in this state or any other state, Thirty-five Dollars 6 (\$35.00); and 7 5. For the seventeenth and any following year of registration 8 9 in this state or any other state, Fifteen Dollars (\$15.00). 10 The registration fee provided for in this subsection shall be in lieu of all other taxes, general or local, unless otherwise 11 12 specifically provided. For all motorcycles, a registration fee shall be assessed at 13 В. the time of initial registration by the owner and annually 14 15 thereafter, for the use of the avenues of public access within this 16 state in the following amounts: 1. For the first through the fourth year of registration in 17 this state or any other state, Seventy-nine Dollars (\$79.00); 18 2. For the fifth through the eighth year of registration in 19 this state or any other state, Sixty-nine Dollars (\$69.00); 20 3. For the ninth through the twelfth year of registration in 21 this state or any other state, Fifty-nine Dollars (\$59.00); 22 23 24

1	4. For the thirteenth through the sixteenth year of
2	registration in this state or any other state, Thirty-five Dollars
3	(\$35.00); and
4	5. For the seventeenth and any following year of registration
5	in this state or any other state, Fifteen Dollars (\$15.00).
6	Except for the fee provided for in Section 1132.6 of this title,
7	the registration fee provided for in this subsection shall be in
8	lieu of all other taxes, general or local, unless otherwise
9	specifically provided.
10	<u>C.</u> For all-terrain vehicles and motorcycles used exclusively
11	for use off roads or highways purchased on or after July 1, 2005,
12	and for all-terrain vehicles and motorcycles used exclusively for
13	use off roads or highways purchased prior to July 1, 2005, which the
14	owner chooses to register pursuant to the provisions of Section
15	1115.3 of this title, an initial and nonrecurring registration fee
16	of Eleven Dollars (\$11.00) shall be assessed at the time of initial
17	registration by the owner. Nine Dollars (\$9.00) of the registration
18	fee shall be deposited in the Oklahoma Tax Commission Reimbursement
19	Fund. Two Dollars (\$2.00) of the registration fee shall be retained
20	by the motor license agent. The fees required by subsection $A$
21	subsections A or B of this section shall not be required for all-
22	terrain vehicles or motorcycles used exclusively off roads and
23	highways.

1 C. D. For utility vehicles used exclusively for use off roads or highways purchased on or after July 1, 2008, and for utility 2 3 vehicles used exclusively for use off roads or highways purchased prior to July 1, 2008, which the owner chooses to register pursuant 4 5 to the provisions of Section 1115.3 of this title, an initial and nonrecurring registration fee of Eleven Dollars (\$11.00) shall be 6 assessed at the time of initial registration by the owner. Nine 7 Dollars (\$9.00) of the registration fee shall be deposited in the 8 9 Oklahoma Tax Commission Reimbursement Fund. Two Dollars (\$2.00) of 10 the registration fee shall be retained by the motor license agent. 11 The fees required by <del>subsection A</del> subsections A or B of this section 12 shall not be required for utility vehicles used exclusively off 13 roads and highways.

14D. E.There shall be a credit allowed with respect to the fee15for registration of a new vehicle which is a replacement for:

A new original vehicle which is stolen from the
purchaser/registrant within ninety (90) days of the date of purchase
of the original vehicle as certified by a police report or other
documentation as required by the Oklahoma Tax Commission; or

2. A defective new original vehicle returned by the
21 purchaser/registrant to the seller within six (6) months of the date
22 of purchase of the defective new original vehicle as certified by
23 the manufacturer.

1 The credit shall be in the amount of the fee for registration 2 which was paid for the new original vehicle and shall be applied to 3 the registration fee for the replacement vehicle. In no event will 4 the credit be refunded.

5 E. F. Upon every transfer or change of ownership of a vehicle, the new owner shall obtain title for and, except in the case of 6 salvage vehicles and manufactured homes, register the vehicle within 7 thirty (30) days of change of ownership and pay a transfer fee of 8 9 Fifteen Dollars (\$15.00) in addition to any other fees provided for 10 in this act. No new decal shall be issued to the registrant. Thereafter, the owner shall register the vehicle annually on the 11 12 anniversary date of its initial registration in this state and shall pay the fees provided in subsection A of this section and receive a 13 decal evidencing such payment. Provided, used motor vehicle dealers 14 shall be exempt from the provisions of this section. 15

F. G. In the event a new or used vehicle is not registered, 16 titled and tagged within thirty (30) days from the date of transfer 17 of ownership, the penalty for the failure of the owner of the 18 vehicle to register the vehicle within thirty (30) days shall be One 19 Dollar (\$1.00) per day, provided that in no event shall the penalty 20 exceed One Hundred Dollars (\$100.00). No penalty shall be waived by 21 the Oklahoma Tax Commission or any motor license agent except as 22 provided in subsection C of Section 1127 of this title. Of each 23 dollar penalty collected pursuant to this subsection: 24

1	1. Twenty-one cents (\$0.21) shall be apportioned as provided in
2	Section 1104 of this title;
3	2. Twenty-one cents (\$0.21) shall be retained by the motor
4	license agent; and
5	3. Fifty-eight cents (\$0.58) shall be deposited in the General
6	Revenue Fund.
7	SECTION 2. This act shall become effective November 1, 2017.
