6 An Act relating to public finance; amending 62 O.S.
7 2011, Section 34.6, as last amended by Section 1,
8 Chapter 342, O.S.L. 2013 (62 O.S. Supp. 2018, Section
9 34.6), which relates to the Oklahoma State Finance
10 Act; requiring that the Director of the Office of
11 Management and Enterprise Services conduct a training
12 program for certain state employees under specified
13 circumstances; providing time limit for completion of
14 training program; and providing an effective date.

15 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

16 SECTION 1. AMENDATORY 62 O.S. 2011, Section 34.6, as
17 last amended by Section 1, Chapter 342, O.S.L. 2013 (62 O.S. Supp.
18 2018, Section 34.6), is amended to read as follows:

19 Section 34.6. A. The Director of the Office of Management and
20 Enterprise Services shall have the power and duty under the
21 direction of the Governor to:

22 1. Prepare the budget document and assist in the drafting of
23 legislation to make it effective;

24 2. Make field surveys and studies of governmental agencies,
looking toward economy and greater efficiency;

3. Make allotments to control expenditures;

1 4. Authorize transfers of appropriation authorized by law;

2 5. Study accounting and other reports rendered by the Central
3 Accounting and Reporting Division;

4 6. Enter into agreements with the United States Secretary of
5 the Treasury for the purpose of implementing federal law;

6 7. Aid the Governor in the economical management of state
7 affairs; ~~and~~

8 8. Conduct training that provides an overview of state finance
9 policies and procedures for state agency employees upon their
10 initial appointment to a position that includes performing state
11 finance and budget functions. Such employees shall complete the
12 training within six (6) months of assuming such position; and

13 9. Adopt such rules and regulations concerning the exercise of
14 powers and duties as the Director shall deem appropriate, in
15 accordance with the Administrative Procedures Act.

16 B. In addition to other duties, the Director of the Office of
17 Management and Enterprise Services shall, upon request, advise and
18 consult with members of the Legislature and legislative committees
19 concerning revenue and expenditures of state agencies.

20 C. Not later than December 31, 2013, the Director of the Office
21 of Management and Enterprise Services shall provide the Legislature
22 with a proposal to consolidate, streamline, and reduce the size of
23 the administrative code of the agencies consolidated pursuant to
24 House Bill No. 2140 of the 1st Session of the 53rd Oklahoma

1 Legislature. The recommendation shall contain the Director's advice
2 on the possibility of consolidating the affected code into a single
3 title.

4 SECTION 2. This act shall become effective November 1, 2019.
