7 An Act relating to the Office of Management and
8 Enterprise Services; amending 62 O.S. 2011, Section
9 34.6, as last amended by Section 1, Chapter 342,
10 O.S.L. 2013 (62 O.S. Supp. 2019, Section 34.6), which
11 relates to powers and duties of the director;
12 deleting obsolete language; requiring daily reporting
13 of expenditures of funds from the CARES Act; and
14 declaring an emergency.

15 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

16 SECTION 1. AMENDATORY 62 O.S. 2011, Section 34.6, as
17 last amended by Section 1, Chapter 342, O.S.L. 2013 (62 O.S. Supp.
18 2019, Section 34.6), is amended to read as follows:

19 Section 34.6. A. The Director of the Office of Management and
20 Enterprise Services shall have the power and duty under the
21 direction of the Governor to:

22 1. Prepare the budget document and assist in the drafting of
23 legislation to make it effective;

24 2. Make field surveys and studies of governmental agencies,
looking toward economy and greater efficiency;

3. Make allotments to control expenditures;

1 4. Authorize transfers of appropriation authorized by law;

2 5. Study accounting and other reports rendered by the Central
3 Accounting and Reporting Division;

4 6. Enter into agreements with the United States Secretary of
5 the Treasury for the purpose of implementing federal law;

6 7. Aid the Governor in the economical management of state
7 affairs; and

8 8. Adopt such rules and regulations concerning the exercise of
9 powers and duties as the Director shall deem appropriate, in
10 accordance with the Administrative Procedures Act.

11 B. In addition to other duties, the Director of the Office of
12 Management and Enterprise Services shall, upon request, advise and
13 consult with members of the Legislature and legislative committees
14 concerning revenue and expenditures of state agencies.

15 ~~C. Not later than December 31, 2013, the Director of the Office~~
16 ~~of Management and Enterprise Services shall provide the Legislature~~
17 ~~with a proposal to consolidate, streamline, and reduce the size of~~
18 ~~the administrative code of the agencies consolidated pursuant to~~
19 ~~House Bill No. 2140 of the 1st Session of the 53rd Oklahoma~~
20 ~~Legislature. The recommendation shall contain the Director's advice~~
21 ~~on the possibility of consolidating the affected code into a single~~
22 ~~title~~

23 The Director of the Office of Management and Enterprise Services
24 shall publish daily reports of all expenditures of funds from the

1 Coronavirus Aid, Relief, and Economic Security (CARES) Act on the
2 Oklahoma Checkbook page on the state website.

3 SECTION 2. It being immediately necessary for the preservation
4 of the public peace, health or safety, an emergency is hereby
5 declared to exist, by reason whereof this act shall take effect and
6 be in full force from and after its passage and approval.
