6 AS INTRODUCED

7 An Act relating to virtual charter schools; requiring  
8 each virtual charter school to create and administer  
9 certain inventory system; requiring inventory system  
10 to include certain items; requiring the inventory  
11 system to include the names and grade levels of  
12 students provided certain items; requiring certain  
13 items to be returned to the virtual charter school  
14 upon certain event; requiring the parent or legal  
15 guardian of a student to be responsible for the cost  
16 of certain unreturned items; requiring a copy of  
17 certain inventory system to be submitted to the  
18 Statewide Virtual Charter School Board by certain  
19 date; providing for codification; providing an  
20 effective date; and declaring an emergency.

21 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

22 SECTION 1. NEW LAW A new section of law to be codified  
23 in the Oklahoma Statutes as Section 3-145.9 of Title 70, unless  
24 there is created a duplication in numbering, reads as follows:

25 A. It shall be the duty of each virtual charter school approved  
26 and sponsored by the Statewide Virtual Charter School Board pursuant  
27 to the provisions of Section 3-145.3 of Title 70 of the Oklahoma  
28 Statutes to create and administer an inventory system for all

1 educational supplies paid for by state-appropriated funds, including  
2 but not limited to:

- 3 1. Textbooks;
- 4 2. Electronic textbooks;
- 5 3. Desktop computers;
- 6 4. Laptop computers;
- 7 5. Electronic tablets;
- 8 6. Printers; and
- 9 7. Multimedia materials.

10 B. 1. The inventory system shall include the name and grade  
11 level of any student to whom items listed in subsection A of this  
12 section have been provided.

13 2. A student to whom items listed in subsection A of this  
14 section have been provided shall return the items to the virtual  
15 charter school prior to graduating from the virtual charter school  
16 or transferring to another virtual charter school, a public charter  
17 school or a public school district.

18 3. If items provided to a student are not returned to the  
19 virtual charter school as required in this subsection, the parent or  
20 legal guardian shall be responsible for the cost of such items and  
21 shall remit payment to the virtual charter school.

22 C. Each virtual charter school shall submit a copy of the  
23 inventory system required by this section to the Statewide Virtual  
24

1 Charter School Board by December 31, 2019, and each December 31  
2 thereafter.

3 SECTION 2. This act shall become effective July 1, 2019.

4 SECTION 3. It being immediately necessary for the preservation  
5 of the public peace, health or safety, an emergency is hereby  
6 declared to exist, by reason whereof this act shall take effect and  
7 be in full force from and after its passage and approval.
