7	An Act relating to the Oklahoma Historical Society; creating the Oklahoma Museum of Popular Culture
8	Supplemental Revolving Fund; stating source of funds; providing for expenditures; requiring certain
9	determination by the State Treasurer; requiring transfer of funds if certain determination is not
10	made by certain date; providing for codification; and declaring an emergency.

13	BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:
14	SECTION 1. NEW LAW A new section of law to be codified
15	in the Oklahoma Statutes as Section 2294.1 of Title 62, unless there
16	is created a duplication in numbering, reads as follows:
17	There is hereby created in the State Treasury a revolving fund
18	for the Oklahoma Historical Society, to be designated the "Oklahoma
19	Museum of Popular Culture Supplemental Revolving Fund". The fund
20	shall be a continuing fund, not subject to fiscal year limitations,
21	and shall consist of all monies received by the Oklahoma Historical
22	Society from appropriations of the Legislature designated for
23	deposit in this fund. All monies accruing to the credit of the fund
24	are hereby appropriated and shall be budgeted and expended to

1 provide funding for repairs, planning, staging, refurbishments, and 2 improvements to real and personal property, and for funding for construction of the Oklahoma Museum of Popular Culture. No 3 expenditures shall be made from the fund until the State Treasurer 4 5 determines that funds provided by local and county governments, the federal government, or through monetary donations in the amount of 6 Eighteen Million Dollars (\$18,000,000.00) are made for repairs, 7 planning, staging, refurbishments, and improvements to real and 8 9 personal property, and for funding for construction of the Oklahoma Museum of Popular Culture; provided, no funds collected or received 10 prior to the effective date of this act shall be counted towards the 11 12 amount. Expenditures from the fund shall be made upon warrants 13 issued by the State Treasurer against claims filed as prescribed by law with the Director of the Office of Management and Enterprise 14 Services for approval and payment. On November 15, 2024, if no 15 determination is made by the Treasurer pursuant to the provisions of 16 17 this section authorizing expenditures from this fund, all unencumbered funds remaining in the Oklahoma Museum of Popular 18 Culture Supplemental Revolving Fund shall be transferred to the 19 State Treasurer for deposit in the General Revenue Fund of the State 20 Treasury for the fiscal year ending June 30, 2024. 21

22 SECTION 2. It being immediately necessary for the preservation 23 of the public peace, health or safety, an emergency is hereby
