An Act relating to taxicabs; amending 47 O.S. 2011, Section 1-174, which relates to taxicabs; modifying definition; and providing an effective date.

SUBJECT: Taxicabs

BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

SECTION 1. AMENDATORY 47 O.S. 2011, Section 1-174, is amended to read as follows:

Section 1-174. Taxicab shall mean and include any motor vehicle for hire, designed to carry ten eight (8) persons or less, operated upon any street or highway, or on call or demand, accepting or soliciting passengers indiscriminately for transportation for hire between such points along streets or highways as may be directed by the passenger or passengers so being transported. This classification shall not include:

1. Motor vehicles of ten <u>eight</u>-passenger capacity or less operated by the owner where the cost of operation is shared by fellow workmen between their homes and the place of regular daily employment, when not operated for more than two trips per day; 2. Motor vehicles operated by the owner where the cost of operation is shared by the passengers on a "share the expense plan";  $\frac{1}{2}$  or

3. Motor vehicles transporting students from the public school system when said the motor vehicle is so transporting under contract with public, private, or parochial school board or governing body, or

4. Motor vehicles operating pursuant to the Oklahoma Transportation Network Company Act as provided for in Section 1011 of this title.

SECTION 2. This act shall become effective November 1, 2017.
