An Act relating to militia; creating a petty cash fund for the Oklahoma Military Department; describing purposes; authorizing the Director of the Office of Management and Enterprise Services to establish certain procedures; providing for codification; and providing an effective date.

SUBJECT: Oklahoma Military Department

BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

SECTION 1. NEW LAW A new section of law to be codified in the Oklahoma Statutes as Section 28 of Title 44, unless there is created a duplication in numbering, reads as follows:

There is hereby created a petty cash fund for programs of the Oklahoma Military Department, including but not limited to billeting funds, youth programs and military awards and decoration programs, the sum of which shall be determined as agreeable to the Oklahoma Military Department and the Director of the Office of Management and Enterprise Services. The Director shall establish procedures for the administration of this petty cash fund.

SECTION 2. This act shall become effective November 1, 2017.
