16	BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:
17	SECTION 1. AMENDATORY 74 O.S. 2011, Section 150.2, as
18	amended by Section 7, Chapter 397, O.S.L. 2015 (74 O.S. Supp. 2016,
19	Section 150.2), is amended to read as follows:
20	Section 150.2. The Oklahoma State Bureau of Investigation shall
21	have the power and duty to:
22	1. Maintain a nationally accredited scientific laboratory to
23	assist all law enforcement agencies in the discovery and detection
24	of criminal activity;

2. Maintain fingerprint and other identification files
 including criminal history records, juvenile identification files,
 and DNA profiles;

3. Establish, coordinate and maintain the automated

7 4. Operate teletype, mobile and fixed radio or other8 communications systems;

9 5. Conduct schools and training programs for the agents, peace 10 officers, and technicians of this state charged with the enforcement 11 of law and order and the investigation and detection of crime;

Narcotics and Dangerous Drugs Control, the Chief Medical Examiner,
and all law enforcement officers and district attorneys when such

9. Investigate any criminal threat made to the physical safety
 of elected or appointed officials of this state or any political
 subdivision of the state and forward the results of that
 investigation to the Department of Public Safety, and provide
 security to foreign elected or appointed officials while they are in
 this state on official business;

7 10. Investigate and detect violations of the Oklahoma Computer
8 Crimes Act; and

9 11. Investigate and enforce all laws relating to any crime 10 listed in Section 571 of Title 57 of the Oklahoma Statutes that 11 occur on the turnpikes; and

12 12. Investigate all law enforcement- or peace officer-involved shootings and in-custody deaths, not including jails or prisons for 13 all jurisdictions within the state with a population of less than 14 one hundred fifty thousand (150,000), according to the latest 15 16 federal decennial census. All law enforcement- or peace officerinvolved shootings and in-custody deaths, not involving jails or 17 prisons that occur within jurisdictions in the state with a 18 population of more than one hundred fifty thousand (150,000), 19 according to the latest federal decennial census, shall be subject 20 to review by the Oklahoma State Bureau of Investigation at the 21 discretion of the Oklahoma State Bureau of Investigation. 22 23

1 SECTION 2. NEW LAW A new section of law to be codified in the Oklahoma Statutes as Section 150.12C of Title 74, unless 2 3 there is created a duplication in numbering, reads as follows: Reports required for officer-involved injuries or deaths. 4 5 Α. In this act: "Deadly weapon" means: 6 1. 7 a firearm or any object manifestly designed, made or a. adapted for the purpose of inflicting death or serious 8 9 bodily injury, or b. any object that in the manner of its use or intended 10 11 use is capable of causing death or serious bodily 12 injury; and "Officer-involved injury or death" means an incident during 13 2. which a peace officer discharges a firearm causing injury or 14 15 death to another. The Oklahoma State Bureau of Investigation shall promulgate 16 Β. rules establishing procedures for reporting by law enforcement 17 agencies of an officer-involved injury or death. The Oklahoma State 18 Bureau of Investigation shall promulgate a form with spaces for the 19 recording of the following information: 20 1. The date and time on which the incident occurred; 21 2. The jurisdiction where the incident occurred; 22 The age, gender and race or ethnicity of each peace officer 23 3. involved in the incident; 24

4. The age, gender and race or ethnicity of each injured or
 2 deceased person involved in the incident;

3 5. Whether the person was injured or died as a result of the 4 incident;

5 6. Whether each injured or deceased person used, exhibited, or6 was carrying a deadly weapon during the incident;

7 7. Whether any peace officer involved in the incident was
8 injured or died as a result of the incident;

9 8. Whether each peace officer involved in the incident was on10 duty during the incident;

9. Whether each peace officer involved in the incident worked
 for the jurisdiction where the incident occurred as a full-time
 peace officer or reserve officer;

14 10. The primary reason for contact with each injured or 15 deceased person involved in the incident;

16 11. The law enforcement agency responsible for investigating 17 the incident; and

18 12. The years of service of each peace officer involved in the 19 incident.

C. Not later than the thirtieth day after the date of an officer-involved injury or death, the law enforcement agency employing an officer involved in the incident shall complete and submit a written or electronic report, using the form created under

subsection B of this section, to the Oklahoma State Bureau of
 Investigation.

3 D. Not later than the fifth day after the date of receipt of a 4 report submitted under subsection C of this section, the Oklahoma 5 State Bureau of Investigation shall post a copy of the report on the 6 agency's Internet website.

F. Not later than February 1 of each year, the Oklahoma State Bureau of Investigation shall submit a report regarding all officerinvolved injuries or deaths that occurred during the preceding year to the Governor, President Pro Tempore of the Senate, the Speaker of the House of Representatives and the standing legislative committees with primary jurisdiction over criminal justice matters. The report must include:

The total number of officer-involved injuries or deaths;
 A summary of the reports submitted to the agency under this
 act; and

17 3. A copy of each report submitted to the agency under this18 article.

F. Not later than February 1, 2018, the Oklahoma State Bureau of Investigation shall create the reporting forms required under this act.

 SECTION 3. This act shall become effective November 1, 2017.
