13	BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:
14	SECTION 1. AMENDATORY 37 O.S. 2011, Section 563.1, as
15	amended by Section 127, Chapter 304, O.S.L. 2012 (37 O.S. Supp.
16	2014, Section 563.1), is amended to read as follows:
17	Section 563.1. A. There is hereby created in the State
18	Treasury a revolving fund for the Oklahoma Department of Commerce
19	Agriculture, Food, and Forestry to be designated the "Oklahoma
20	Viticulture and Enology Center Development Revolving Fund".
21	B. The fund shall be a continuing fund, not subject to fiscal
22	year limitations, and shall consist of all monies distributed to the
23	fund:
24	

- 1 1. From the apportionment provided in paragraph 1 of Section 2 563 of this title; and
- 2. From any other source in accordance with state and federal law.
 - C. All monies accruing to the credit of the fund are hereby appropriated and may be budgeted and expended by the Department for the purpose of:
- 8 1. Establishing a Viticulture and Enology Center on the campus 9 of Redlands Community College;
- Developing viticulture-related and enology-related education
 programs;
 - 3. Developing technologies, strategies, or practices that aid in the production of grapes and wine in Oklahoma; and
- 4. Increasing the positive economic impact of the Oklahoma wine industry on this state.
 - D. Expenditures from the fund shall be made upon warrants issued by the State Treasurer against claims filed as prescribed by law with the Director of the Office of Management and Enterprise Services for approval and payment.
- 20 SECTION 2. NEW LAW A new section of law not to be codified in the Oklahoma Statutes reads as follows:
- 22 All funds currently held in the Oklahoma Viticulture and Enology 23 Center Development Revolving Fund shall remain in the fund and be
