9	An Act relating to aircraft excise tax; amending 68 O.S. 2021, Section 6005, which relates to
10	apportionment of tax revenue; deleting obsolete language; modifying apportionment; providing an
11	effective date; and declaring an emergency.

14	BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:
15	SECTION 1. AMENDATORY 68 O.S. 2021, Section 6005, is
16	amended to read as follows:
17	Section 6005. A. For fiscal years beginning prior to July 1,
18	1999, all revenues derived pursuant to the provisions of Sections
19	6001 through 6007 of this title shall be paid monthly by the
20	Oklahoma Tax Commission to the State Treasurer and placed to the
21	credit of the General Revenue Fund to be paid out pursuant to direct
22	appropriation by the Legislature.
23	B. 1. For the fiscal year beginning July 1, 1999, fifty
24	percent (50%) of all revenues derived pursuant to the provisions of

Sections 6001 through 6007 of this title shall be paid monthly by the Tax Commission to the State Treasurer and placed to the credit of the General Revenue Fund to be paid out pursuant to direct appropriation by the Legislature, and fifty percent (50%) of the revenues shall be placed to the credit of the Oklahoma Aeronautics Gommission Revolving Fund.

7 2. For fiscal year 2001 through fiscal year 2015 For the fiscal 8 year beginning July 1, 2022, and all subsequent fiscal years, one 9 hundred percent (100%) of the revenues derived pursuant to the 10 provisions of Sections 6001 through 6007 of this title shall be paid 11 monthly by the <u>Oklahoma</u> Tax Commission to the State Treasurer and 12 shall be placed to the credit of the Oklahoma Aeronautics Commission 13 Revolving Fund.

3. For the fiscal year beginning July 1, 2015, and for each 14 fiscal year thereafter, the first Four Million Five Hundred Thousand 15 Dollars (\$4,500,000.00) of the revenues each fiscal year derived 16 17 pursuant to the provisions of Sections 6001 through 6007 of this title shall be paid by the Tax Commission to the State Treasurer and 18 placed to the credit of the Oklahoma Aeronautics Commission 19 20 Revolving Fund, and all such revenues derived each fiscal year in excess of Four Million Five Hundred Thousand Dollars (\$4,500,000.00) 21 shall be paid by the Tax Commission to the State Treasurer and 22 placed to the credit of the General Revenue Fund to be paid out 23 24 pursuant to direct appropriation by the Legislature.

1	SECTION 2. This act shall become effective July 1, 2022.
2	SECTION 3. It being immediately necessary for the preservation
3	of the public peace, health or safety, an emergency is hereby
4	declared to exist, by reason whereof this act shall take effect and
5	be in full force from and after its passage and approval.
