8 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

9 SECTION 1. NEW LAW A new section of law to be codified
10 in the Oklahoma Statutes as Section 1698.398 of Title 69, unless
11 there is created a duplication in numbering, reads as follows:

12 The section of State Highway 66 beginning at the intersection of
13 Country Club Road on the southwest edge of Bristow extending
14 northeasterly to the intersection of West 3rd Avenue in Creek County
15 shall be designated as the "Army SPC Ryan J. Grady Memorial
16 Highway". The Department of Transportation shall cause suitable
17 markers bearing that name to be placed on the highway.

18 SECTION 2. NEW LAW A new section of law to be codified
19 in the Oklahoma Statutes as Section 1698.399 of Title 69, unless
20 there is created a duplication in numbering, reads as follows:

21 The section of Interstate 35 beginning on the south side of the
22 State Highway 32 interchange extending north approximately seven (7)
23 miles to the north side of the Oswalt Road interchange in Love
24 County shall be designated as the "First MCPON Delbert D. Black,
U.S. Navy, Memorial Highway". The Department of Transportation

1 shall cause suitable markers bearing that name to be placed on the
2 highway.

3 SECTION 3. NEW LAW A new section of law to be codified
4 in the Oklahoma Statutes as Section 1698.400 of Title 69, unless
5 there is created a duplication in numbering, reads as follows:

6 The intersection of U.S. Highway 60 and State Highway 18 north
7 of Fairfax in Osage County shall be designated as the "Captain
8 William "Willy" Hargraves Memorial Intersection". The Department of
9 Transportation shall cause suitable markers bearing that name to be
10 placed at the intersection.

11 SECTION 4. NEW LAW A new section of law to be codified
12 in the Oklahoma Statutes as Section 1698.401 of Title 69, unless
13 there is created a duplication in numbering, reads as follows:

14 The bridge crossing over Polecat Creek on U.S. Highway 75A south
15 of Sapulpa in Creek County shall be designated as the "Trooper Larry
16 L. Hillyard Memorial Bridge". The Department of Transportation
17 shall cause suitable permanent markers bearing that name to be
18 placed on the bridge.

19 SECTION 5. NEW LAW A new section of law to be codified
20 in the Oklahoma Statutes as Section 1698.402 of Title 69, unless
21 there is created a duplication in numbering, reads as follows:

22 The section of State Highway 48A beginning at the intersection
23 of Hollow Springs Road, extending east to the intersection of SH-48
24 in Coleman in Johnston County shall be designated as the "C.D.

1 Scribner WWII Veteran Memorial Highway". The Department of
2 Transportation shall cause suitable permanent markers bearing that
3 name to be placed on the highway.

4 SECTION 6. NEW LAW A new section of law to be codified
5 in the Oklahoma Statutes as Section 1698.403 of Title 69, unless
6 there is created a duplication in numbering, reads as follows:

7 The section of State Highway 66 beginning at the intersection of
8 Flynn Avenue in Depew extending east to the intersection of South
9 433rd W Avenue in Creek County shall be designated as the "LCpl
10 Nelson Matlock Memorial Highway". The Department of Transportation
11 shall cause suitable permanent markers bearing that name to be
12 placed on the highway.

13 SECTION 7. AMENDATORY Section 20, Chapter 356, O.S.L.
14 2022 (69 O.S. Supp. 2022, Section 1698.383), is amended to read as
15 follows:

16 Section 1698.383 The section of Interstate 44 beginning one-
17 half (0.5) mile ~~north~~ south of State Highway 36 interchange
18 extending ~~south~~ north to U.S. Highway 70 interchange in Cotton
19 County shall be designated as the "William Mark Miller Memorial
20 Highway". The Department of Transportation shall cause suitable
21 permanent markers bearing that name to be placed on the highway.

22 SECTION 8. This act shall become effective November 1, 2023."
