10	An Act relating to revenue and taxation; amending 68 O.S. 2011, Section 1356, as last amended by Section 1
11	of Enrolled Senate Bill No. 189 of the 1st Session of the 56th Oklahoma Legislature, which relates to sales
12	tax exemptions; providing exemption for sales to and by certain organizations; modifying application of
13	sales tax exemption for purposes of promotion of the state by Oklahoma Tourism and Recreation Department;
14	clarifying effective date of certain exemption; repealing Section 1 of Enrolled Senate Bill No. 235
15	of the 1st Session of the 56th Oklahoma Legislature, which is a duplicate section and which relates to
16	sales tax exemptions; providing an effective date; and declaring an emergency.

19	BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:
20	SECTION 1. AMENDATORY 68 O.S. 2011, Section 1356, as
21	last amended by Section 1 of Enrolled Senate Bill No. 189 of the 1st
22	Session of the 56th Oklahoma Legislature, is amended to read as
23	follows:

Section 1356. Exemptions - Governmental and nonprofit entities.
 There are hereby specifically exempted from the tax levied by
 Section 1350 et seq. of this title:

Sale of tangible personal property or services to the United 4 1. 5 States government or to the State of Oklahoma, any political subdivision of this state or any agency of a political subdivision 6 of this state; provided, all sales to contractors in connection with 7 the performance of any contract with the United States government, 8 9 State of Oklahoma or any of its political subdivisions shall not be 10 exempted from the tax levied by Section 1350 et seq. of this title, 11 except as hereinafter provided;

12 2. Sales of property to agents appointed by or under contract 13 with agencies or instrumentalities of the United States government 14 if ownership and possession of such property transfers immediately 15 to the United States government;

3. Sales of property to agents appointed by or under contract with a political subdivision of this state if the sale of such property is associated with the development of a qualified federal facility, as provided in the Oklahoma Federal Facilities Development Act, and if ownership and possession of such property transfers immediately to the political subdivision or the state;

4. Sales made directly by county, district or state fair
authorities of this state, upon the premises of the fair authority,
for the sole benefit of the fair authority or sales of admission

1 tickets to such fairs or fair events at any location in the state 2 authorized by county, district or state fair authorities; provided, 3 the exemption provided by this paragraph for admission tickets to fair events shall apply only to any portion of the admission price 4 5 that is retained by or distributed to the fair authority. As used in this paragraph, "fair event" shall be limited to an event held on 6 the premises of the fair authority in conjunction with and during 7 the time period of a county, district or state fair; 8

9 5. Sale of food in cafeterias or lunch rooms of elementary 10 schools, high schools, colleges or universities which are operated 11 primarily for teachers and pupils and are not operated primarily for 12 the public or for profit;

6. Dues paid to fraternal, religious, civic, charitable or 13 educational societies or organizations by regular members thereof, 14 provided, such societies or organizations operate under what is 15 commonly termed the lodge plan or system, and provided such 16 societies or organizations do not operate for a profit which inures 17 to the benefit of any individual member or members thereof to the 18 exclusion of other members and dues paid monthly or annually to 19 privately owned scientific and educational libraries by members 20 sharing the use of services rendered by such libraries with students 21 interested in the study of geology, petroleum engineering or related 22 subjects; 23

1 7. Sale of tangible personal property or services to or by churches, except sales made in the course of business for profit or 2 3 savings, competing with other persons engaged in the same or a similar business or sale of tangible personal property or services 4 5 by an organization exempt from federal income tax pursuant to Section 501(c)(3) of the Internal Revenue Code of 1986, as amended, 6 7 made on behalf of or at the request of a church or churches if the sale of such property is conducted not more than once each calendar 8 9 year for a period not to exceed three (3) days by the organization 10 and proceeds from the sale of such property are used by the church 11 or churches or by the organization for charitable purposes;

The amount of proceeds received from the sale of admission 12 8. tickets which is separately stated on the ticket of admission for 13 the repayment of money borrowed by any accredited state-supported 14 college or university or any public trust of which a county in this 15 state is the beneficiary, for the purpose of constructing or 16 enlarging any facility to be used for the staging of an athletic 17 event, a theatrical production, or any other form of entertainment, 18 edification or cultural cultivation to which entry is gained with a 19 paid admission ticket. Such facilities include, but are not limited 20 to, athletic fields, athletic stadiums, field houses, amphitheaters 21 and theaters. To be eligible for this sales tax exemption, the 22 amount separately stated on the admission ticket shall be a 23 surcharge which is imposed, collected and used for the sole purpose 24

1 of servicing or aiding in the servicing of debt incurred by the 2 college or university to effect the capital improvements 3 hereinbefore described;

9. Sales of tangible personal property or services to the 4 5 council organizations or similar state supervisory organizations of the Boy Scouts of America, Girl Scouts of U.S.A. and Camp Fire USA; 6 7 10. Sale of tangible personal property or services to any county, municipality, rural water district, public school district, 8 9 the institutions of The Oklahoma State System of Higher Education, 10 the Grand River Dam Authority, the Northeast Oklahoma Public Facilities Authority, the Oklahoma Municipal Power Authority, City 11 12 of Tulsa-Rogers County Port Authority, Muskogee City-County Port Authority, the Oklahoma Department of Veterans Affairs, the Broken 13 Bow Economic Development Authority, Ardmore Development Authority, 14 Durant Industrial Authority, Oklahoma Ordnance Works Authority, 15 Central Oklahoma Master Conservancy District, Arbuckle Master 16 Conservancy District, Fort Cobb Master Conservancy District, Foss 17 Reservoir Master Conservancy District, Mountain Park Master 18 Conservancy District, Waurika Lake Master Conservancy District, 19 Office of Management and Enterprise Services only when carrying out 20 a public construction contract on behalf of the Oklahoma Department 21 of Veterans Affairs or to any person with whom any of the above-22 named subdivisions or agencies of this state has duly entered into a 23 public contract pursuant to law, necessary for carrying out such 24

1 public contract or to any subcontractor to such a public contract. 2 Any person making purchases on behalf of such subdivision or agency 3 of this state shall certify, in writing, on the copy of the invoice or sales ticket to be retained by the vendor that the purchases are 4 5 made for and on behalf of such subdivision or agency of this state and set out the name of such public subdivision or agency. Any 6 7 person who wrongfully or erroneously certifies that purchases are for any of the above-named subdivisions or agencies of this state or 8 9 who otherwise violates this section shall be guilty of a misdemeanor 10 and upon conviction thereof shall be fined an amount equal to double 11 the amount of sales tax involved or incarcerated for not more than 12 sixty (60) days or both;

Sales of tangible personal property or services to private 13 11. institutions of higher education and private elementary and 14 secondary institutions of education accredited by the State 15 Department of Education or registered by the State Board of 16 Education for purposes of participating in federal programs or 17 accredited as defined by the Oklahoma State Regents for Higher 18 Education which are exempt from taxation pursuant to the provisions 19 of the Internal Revenue Code, 26 U.S.C., Section 501(c)(3), 20 including materials, supplies, and equipment used in the 21 construction and improvement of buildings and other structures owned 22 by the institutions and operated for educational purposes. 23

Any person who wrongfully or 4 5 erroneously certifies that the purchases are for any such fire department or who otherwise violates the provisions of this section 6 7 shall be deemed quilty of a misdemeanor and upon conviction thereof, shall be fined an amount equal to double the amount of sales tax 8 9 involved or incarcerated for not more than sixty (60) days, or both; 10 18. Complimentary or free tickets for admission to places of 11 amusement, sports, entertainment, exhibition, display or other 12 recreational events or activities which are issued through a box office or other entity which is operated by a state institution of 13 higher education with institutional employees or by a municipality 14

The first Fifteen Thousand Dollars (\$15,000.00) each year 16 from sales of tangible personal property by fire departments 17 organized pursuant to Titles 11, 18, or 19 of the Oklahoma Statutes 18 for the purposes of raising funds for the benefit of the fire 19 department. Fire departments selling tangible personal property for 20 the purposes of raising funds shall be limited to no more than six 21 (6) days each year to raise such funds in order to receive the 22 exemption granted by this paragraph; 23

Any person making purchases on behalf of any such museum or other entity shall certify, in writing, on the copy of the invoice or sales ticket to be retained by the vendor that the purchases are made for and on behalf of such museum or other entity and set out the name of such museum or other entity. Any person who wrongfully or erroneously certifies that the

7 26. Sales of tickets for admission by any museum accredited by the American Association of Museums. In order to be eligible for 8 9 the exemption provided by this paragraph, an amount equivalent to 10 the amount of the tax which would otherwise be required to be 11 collected pursuant to the provisions of Section 1350 et seq. of this 12 title shall be separately stated on the admission ticket and shall be collected and used for the sole purpose of servicing or aiding in 13 the servicing of debt incurred by the museum to effect the 14 construction, enlarging or renovation of any facility to be used for 15 entertainment, edification or cultural cultivation to which entry is 16 gained with a paid admission ticket; 17

18 27. Sales of tangible personal property or services occurring 19 on or after June 1, 1995, to children's homes which are supported or 20 sponsored by one or more churches, members of which serve as 21 trustees of the home;

31. Sales of tangible personal property or services to a
municipality, county or school district pursuant to a lease or
lease-purchase agreement executed between the vendor and a
municipality, county or school district. A copy of the lease or
lease-purchase agreement shall be retained by the vendor;

32. Sales of tangible personal property or services to any spaceport user, as defined in the Oklahoma Space Industry Development Act;

The sale, use, storage, consumption, or distribution in 16 this state, whether by the importer, exporter, or another person, of 17 any satellite or any associated launch vehicle, including components 18 of, and parts and motors for, any such satellite or launch vehicle, 19 imported or caused to be imported into this state for the purpose of 20 export by means of launching into space. This exemption provided by 21 this paragraph shall not be affected by:

a. the destruction in whole or in part of the satelliteor launch vehicle,

Provided, the exemption provided for in this paragraph shall not be allowed unless 11 the purchaser or lessee signs an affidavit stating that the item or 12 items to be exempted are for the exclusive use designated herein. 13 Any person furnishing a false affidavit to the vendor for the 14 15 purpose of evading payment of any tax imposed by Section 1354 of this title shall be subject to the penalties provided by law. 16 As used in this paragraph, "machinery and equipment" means "section 38 17 property" as defined in Sections 48(a)(1)(A) and (B)(i) of the 18 Internal Revenue Code of 1986, which is used as an integral part of 19 the manufacturing, processing, compounding, or producing of items of 20 tangible personal property. Such term includes parts and 21 accessories only to the extent that the exemption thereof is 22 consistent with the provisions of this paragraph; 23

1 38. The amount of a surcharge or any other amount which is 2 separately stated on an admission ticket which is imposed, collected 3 and used for the sole purpose of constructing, remodeling or 4 enlarging facilities of a public trust having a municipality or 5 county as its sole beneficiary;

39. Sales of tangible personal property or services which are
directly used in or for the benefit of a state park in this state,
which are made to an organization which is exempt from taxation
pursuant to the provisions of the Internal Revenue Code, 26 U.S.C.,
Section 501(c)(3) and which is organized primarily for the purpose
of supporting one or more state parks located in this state;

12 40. The sale, lease or use of parking privileges by an13 institution of The Oklahoma State System of Higher Education;

41. Sales of tangible personal property or services for use on 14 campus or school construction projects for the benefit of 15 institutions of The Oklahoma State System of Higher Education, 16 private institutions of higher education accredited by the Oklahoma 17 State Regents for Higher Education or any public school or school 18 district when such projects are financed by or through the use of 19 nonprofit entities which are exempt from taxation pursuant to the 20 provisions of the Internal Revenue Code, 26 U.S.C., Section 21 501(c)(3); 22

42. Sales of tangible personal property or services by anorganization which is exempt from taxation pursuant to the

1 provisions of the Internal Revenue Code, 26 U.S.C., Section 2 501(c)(3), in the course of conducting a national championship 3 sports event, but only if all or a portion of the payment in exchange therefor would qualify as the receipt of a qualified 4 5 sponsorship payment described in Internal Revenue Code, 26 U.S.C., Section 513(i). Sales exempted pursuant to this paragraph shall be 6 exempt from all Oklahoma sales, use, excise and gross receipts 7 8 taxes;

9 43. Sales of tangible personal property or services to or by an 10 organization which:

a. is exempt from taxation pursuant to the provisions of
the Internal Revenue Code, 26 U.S.C., Section
501(c)(3),

b. is affiliated with a comprehensive university within
The Oklahoma State System of Higher Education, and
c. has been organized primarily for the purpose of
providing education and teacher training and
conducting events relating to robotics;

19 44. The first Fifteen Thousand Dollars (\$15,000.00) each year 20 from sales of tangible personal property to or by youth athletic 21 teams which are part of an athletic organization exempt from 22 taxation pursuant to the provisions of the Internal Revenue Code, 26 23 U.S.C., Section 501(c)(4), for the purposes of raising funds for the 24 benefit of the team;

Sales of tickets for admission to a collegiate athletic event that is held in a facility owned or operated by a municipality or a public trust of which the municipality is the sole beneficiary and that actually determines or is part of a tournament or tournament process for determining a conference tournament championship, a conference championship, or a national championship;

46. Sales of tangible personal property or services to or by an
organization which is exempt from taxation pursuant to the
provisions of the Internal Revenue Code, 26 U.S.C., Section
501(c)(3) and is operating the Oklahoma City National Memorial and
Museum, an affiliate of the National Park System;

47. Sales of tangible personal property or services to organizations which are exempt from federal taxation pursuant to the provisions of Section 501(c)(3) of the Internal Revenue Code, 26 U.S.C., Section 501(c)(3), the memberships of which are limited to honorably discharged veterans, and which furnish financial support to area veterans' organizations to be used for the purpose of constructing a memorial or museum;

19 48. Sales of tangible personal property or services on or after 20 January 1, 2003, to an organization which is exempt from taxation 21 pursuant to the provisions of the Internal Revenue Code, 26 U.S.C., 22 Section 501(c)(3) that is expending monies received from a private 23 foundation grant in conjunction with expenditures of local sales tax 24 revenue to construct a local public library;

49. Sales of tangible personal property or services to a state
 that borders this state or any political subdivision of that state,
 but only to the extent that the other state or political subdivision
 exempts or does not impose a tax on similar sales of items to this
 state or a political subdivision of this state;

50. Effective July 1, 2005, sales of tangible personal property
or services to the Career Technology Student Organizations under the
direction and supervision of the Oklahoma Department of Career and
Technology Education;

10 51. Sales of tangible personal property to a public trust having either a single city, town or county or multiple cities, 11 12 towns or counties or combination thereof as beneficiary or beneficiaries or a nonprofit organization which is exempt from 13 taxation pursuant to the provisions of the Internal Revenue Code, 26 14 15 U.S.C., Section 501(c)(3) for the purpose of constructing improvements to or expanding a hospital or nursing home owned and 16 operated by any such public trust or nonprofit entity prior to July 17 1, 2008, in counties with a population of less than one hundred 18 thousand (100,000) persons, according to the most recent Federal 19 Decennial Census. As used in this paragraph, "constructing 20 improvements to or expanding" shall not mean any expense for routine 21 maintenance or general repairs and shall require a project cost of 22 at least One Hundred Thousand Dollars (\$100,000.00). For purposes 23 of this paragraph, sales made to a contractor or subcontractor that 24

1 enters into a contractual relationship with a public trust or 2 nonprofit entity as described by this paragraph shall be considered sales made to the public trust or nonprofit entity. The exemption 3 authorized by this paragraph shall be administered in the form of a 4 5 refund from the sales tax revenues apportioned pursuant to Section 1353 of this title and the vendor shall be required to collect the 6 7 sales tax otherwise applicable to the transaction. The purchaser may apply for a refund of the sales tax paid in the manner 8 9 prescribed by this paragraph. Within thirty (30) days after the end 10 of each fiscal year, any purchaser that is entitled to make application for a refund based upon the exempt treatment authorized 11 12 by this paragraph may file an application for refund of the sales taxes paid during such preceding fiscal year. The Tax Commission 13 shall prescribe a form for purposes of making the application for 14 refund. The Tax Commission shall determine whether or not the total 15 amount of sales tax exemptions claimed by all purchasers is equal to 16 or less than Six Hundred Fifty Thousand Dollars (\$650,000.00).
