15	Section 982a. A. 1. Any time within sixty (60) months after
16	the initial sentence is imposed or within sixty (60) months after
17	probation has been revoked, the court imposing sentence or
18	revocation of probation may modify such sentence or revocation by
19	directing that another sentence be imposed, if the court is
20	satisfied that the best interests of the public will not be
21	jeopardized; provided, however, the court shall not impose a
22	deferred sentence. Any application for sentence modification that
23	is filed and ruled upon beyond twelve (12) months of the initial
24	sentence being imposed must be approved by the district attorney who

shall provide written notice to any victims in the case which is
 being considered for modification.

3 2. The court imposing sentence may modify the sentence of any offender who was originally sentenced for a drug charge and ordered 4 5 to complete the Drug Offender Work Camp at the Bill Johnson Correctional Facility and direct that another sentence be imposed, 6 if the court is satisfied that the best interests of the public will 7 not be jeopardized; provided, however, the court shall not impose a 8 9 deferred sentence. An application for sentence modification 10 pursuant to this paragraph may be filed and ruled upon beyond the 11 initial sixty-month time period provided for in paragraph 1 of this 12 subsection.

3. This section shall not apply to convicted felons who have
been in confinement in any state or federal prison system for any
previous felony conviction during the ten-year period preceding the
date that the sentence this section applies to was imposed.
Further, without the consent of the district attorney, this section
shall not apply to sentences imposed pursuant to a plea agreement or
jury verdict.

B. The court imposing the sentence may modify the sentence of any offender sentenced to life without parole for an offense other than a violent crime, as enumerated in Section 571 of Title 57 of the Oklahoma Statutes, who has served at least ten (10) years of the sentence in the custody of the Department of Corrections upon a

1 finding that the best interests of the public will not be 2 jeopardized. Provided; however, prior to granting a sentence 3 modification under the provisions of this subsection, the court shall provide notice of the hearing to determine sentence 4 5 modification to the victim or representative of the victim and shall allow the victim or representative of the victim the opportunity to 6 provide testimony at the hearing. The court shall consider the 7 testimony of the victim or representative of the victim when 8 9 rendering a decision to modify the sentence of an offender.

10 C. For purposes of judicial review, upon court order or written 11 request from the sentencing judge, the Department of Corrections 12 shall provide the court imposing sentence or revocation of probation with a report to include a summary of the assessed needs of the 13 offender, any progress made by the offender in addressing his or her 14 15 assessed needs, and any other information the Department can supply on the offender. The court shall consider such reports when 16 modifying the sentence or revocation of probation. The court shall 17 allow the Department of Corrections at least twenty (20) days after 18 receipt of a request or order from the court to prepare the required 19 reports. 20

D. If the court considers modification of the sentence or
revocation of probation, a hearing shall be made in open court after
receipt of the reports required in subsection C of this section.
The clerk of the court imposing sentence or revocation of probation

Such notice shall be mailed at least twenty-one (21) days prior to the hearing date and shall include a copy of the report and any other written information to be considered at the judicial review hearing.

E. If an appeal is taken from the original sentence or from a 8 9 revocation of probation which results in a modification of the 10 sentence or modification to the revocation of probation of the 11 offender, such sentence may be further modified in the manner 12 described in paragraph 1 of subsection A of this section within sixty (60) months after the receipt by the clerk of the district 13 court of the mandate from the Supreme Court or the Court of Criminal 14 15 Appeals.

16 F. 1. Notwithstanding subsections A, C and D of this section, the court shall set aside the judgment and sentence and resentence a 17 person convicted pursuant to Section 2-402 of Title 63 of the 18 Oklahoma Statutes, whether by trial or plea, upon a finding that the 19 20 person, if such person committed the same crime on or after July 1, 2017, would have been guilty of a misdemeanor, and who is a person: 21 enumerated by the Department of Corrections pursuant 22 a. 23 to Section 2 of this act who is currently serving a 24 sentence of imprisonment,

7	2. A hearing shall not be conducted to modify a sentence
8	pursuant to this subsection unless requested by the person.
9	If the person's sentence includes multiple felony convictions,
10	one or more of which were reduced to misdemeanors pursuant to this
11	subsection, the court shall reduce the sentence to the length it
12	would have been if the violation of Section 2-402 of Title 63 of the
13	Oklahoma Statutes was committed on or after July 1, 2017.
14	The court shall resentence each person set forth in subparagraph
15	a of paragraph 1 of this subsection within three (3) months of
16	receipt of the report pursuant to Section 2 of this act. The court
17	shall resentence each person set forth in subparagraphs b and c of
18	paragraph 1 of this subsection within six (6) months of referral.
19	A person whose sentence is modified pursuant to this subsection
20	shall be given credit for time served. In no event may a resentence

23	3. A sentence for Section 2-402 of Title 63 of the Oklahoma
24	Statutes that is modified pursuant to this subsection shall be

1 considered a misdemeanor for all purposes. Upon a sentence 2 modification pursuant to this subsection, the court shall order all 3 applicable court and law enforcement records relating to the 4 person's felony conviction pursuant to Section 2-402 of Title 63 of 5 the Oklahoma Statutes to be modified to reflect the new sentence. 6 4. A final judgment entered under this subsection may be 7 appealed to the Court of Criminal Appeals within thirty (30) days 8 from the entry of the judgment.

9 SECTION 2. NEW LAW A new section of law to be codified 10 in the Oklahoma Statutes as Section 983c of Title 22, unless there 11 is created a duplication in numbering, reads as follows:

12 The Director of the Department of Corrections shall compile and distribute a report on or before August 1, 2019, and every three (3) 13 months thereafter, to each presiding judge for each district court 14 15 from which any person has been sentenced and is currently serving a sentence of imprisonment, including revocation and acceleration 16 sentences, for a conviction pursuant to Section 2-402 of Title 63 of 17 Oklahoma Statutes, who committed his or her offense prior to July 1, 18 2017, and has three (3) months or more remaining until his or her 19 expected release date. Such report shall include persons currently 20 serving a sentence of imprisonment for multiple offenses, served 21 concurrently or consecutively, one or more of which is for a 22 conviction pursuant to Section 2-402 of Title 63 of the Oklahoma 23 Statutes. Such report shall include the county from which a person 24

1 was sentenced, the court-imposed sentence, including sentences for 2 other offenses served concurrently or consecutively, and the expected remaining stay in prison. Copies of the reports shall be 3 made available to the public upon request. The Department shall 4 5 notify any person serving a sentence of imprisonment for a conviction pursuant to Section 2-402 of Title 63 of the Oklahoma 6 7 Statutes who committed his or her offense prior to July 1, 2017, who has three (3) months or less remaining until the expected release 8 9 date, that he or she has the right to apply for sentence 10 modification for a conviction pursuant to Section 2-402 of Title 63 11 of the Oklahoma Statutes.

12 This section shall terminate on August 1st, 2024.

SECTION 3. AMENDATORY 22 O.S. 2011, Section 991b, as last amended by Section 11, Chapter 128, O.S.L. 2018 (22 O.S. Supp. 2018, Section 991b), is amended to read as follows:

Section 991b. A. The Department of Corrections shall develop a matrix of technical violations and sanctions to address violations committed 13 by persons who are being supervised by the Department. 14 The Department shall be authorized to use a violation response and 15 intermediate sanction process based on the sanction matrix to apply 16 to any technical violations of probationers. Within four (4) 17 working days of the discovery of the violation, the probation 18 officer shall initiate the violation response and intermediate 19 sanction process. The sentencing judge may authorize any 20 recommended sanctions, which may include, but are not limited to: 21 short-term jail or lockup, day treatment, program attendance, 22 community service, outpatient or inpatient treatment, monetary 23 fines, curfews, ignition interlock devices on vehicles, or a one-24

The probation officer shall complete a sanction form, which shall specify the technical 6 violation, sanction, and the action plan to correct the noncompliant 7 behavior resulting in the technical violation. The probation 8 9 officer shall refer to the sanctioning matrix to determine the 10 supervision, treatment, and sanctions appropriate to address the noncompliant behavior. The probation officer shall refer the 11 12 violation information and recommended response with a sanction plan to the Department of Corrections to be heard by a hearing officer. 13 The Department of Corrections shall develop a sanction matrix, 14 15 forms, policies and procedures necessary to implement this provision. 7 2. The hearing officer shall determine based on a preponderance of the evidence whether a technical violation occurred. Upon a 8 9 finding that a technical violation occurred, the hearing officer may 10 order the offender to participate in the recommended sanction plan 11 or may modify the plan. Offenders who accept the sanction plan 12 shall sign a violation response sanction form, and the hearing officer shall then impose the sanction. Failure of the offender to 13 comply with the imposed sanction plan shall constitute a violation 14 of the rules and conditions of supervision that may result in a 15 revocation proceeding. If an offender does not voluntarily accept 16 the recommended sanction plan, the Department shall either impose 17 the sanction and allow the offender to appeal to the district court, 18 or request a revocation proceeding as provided by law. Every 19 administrative hearing and sanction imposed by the Department shall 20 be appealable to the district court. 21

3. Absent a finding of willful nonpayment by the offender, the
failure of an offender to pay fines and costs may not serve as a
basis for revocation, excluding restitution.

E. 1. Where one of the grounds for revocation is the failure of the defendant to make restitution as ordered, the Department of Corrections shall forward to the district attorney all information pertaining to the failure of the defendant to make timely restitution as ordered by the court, and the district attorney shall file a petition setting forth the grounds for revocation.

7 2. The defendant ordered to make restitution can petition the 8 court at any time for remission or a change in the terms of the 9 order of restitution if the defendant undergoes a change of 10 condition which materially affects the ability of the defendant to 11 comply with the order of the court.

12 3. At the hearing, if one of the grounds for the petition for revocation is the failure of the defendant to make timely 13 restitution as ordered by the court, the court will hear evidence 14 15 and if it appears to the satisfaction of the court from such evidence that the terms of the order of restitution create a 16 manifest hardship on the defendant or the immediate family of the 17 defendant, the court may cancel all or any part of the amount still 18 due, or modify the terms or method of payment. Provided, if the 19 court determines that a reduction in the restitution still due is 20 warranted, the court shall equally apply the same percentage 21 reduction to any court-ordered monetary obligation owed by the 22 defendant including, but not limited to, fines, court costs and 23 costs of incarceration. 24

1 F. The court may revoke a portion of the sentence and leave the remaining part not revoked, but suspended for the remainder of the 2 3 term of the sentence, and under the provisions applying to it. The person whose suspended sentence is being considered for revocation 4 5 at the hearing shall have the right to be represented by counsel, to present competent evidence in his or her own behalf and to be 6 7 confronted by the witnesses against the defendant. Any order of the court revoking the suspended sentence, in whole or in part, shall be 8 9 subject to review on appeal, as in other appeals of criminal cases. 10 Provided, however, that if the crime for which the suspended 11 sentence is given was a felony, the defendant may be allowed bail 12 pending appeal. If the reason for revocation be that the defendant committed a felony, the defendant shall not be allowed bail pending 13 appeal. 14

Be supervised in the community for a period not to exceed 4 5 eighteen (18) months, unless a petition alleging violation of any condition of deferred judgment is filed during the period of 6 7 supervision. As a condition of any supervision, the defendant shall be required to pay a supervision fee of Forty Dollars (\$40.00) per 8 9 month. The supervision fee shall be waived in whole or part by the 10 supervisory agency when the accused is indigent. No person shall be 11 denied supervision based solely on the inability of the person to 12 pay a fee;

8. Pay into the court fund a monthly amount not exceeding Forty Dollars (\$40.00) per month during any period during which the proceedings are deferred when the defendant is not to be supervised in the community. The total amount to be paid into the court fund shall be established by the court and shall not exceed the amount of the maximum fine authorized by law for the offense;

9. Make other reparations to the community or victim as
 required and deemed appropriate by the court;

Records expunded pursuant to this subsection shall be 18 admissible in any subsequent criminal prosecution to prove the 19 existence of a prior conviction or prior deferred judgment without 20 the necessity of a court order requesting the unsealing of such 21 records. 22

E. The provisions of subsection D of this section shall beretroactive.

1 F. Whenever a judgment has been deferred by the court according to the provisions of this section, deferred judgment may not be 2 3 accelerated for any technical violation unless a petition setting forth the grounds for such acceleration is filed by the district 4 5 attorney with the clerk of the sentencing court and competent evidence justifying the acceleration of the judgment is presented to 6 7 the court at a hearing to be held for that purpose. The hearing shall be held not more than twenty (20) days after the entry of the 8 9 plea of not guilty to the petition, unless waived by both the state 10 and the defendant. Any acceleration of a deferred sentence based on 11 a technical violation shall not exceed ninety (90) days for a first 12 acceleration or five (5) years for a second or subsequent acceleration. 13

G. Upon any violation of the deferred judgment, other than a technical violation, the court may enter a judgment of guilt and proceed as provided in Section 991a of this title or may modify any condition imposed. Provided, however, if the deferred judgment is for a felony offense, and the defendant commits another felony offense, the defendant shall not be allowed bail pending appeal. H. The deferred judgment procedure described in this section

21 shall apply only to defendants who have not been previously 22 convicted of a felony offense and have not received more than one 23 deferred judgment for a felony offense within the ten (10) years 24 previous to the commission of the pending offense.
