13	BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:
14	SECTION 1. NEW LAW A new section of law to be codified
15	in the Oklahoma Statutes as Section 178 of Title 13, unless there is
16	created a duplication in numbering, reads as follows:
17	As used in this act:
18	1. "Electronic communication service" means a service that
19	provides to users of the service the ability to send or receive wire
20	or electronic communications;
21	2. "Electronic device" means a device that enables access to or
22	use of an electronic communication service or remote computing
23	service or location information service;

"Government entity" means the state, a county, a 2 municipality, a higher education institution, a local district, a 3 special service district or any other political subdivision of the 4 state or an administrative subunit of any political subdivision 5 including a law enforcement entity or any other investigative 6 entity, agency, department, division, bureau, board or commission, 7 or an individual acting or purporting to act for or on behalf of a 8 state or local agency;

9 4. "Location information" means information concerning the 10 location of an electronic device that, in whole or in part, is 11 generated or derived from or obtained by the operation of an 12 electronic device;

¹³ 5. "Location information service" means the provision of a ¹⁴ global positioning service or other mapping, locational or ¹⁵ directional information service;

16 6. "Metadata" means the structural information of an electronic 17 file that contains data about the file itself rather than the 18 content of the file. The term includes, but is not limited to, 19 hidden text, formatting codes and formulae, and includes all 20 contextual, processing and use information necessary to identify and 21 certify the scope, authenticity and integrity of active or archival 22 electronic information or records;

A government 18 entity may not use, copy or disclose for any purpose location 19 information, metadata, stored data or transmitted data of an 20 electronic device that is not the subject of the court order or 21 warrant that is collected as part of an effort to obtain the 22 location information, metadata, stored data or transmitted data of 23 the electronic device that is the subject of the court order or 24 warrant. Such data shall be destroyed in an unrecoverable manner by _ _

¹ the government entity no later than twenty-four (24) hours after the ² data is collected.

B. 1. A government entity shall not obtain the location
information, metadata, stored data or transmitted data of an
electronic device without a court order or search warrant issued by
a duly authorized court, unless:

7 the device is reported stolen by the owner, a. 8 b. in response to the user's call for emergency services, 9 the entity has the informed and affirmative consent of с. 10 the owner or user of the electronic device, or 11 there exists a possible life-threatening situation. d. 12 Any evidence obtained in violation of paragraph 1 of this 2. 13 subsection shall not be admissible in any civil, criminal or 14 administrative proceeding and shall not be used in an affidavit of 15 probable cause in an effort to obtain a search warrant.

C. Notice shall be given to the user whose location
information, metadata, stored data, transmitted data or electronic
device was searched or obtained by a government entity.
SECTION 3. This act shall become effective November 1, 2019.
