6 AS INTRODUCED

7 An Act relating to the University Hospitals
8 Authority; amending 63 O.S. 2011, Section 3202, as
9 amended by Section 1, Chapter 495, O.S.L. 2019 (63
10 O.S. Supp. 2020, Section 3202), which relates to
11 definitions; modifying definitions; authorizing
12 Authority to assign certain facilities to certain
13 entities; prohibiting certain use of titles without
14 permission; amending 63 O.S. 2011, Section 3206,
15 which relates to Children's Hospital; modifying name;
16 and providing an effective date.

17 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

18 SECTION 1. AMENDATORY 63 O.S. 2011, Section 3202, as
19 amended by Section 1, Chapter 495, O.S.L. 2019 (63 O.S. Supp. 2020,
20 Section 3202), is amended to read as follows:

21 Section 3202. A. As used in the University Hospitals Authority
22 Act:

23 1. "University Hospitals" include ~~the Oklahoma Memorial~~
24 ~~Hospital, which shall be renamed University Hospital; the, Oklahoma~~
~~Children's Hospital of Oklahoma; the Child Study Center; and the~~
~~O'Donoghue Rehabilitation Institute~~ and any and all inpatient and
outpatient hospital and clinical facilities and office and research

1 buildings, facilities or property owned by or under the management
2 and control of the University Hospitals Authority or the University
3 Hospitals Trust;

4 2. "Authority" means the University Hospitals Authority;

5 3. "Department" means the Department of Human Services;

6 4. "Commission" means the Commission for Human Services or the
7 Oklahoma Public Welfare Commission;

8 5. "University Hospital" means ~~Everett Tower and the North~~
9 ~~Pavilion, which have been renamed as Children's Hospital at the~~
10 ~~University of Oklahoma Medical Center~~ the inpatient and outpatient
11 hospital and clinical facilities and office and research buildings,
12 facilities or property assigned for the use of University Hospital
13 by the University Hospitals Authority; and

14 6. "Oklahoma Children's Hospital of Oklahoma" means the
15 ~~Bielstein, Garrison, Nicholson and MRI towers which are no longer~~
16 ~~being used as hospitals~~ inpatient and outpatient hospital and
17 clinical facilities and office and research buildings, facilities or
18 property assigned for the use of Oklahoma Children's Hospital by the
19 University Hospitals Authority. Any statutory reference to
20 "Children's Hospital of Oklahoma" or "Children's Hospital" shall be
21 construed to refer to Oklahoma Children's Hospital as defined in
22 this section.

23 B. The University Hospitals Authority may assign any inpatient
24 and outpatient hospital and clinical facilities, research buildings,

1 facilities or property and any other buildings, facilities or
2 property under its ownership or management and control to University
3 Hospital, Oklahoma Children's Hospital or any other division or
4 entity which is part of University Hospitals.

5 C. No person or entity shall use the title "Oklahoma Children's
6 Hospital" or "Children's Hospital of Oklahoma" for any purpose
7 without the express permission of the University Hospitals Trust.

8 No person or entity shall use the title "Children's Hospital" with
9 respect to Children's Hospital of Oklahoma as defined in this
10 section without the express permission of the University Hospitals
11 Trust.

12 SECTION 2. AMENDATORY 63 O.S. 2011, Section 3206, is
13 amended to read as follows:

14 Section 3206. Oklahoma Children's Hospital ~~of Oklahoma~~ shall
15 serve as a general hospital and service institution for persons
16 under twenty-one (21) years of age and shall have the authority to
17 extend transplant services to persons twenty-one (21) years or
18 older.

19 SECTION 3. This act shall become effective November 1, 2021.
