13	BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:
14	SECTION 1. AMENDATORY 26 O.S. 2011, Section 2-129, as
15	amended by Section 1, Chapter 202, O.S.L. 2013 (26 O.S. Supp. 2014,
16	Section 2-129), is amended to read as follows:
17	Section 2-129. The inspector shall be paid Ninety-five Dollars
18	(\$95.00) One Hundred Fifty Dollars (\$150.00) for each election and
19	shall be allowed mileage reimbursement at the rate provided by the
20	State Travel Reimbursement Act for mileage incurred to receive or
21	return ballots and materials for the election. Judges $_{\overline{ au}}$ and clerks
22	and counters shall be paid Eighty-five Dollars (\$85.00) One Hundred
23	Twenty-five Dollars (\$125.00) for each election. Provided, if an
24	inspector, judge or clerk does not perform his or her duties for the

1 entire day of the election, the payment amounts set forth in this 2 section, excluding mileage reimbursement, shall be reduced to 3 seventy-five percent (75%) of the original amount. Precinct officials assigned to work a polling place ten (10) miles or more 4 5 from their home_{τ} shall be allowed mileage reimbursement at the rate provided by the State Travel Reimbursement Act for mileage incurred 6 7 from their home to and from their assigned polling place. An additional Two Dollars (\$2.00) per election shall be paid to each 8 9 inspector, judge, and clerk and counter of a precinct from the funds 10 of the county. Compensation provided herein shall be paid for any 11 state, county, municipal or school district election; provided, 12 however, that compensation for elections conducted concurrently 13 shall not exceed in total the amount herein prescribed. Said compensation shall be paid by the State Election Board for all 14 15 regular Primary, Runoff Primary and General Elections, all statewide special elections and all special elections for United States 16 Representatives or United States Senators and State Senators or 17 State Representatives. Provided, the county election board may 18 appoint volunteer inspectors, judges, clerks and counters who shall 19 not receive the compensation provided herein. 20 SECTION 2.
