20	report inspection; providing for fines; setting maximum fine amount; making each day of violation a
21	separate offense; barbering schools; providing for regional accreditation recognized by the Department
22	of Education; increasing number of apprentices; setting certificate fee; providing for hairbraiding
23	certificate; and providing an effective date.

1 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA: 2 SECTION 1. AMENDATORY 59 O.S. 2011, Section 199.1, as 3 last amended by Section 1, Chapter 62, O.S.L. 2018 (59 O.S. Supp. 4 2018, Section 199.1), is amended to read as follows: 5 Section 199.1. As used in the Oklahoma Cosmetology and 6 Barbering Act: 7 "Apprentice" means a person who is engaged in learning the 1. 8 practice of cosmetology or barbering in a cosmetology or barbering 9 establishment; 10 "Barber" or "barber stylist" means any person who engages in 2. 11 the practice of barbering; 12 "Barbering" means any one or any combination of the 3. 13 following practices, when done upon the upper part of the human body 14 for cosmetic purposes and when done for payment either directly or 15 indirectly for the general public, constitutes the practice of 16 barbering, to wit: Shaving or trimming the beard, or cutting the 17 hair; giving facial or scalp massages or treatment with oils, 18 creams, lotions or other preparations, either by hand or mechanical 19 appliances; singeing, shampooing or applying lighteners or color to 20 the hair or applying hair tonics; applying cosmetic preparations, 21 antiseptics, powders, oils, clays or lotions to scalp, face, neck or 22 upper part of the body; and removing superfluous hair from the face, 23 neck or upper part of the body; 24

4. "Barber establishment" means an establishment or place of
 business where one or more persons are engaged in the practice of
 barbering, but shall not include barber schools or colleges;

4 5. "Barber school" or "barber college" means an establishment
5 operated for the purpose of teaching barbering;

6 6. "Board" means the State Board of Cosmetology and Barbering;
7 7. "Cosmetic studio" means any place or premises where
8 demonstrators give demonstrations, without compensation, for the
9 purpose only of advertising and selling cosmetics;

10 8. "Cosmetician Cosmetician/stylist" means a person licensed by 11 the Board to perform patron services limited to hair arranging and 12 application of makeup, including, but not limited to, using 13 hairstyling tools and products. Services must be performed in a 14 licensed establishment;

9. "Cosmetology" means any one or a combination of practices 15 generally and usually performed by and known as the occupation of 16 beauticians, beauty culturists, beauty operators, cosmeticians, 17 cosmetologists or hairdressers, or of any other person holding 18 himself or herself out as practicing cosmetology by whatever 19 designation and within the meaning of the Oklahoma Cosmetology and 20 Barbering Act and in or upon whatever place or premises. 21 Cosmetology shall include, but not be limited to, any one or 22 combination of the following practices: bleaching, cleansing, 23 curling, cutting, coloring, dressing, removing, singeing, styling, 24

1 waving, or similar work, upon the hair of any person by any means 2 whether, and with hands or mechanical or electrical apparatus or appliances. Nothing in the Oklahoma Cosmetology and Barbering Act 3 shall be construed to prohibit the use of hands or mechanical or 4 5 electrical apparatus or appliances any of the devices for the nonpermanent removal of hair from the human body without puncturing the 6 skin, or by the use of cosmetic preparations, antiseptics, tonics, 7 lotions, or creams, massaging, cleansing, stimulating, exercising, 8 9 beautifying, or similarly working similar work, the scalp, face, 10 neck, arms, bust, upper part of the body or the manicuring of the nails of any person, exclusive of such of the foregoing practices as 11 12 come within the scope of the practice of the healing arts as provided by the laws of this state; 13

14 10. "Cosmetology establishment" means an establishment or place 15 of business where one or more persons are engaged in the practices 16 of cosmetology but shall not include cosmetology schools or 17 colleges;

18 11. "Cosmetology or barber school/college" means any place or 19 premises where instruction in any or all the practices of 20 cosmetology or barbering is given. Any person, firm, institution or 21 corporation, who holds himself, herself or itself out as a school to 22 teach and train, or any person, firm, institution or corporation who 23 shall teach and train any other person or persons in any of the 24 practices of cosmetology or barbering is hereby declared to be

engaged in operating a cosmetology and/or barber school, and shall be subject to the provisions of the Oklahoma Cosmetology and Barbering Act. Licensed cosmetology and/or barber schools may offer education to secondary and post secondary students in the state;

5 12. "Demonstrator" means a person who is not licensed in this 6 state as an operator or instructor and who demonstrates any cosmetic 7 preparation. The person shall be required to obtain a Demonstrator 8 license and pass a state written exam relating to general safety and 9 sanitation from the Board before making any such demonstrations;

10 13. "Facial/Esthetics instructor" means a person licensed by 11 the Board as a qualified teacher of the art and science of facial 12 and esthetics theory and practice;

13 14. "Facialist/Esthetician" means any person who gives facials 14 for compensation;

15 <u>15.</u> <u>14.</u> "Hairbraiding technician" means a person certified by 16 the Board to perform hairbraiding techniques, and hair extensions in 17 a licensed cosmetology establishment;

18 <u>16.</u> <u>15.</u> "Hybrid learning" means courses that combine face-to-19 face classroom instruction with on-line, computer-based learning;

20 <u>17. 16.</u> "Manicurist/Nail technician" means a person who gives 21 manicures, gives pedicures, or applies artificial nails;

22 18. "Manicurist/Nail technician instructor" means a person
23 licensed by the Board as a qualified teacher of the art and science
24 of nail technology theory and practice;

1 <u>19. "Master barber instructor</u>" <u>17. "Master instructor barber"</u> 2 means a person who gives instruction in barbering or any practices 3 thereof;

4 20. Master cosmetology instructor" <u>18. "Master instructor</u>
5 <u>cosmetology"</u> means a person who gives instruction in cosmetology or
6 any practices thereof;

7 <u>19. "Master instructor facial/esthetician" means a person</u>
8 <u>licensed by the Board as a qualified teacher of the art and science</u>
9 <u>of facial and esthetics theory and practice;</u>

10 20. <u>"Master instructor manicurist/nail technician" means a</u>
11 person licensed by the Board as a qualified teacher of the art and
12 science of nail technology theory and practice;

13 21. "Post-secondary institution" means a school licensed to 14 teach students according to prescribed curriculum as in paragraph 1 15 of subsection F of Section 199.7 of this title and in Board rule 16 175:10-3-34(a);

17 22. "Public school" means any state-supported institution18 conducting a cosmetology program;

19 23. "Secondary institution" means a school licensed to teach 20 students eligible for credit of five hundred (500) hours of related 21 subjects as prescribed in paragraph 2 of subsection F of Section 22 199.7 of this title and in Board rule 175:10-3-34 (b); and

24. "Student" means a person who is enrolled in and attending a
 cosmetology school for the purpose of learning the practice of
 cosmetology or barbering.

SECTION 2. AMENDATORY 59 O.S. 2011, Section 199.3, as
last amended by Section 2, Chapter 62, O.S.L. 2018 (59 O.S. Supp.
2018, Section 199.3), is amended to read as follows:

Section 199.3. A. In order to safeguard and protect the health and general welfare of the people of the State of Oklahoma, the State Board of Cosmetology and Barbering is hereby vested with the powers and duties necessary and proper to enable it to fully and effectively carry out the provisions of the Oklahoma Cosmetology and Barbering Act.

B. The Board shall have the powers and duties to:

Promulgate rules pursuant to the Administrative Procedures 1. 14 Act relating to standards of sanitation which must be observed and 15 practiced by all cosmetology and barber establishments, cosmetology 16 or and barber schools, master cosmetology instructors, master barber 17 instructors, barbers, apprentices, students, and board licensees 18 persons licensed or certified by the Board. The Board shall furnish 19 copies of the rules to the owner or manager of each cosmetology 20 school, barber school and cosmetology and barber establishment 21 operating in this state. It shall be the duty of each owner or 22 manager to post a copy of the rules in a conspicuous place in each 23 of the establishments or schools; 24

1 2. Conduct examinations of applicants for certificates of registration licensure or certification as manicurist 2 manicurist/nail technicians, cosmetologists, facial operators 3 facial/estheticians, hairbraiding technician technicians, 4 5 manicurist/nail technician instructor master instructors manicurist/nail technician, facial/esthetics instructor master 6 7 instructors facial/esthetician, master cosmetology instructor master instructors cosmetology, cosmetician cosmetician/stylists, barber 8 9 barbers, or barber instructor master instructors barber at such 10 times and places determined by the Board. Applications for all examinations shall be made on forms approved by the Board; 11 3. Keep a record of all its proceedings. The Board shall keep 12 a record of all applicants for certificates, licenses and permits, 13 showing the name of the applicant, the name and location of the 14 place of occupation or business, if any, and the residence address 15 of the applicant, and whether the applicant was granted or refused a 16 certificate, license, or permit. The records of the Board shall be 17 valid and sufficient evidence of matters contained therein $_{\tau}$ and 18 shall constitute public records. Records shall be open to public 19 inspection at all reasonable times and subject to the Oklahoma Open 20 Records Act. Notwithstanding any other provision of law to the 21 contrary, records and information obtained in connection with an 22 investigation of alleged violations, including complaints, identity 23

24 of a complainant, investigative reports, and documentation or images

1	generated or received during the course of an investigation, shall
2	be confidential and shall not be subject to disclosure;
3	4. Notwithstanding any other provision of law to the contrary,
4	records and information obtained in connection with an investigation
5	of alleged violations, including complaints, identity of a
6	complainant, investigative reports, and documentation or images
7	generated or received during the course of an investigation, shall
8	be confidential and shall not be subject to disclosure. However,
9	such information may be introduced by the state in administrative
10	proceedings before the Board and the information then becomes a
11	public record. The Board may also provide such information to law
12	enforcement and other public agencies as necessary and appropriate
13	in the discharge of the duties of that agency. The respondent in a
14	complaint may acquire information obtained during an investigation,
15	unless the disclosure of the information is otherwise prohibited,
16	except for the investigative report, if the respondent signs a
17	protective order whereby the respondent agrees to use the
18	information solely for the purpose of defense in the Board
19	proceeding and in any appeal therefrom and agrees to not otherwise
20	disclose the information. This subsection shall not apply to
21	routine inspection reports.
22	5. Issue all certificates of registration , licenses, permits,
23	registrations, notices and orders;
24	

5. 6. Establish and conduct examinations for limited specialty
 licenses for cosmetician, facial/esthetics instructor,

3 manicurist/nail technician instructor, master barber instructor, or
4 master cosmetology instructor and certificates within the practice
5 of cosmetology and barbering. The Board shall also promulgate rules
6 for special said specialty licenses and certificates, including but
7 not limited to reduced curriculum requirements, as the Board may
8 deem appropriate and necessary to further the purposes of the
9 Oklahoma Cosmetology and Barbering Act;

10 6. 7. Make regular inspections of all cosmetology and barber 11 barbering schools and cosmetology and barber barbering 12 establishments licensed to operate in this state, and reports thereof shall be kept and maintained in the office of the Board; 13 7. 8. Make investigations and reports on all suspected or 14 reported violations of the Oklahoma Cosmetology and Barbering Act; 15 8. 9. Take samples of beauty supplies for the purpose of 16 chemical analysis; provided, that if the owner demands payment for 17 the sample taken, payment at the regular retail price shall be made; 18 9. Refuse, revoke, 10. Revoke or suspend licenses, 19 certificates of registration or permits after notice and an 20 opportunity for a full hearing, pursuant to Article II of the 21 Administrative Procedures Act, on proof of violation of any of these 22 provisions of the Cosmetology and Barbering Act or the rules 23

24 established by the Board;

1 <u>10. 11.</u> Enter into any contracts necessary to implement or 2 enforce the provisions of the Oklahoma Cosmetology and Barbering Act 3 or rules promulgated thereto; and

4 <u>11. 12.</u> Apply to a court of competent jurisdiction for an order
5 enjoining <u>an unlicensed a person not licensed or certified by the</u>
6 <u>Board from practicing cosmetology or barbering or holding himself or</u>
7 herself out as a practitioner of cosmetology or barbering.
8 Injunctive relief granted by the court shall be without bond.

9 C. 1. Any person whose license, certificate of registration, 10 or permit has been suspended or revoked may, after the expiration of 11 thirty (30) days, make application to the Board for reinstatement 12 thereof.

Reinstatement of any such license, certificate of
 registration, or permit shall rest in the sound discretion of the
 Board.

3. Any action of the Board in refusing, revoking, or suspending a license, certificate of registration, or permit may be appealed to the district court of the county of the appellant's residence pursuant to the Administration Procedures Act.

D. 1. In any case where a <u>licensee person licensed or</u> <u>certified by the Board</u> becomes a member of the Armed Forces of the United States, such license <u>or certificate</u> shall not lapse by reason thereof but shall be considered and held in force and effect without further payment of license or certificate fees during the period of

service in the Armed Forces of the United States and for six (6)
 months after honorable release from the Armed Forces of the United
 States the licensee person may resume practice pursuant to a license
 <u>or certificate</u> without other or further examination by notifying the
 Board in writing.

2. The period of time in which the licensee person licensed or
<u>certified by the Board</u> shall have been a member of the Armed Forces
of the United States shall not be computed in arriving at the amount
of fee or fees due or to become due by such licensee person.

10 SECTION 3. AMENDATORY 59 O.S. 2011, Section 199.4, as 11 amended by Section 88, Chapter 229, O.S.L. 2013 (59 O.S. Supp., 12 Section 199.4), is amended to read as follows:

Section 199.4. The State Board of Cosmetology and Barbering shall employ an executive director who shall be in charge of the office of the Board. The executive director shall have such qualifications as shall be established by rules of the Board; provided, the executive director shall not be actively engaged in the practice of cosmetology or barbering while serving as executive director. The executive director shall:

Devote his or her entire time to the duties of the office;
 Receive salary and benefits as provided by law;

3. Keep and preserve all books and records pertaining to theBoard;

1 4. Have authority, in the name of and in behalf of the Board, to issue all licenses, certificates of registration, permits, 2 3 registrations, orders, and notices; 5. Have authority to collect all fees and penalties provided 4 5 for by the Oklahoma Cosmetology and Barbering Act; 6. Make quarterly reports to the Board of all monies collected 6 and the sources from which derived; 7 7. Have authority to approve payrolls and all claims for the 8 9 Board; 8. Have authority to employ staff; 10 9. Keep a continuous inventory of all properties, excluding 11 12 supplies, belonging to the Board; and 10. Perform such other duties as may be directed by the Board. 13 59 O.S. 2011, Section 199.6, as SECTION 4. AMENDATORY 14 last amended by Section 4, Chapter 260, O.S.L. 2014 (59 O.S. Supp. 15 2018, Section 199.6), is amended to read as follows: 16 Section 199.6. A. The State Board of Cosmetology and Barbering 17 is hereby authorized to promulgate rules for governing the 18 examination and licensure or certification of cosmetologists, 19 manicurists, nail technicians manicurist/nail technicians, 20 estheticians facial/estheticians, cosmeticians cosmetician/stylists, 21 hair braiding technicians, master cosmetology instructors master 22 instructors cosmetology, manicurist instructors master instructors 23 manicurist/nail technician, esthetics instructors master instructors 24

<u>facial/esthetician</u>, barbers, and <u>master barber instructors master</u> <u>instructors barber</u>. The Board is hereby authorized to promulgate rules to govern the sanitary operation of cosmetology and barbering establishments and to administer fines not to exceed Fifty Dollars (\$50.00) for those licensed and not to exceed Five Hundred Dollars (\$500.00) for those not licensed. Each day a violation continues shall be construed as a separate offense.

B. The State Board of Cosmetology and Barbering shall have the
power and duty to implement rules of the Board, to issue and renew
licenses <u>and certificates</u>, to inspect cosmetology and barbering
establishments and schools, and to inspect the sanitary operating
practices of cosmetology and barbering licensees, including sanitary
conditions of cosmetology and barbering establishments and schools.

14 C. It shall be unlawful and constitute a misdemeanor, 15 punishable upon conviction by a fine of not less than Fifty Dollars 16 (\$50.00), nor more than One Hundred Fifty Dollars (\$150.00), or by 17 imprisonment in the county jail for not more than thirty (30) days, 18 or both such fine and imprisonment, for any person, firm, or 19 corporation in this state to:

Operate or attempt to operate a cosmetology school/college,
 cosmetology or barber establishment, cosmetology or barber school or
 college that offers cosmetology, barbering or both without having
 obtained a license therefor from the State Board of Cosmetology and
 Barbering;

2. Give or attempt to give instruction in cosmetology or
 barbering, without having obtained an instructor's <u>a master</u>
 <u>instructor</u> license from the State Board of Cosmetology and
 Barbering;

3. Practice or offer to practice barbering, cosmetology or
manicuring without having obtained a license therefor from the
Board;

8 4. Operate a cosmetic studio without having obtained a license9 therefor from the Board;

10 5. Demonstrate a cosmetic preparation without having obtained a 11 demonstrator's license from the Board;

12 6. Permit any person in one's employ, supervision, or control
13 to practice cosmetology or barbering unless that person has obtained
14 an appropriate license <u>or certificate</u> from the Board;

7. Willfully violate any rule promulgated by the Board for the
sanitary management and operation of a cosmetology or barber
establishment, cosmetology school or barber college; or

18 8. Violate any of the provisions of the Oklahoma Cosmetology
 19 and Barbering Act.

D. The State Board of Cosmetology and Barbering shall have the authority to levy administrative fines not to exceed Five Hundred Dollars (\$500.00) for persons practicing cosmetology or barbering without a license <u>or certificate</u>, for persons operating <u>a</u> cosmetology or barbering establishment or school without a license,

and for owners of licensed establishments who allow unlicensed
individuals persons who are not licensed or certified by the Board
to practice cosmetology or barbering without a license in their
establishment. Each day a violation continues shall be a separate
offense. The administrative fine shall not exceed a total of Five
Hundred Dollars (\$500.00).

E. <u>The Board shall have the authority to levy fines not to</u>
<u>exceed Five Hundred Dollars (\$500.00) for any violation of the</u>
<u>Oklahoma Cosmetology and Barbering Act, including violations listed</u>
<u>in subsection (C) above, and any rules of the Board. Each day a</u>
violation continues shall be a separate offense.

12 <u>F.</u> The provisions of the Oklahoma Cosmetology and Barbering Act 13 shall not apply to the following persons while such persons are 14 engaged in the proper discharge of their professional duties;

15 1. Funeral directors;

16 2. Persons in the Armed Services;

Persons authorized to practice the healing arts or nursing;
 or

Regularly employed sales people working in retail
 establishments engaged in the business of selling cosmetics in
 sealed packages.

1 Section 199.7. A. Each cosmetology and barber school shall be licensed annually by the State Board of Cosmetology and Barbering. 2 Application for the first year's license for a cosmetology and 3 barber school shall be accompanied by a fee of Four Hundred Dollars 4 5 (\$400.00), which shall be retained by the Board if the application is approved and a license is issued. The annual renewal license fee 6 7 for cosmetology or barber schools shall be One Hundred Twenty-five Dollars (\$125.00). 8

9 Β. 1. No license or renewal thereof for a cosmetology or barber school shall be issued unless the owner thereof furnishes to 10 11 the Board a good and sufficient surety bond in the principal sum of Two Thousand Dollars (\$2,000.00) for the first instructor and an 12 additional One Thousand Dollars (\$1,000.00) for each additional 13 instructor, executed by a surety company authorized to do business 14 in this state, and conditioned on the faithful performance of the 15 terms and conditions of all contracts entered into between the owner 16 of the cosmetology or barber school and all persons enrolling 17 therein. 18

19 2. The surety bond shall be in a form approved by the Attorney 20 General and filed in the Office of the Secretary of State. Suit may 21 be brought on the bond by any person injured by reason of the breach 22 of the conditions thereof.

C. It shall be the duty of the owner or manager of acosmetology or barber school to enter into a written contract with

all students before permitting students to attend any classes.
Contracts shall be made out in triplicate, the original copy to be retained by the school, the duplicate to be given to the student, and the triplicate to be filed with the executive director of the Board.

D. A school licensed or applying for licensure shall maintain
recognition as an institution of postsecondary study by meeting the
following conditions:

9 1. The school shall admit as a regular student only an
10 individual who has earned a recognized high school diploma, or who
11 is beyond the age of compulsory high school attendance;

12 2. The school shall be licensed by name, or in the case of an
13 applicant, shall apply for licensure by name, to offer one or more
14 training programs beyond the secondary level.

E. No license for a cosmetology or barber school shall be issued unless the owner thereof presents evidence satisfactory to the Board that the school has satisfactory facilities and equipment and has instructors qualified to give a course of study as provided in the Oklahoma Cosmetology and Barbering Act.

F. There shall be included in the curriculum for cosmetology and barber schools, courses of study in the theory of cosmetology and barbering related theory, studies in manipulative practices, sterilization and sanitation, shop management, and such other related subjects as may be approved by the Board.

1 G. 1. The Board shall adopt a curriculum of required courses of instruction in theory and training of either one thousand five 2 hundred (1,500) clock hours or an equivalent number of credit hours 3 as recognized by the United States Department of Education or a 4 5 regional or national accreditation entity recognized by the United States Department of Education in a basic course to be taught in all 6 cosmetology or barbering schools in the state. The basic 7 cosmetology or barbering course shall be designed to qualify 8 9 students completing the course to take the examination for a license. 10

2. Cosmetology and barber students in vocational, trade, and 11 12 industrial cosmetology and barbering classes in public schools, parochial, private schools or home schools shall qualify by 13 completing one thousand (1,000) hours in a basic course of 14 cosmetology or barbering and five hundred (500) hours of approved 15 related subjects to be selected from, but not limited to, the 16 following high school courses in a public school, parochial, private 17 or home school: psychology, biology, general science, American 18 history, art, typing I, typing II, business arithmetic, 19 salesmanship, bookkeeping I, bookkeeping II, related mathematics, 20 English II, English III and English IV. 21

H. 1. No person shall be eligible to give instruction in cosmetology or barbering unless the person is the holder of a current unrevoked instructor's license issued by the Board.

2. Each cosmetology or barber school shall employ at least one
 instructor for the first fifteen students registered therein, and at
 least one additional instructor shall be employed for each
 additional group of fifteen students, or major fraction thereof.

3. Students utilizing hybrid learning programs are included in
the total student number as referenced in the ratio in paragraph 2
of subsection G of this section.

8 I. A cosmetology or barbering school may be operated in and as 9 part of an accredited high school.

10 J. No cosmetology or barber school owner or an establishment 11 owner shall charge students or apprentices for cosmetic materials, 12 supplies, apparatus, or machines used by them in practice work. No instructor shall be permitted to do 15 professional or clinical work in a cosmetology or barber school at 16 any time. 17

a. have an eighth-grade education or the equivalentthereof, and

b. be at least sixteen (16) years of age unless they are

No student shall be credited with more than eight (8) hours'

N. No person shall be eligible to register for the examination

P. Each cosmetology or barber school shall prominently display in a conspicuous place above or to the side of the entrance thereto a sign identifying it as an institute of learning. Wording on sign shall be in plain letters at least three (3) inches high and at least one (1) inch wide.

E. Completion of three thousand (3,000) hours of apprentice training in a cosmetology or barbering establishment is the equivalent of one-thousand-five-hundred-hours training in a cosmetology or barber school and shall entitle the apprentice to take the examination.

6 SECTION 7. AMENDATORY 59 O.S. 2011, Section 199.9, as 7 last amended by Section 7, Chapter 260, O.S.L. 2014 (59 O.S. Supp. 8 2018, Section 199.9), is amended to read as follows:

9 Section 199.9. A. The State Board of Cosmetology and Barbering 10 shall not issue a license for a cosmetology or barber establishment 11 until an inspection has been made of the salon establishment and 12 equipment, including the sanitary facilities thereof. Temporary approval pending inspection may be made upon sworn affidavit by the 13 license applicant that all requirements have been met. No license 14 shall be issued for a cosmetology or barber establishment to be 15 operated in a private home or residence unless the salon 16 establishment is located in a room or rooms not used or occupied for 17 residential purposes. 18

B. 1. Except as otherwise provided in the Oklahoma Cosmetology and Barbering Act, it shall be unlawful for any person to practice cosmetology or barbering in any place other than a licensed establishment or school licensed by the Board.

23 2. In an emergency such as illness, invalidism, or death, a
 24 licensed operator practitioner licensed or certified by the Board

1 may perform cosmetology or barbering services for a person by 2 appointment in a place other than a licensed cosmetology or barber 3 establishment or cosmetology or barber school.

salon which provides both cosmetology and barbering services must
obtain a license from the Board.

The public display of a licensee's personal 16 residential address on the face of any license issued pursuant to 17 the provisions of the Oklahoma Cosmetology and Barbering Act shall 18 be prohibited on and after July 1, 2016, and such personal address 19 information, if publically displayed on a valid license, may be 20 redacted by the licensee until the license is renewed and no longer 21 bears his or her personal residential address. 22

B. Applications for renewal must be made on or before the last
 day of the month in which the applicant's birthday falls, and shall
 be accompanied by the appropriate fees.

C. Any person who fails to renew the license <u>or certificate</u>
within the required time, may make application for renewal at any

<u>or certificate</u> by paying the regular renewal license fee and a late
fee of Ten Dollars (\$10.00), which becomes due two (2) months after
the expiration date.

D. Any person who fails to renew within the required time may make application with subsequent renewal and penalty fees.

E. Before a person may take an examination to renew an expired license <u>or certificate</u> after a period of five (5) years, such person shall register in a cosmetology or barber school for the given number of review hours in accordance with the following timetable and schedule based upon the type of license or certificate held.
