AMENDATORY 15 (63 O.S. Supp. 2016, Section 1-1440.1), is amended to read as follows: 16 Section 1-1440.1. As used in the Home Bakery Act of 2013: 17 "Home food establishment" shall mean a business on the 18 premises of a residence in which prepared food is created for sale 19 or resale, for consumption off the premises at farmers markets, on 20 site, at cooperatives, through membership-based buying clubs or for 21 delivery, if the business has gross annual sales of prepared food of 22 less than Twenty Thousand Dollars (\$20,000.00). Gross annual sales 23

- 1 includes all sales of prepared food produced by the business at any 2 location; and
- 2. "Prepared food" shall mean any baked goods except for products that contain meat products or fresh fruit.

- 8 Section 1-1440.2. A. A home food establishment may sell

- 19 C. The Oklahoma Department of Agriculture, Food, and Forestry
- 20 may, upon a consumer complaint, request written documentation to
