6 AS INTRODUCED

7 An Act relating to judicial officers; amending 20
8 O.S. 2011, Sections 3.1, 3.2, 3.3, 30.2A and 31.2,
9 which relate to salaries; requiring legislative
10 approval of changes in judicial compensation;
11 authorizing legislative amendment of changes in
12 judicial compensation; modifying compensation of
13 certain judicial officers; requiring payment from
14 existing available funds; and providing an effective
15 date.

16 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

17 SECTION 1. AMENDATORY 20 O.S. 2011, Section 3.1, is
18 amended to read as follows:

19 Section 3.1. A. Except as otherwise provided by the Board on
20 Judicial Compensation, the following judicial officers shall receive
21 compensation for their services, payable monthly as follows:

22 1. The Chief Justice of the Supreme Court shall receive an
23 annual salary of ~~One Hundred Seventeen Thousand Five Hundred~~
24 ~~Seventy-one Dollars (\$117,571.00)~~ One Hundred Sixty-four Thousand
Six Hundred Forty Dollars (\$164,640.00); and

1 2. An Associate Justice of the Supreme Court shall receive an
2 annual salary of ~~One Hundred Thirteen Thousand Five Hundred Seventy-~~
3 ~~one Dollars (\$113,571.00)~~ One Hundred Fifty-four Thousand One
4 Hundred Seventy-four Dollars (\$154,174.00).

5 B. Any increase in salary provided for in subsection A of this
6 section must be paid from existing available funds.

7 SECTION 2. AMENDATORY 20 O.S. 2011, Section 3.2, is
8 amended to read as follows:

9 Section 3.2. A. There is hereby created the Board on Judicial
10 Compensation. Pursuant to the provisions of Section 11 of Article
11 VII of the Oklahoma Constitution, members of the State Judiciary
12 shall receive compensation as shall be fixed by the Board on
13 Judicial Compensation as provided in ~~this act~~ Section 3.1 et seq. of
14 this title, unless if such compensation is ~~rejected~~ approved, or
15 amended and approved, by law passed by a majority vote of each house
16 of the Legislature. If the Governor vetoes such a law, the
17 procedure shall be the same as for the veto of any other bill or
18 joint resolution.

19 B. The Board shall be composed of seven (7) members. Two
20 members shall be appointed by the President Pro Tempore of the
21 Senate, two members shall be appointed by the Speaker of the House
22 of Representatives, two members shall be appointed by the Governor,
23 and one member shall be appointed by the Chief Justice of the
24 Supreme Court. The members appointed by the President Pro Tempore

1 of the Senate shall be from labor and civic organizations. The
2 members appointed by the Speaker of the House of Representatives
3 shall be from communications media and retail business. The members
4 appointed by the Governor shall be from manufacturing and
5 professional fields not otherwise specified. The member appointed
6 by the Chief Justice of the Supreme Court shall be from agriculture.
7 No more than four members shall be from any one political party. No
8 active or retired judge or attorney practicing law in any state may
9 serve on the Board on Judicial Compensation.

10 C. The Administrative Office of the Courts shall provide such
11 staff and support as is necessary for the Board on Judicial
12 Compensation to carry out its duties. Requests from the Board for
13 staff and support shall be coordinated through the Office of the
14 Administrative Director of the Courts.

15 D. The members of the Board shall serve terms which run
16 concurrently with the terms of the respective appointing authorities
17 and shall serve at their pleasure.

18 E. The members of the Board shall select a chair and secretary
19 and such other officers as they deem necessary.

20 F. Members of the Board shall serve without compensation but
21 shall be reimbursed by their appointing authority for all actual and
22 necessary expenses incurred in the performance of their duties in
23 accordance with the State Travel Reimbursement Act.

1 SECTION 3. AMENDATORY 20 O.S. 2011, Section 3.3, is
2 amended to read as follows:

3 Section 3.3. A. The Board on Judicial Compensation shall meet
4 on the third Tuesday of September in every odd-numbered year in the
5 Administrative Office of the Courts, at which meeting the Board
6 shall review the compensation paid to members of the State Judiciary
7 and, if necessary, change the compensation. In its review, the
8 Board shall consider various factors, including judicial
9 compensation in other states, with an emphasis on states within the
10 region, the value of comparable services performed in the private
11 sector, compensation of attorneys in the private and public sectors,
12 compensation of other state, county and municipal public officials,
13 and changes in the cost of living. The Board may, at the call of
14 the chair or upon a majority vote of its membership, hold such
15 additional meetings as are necessary to carry out its official
16 duties. Any change in judicial compensation shall be made by the
17 Board not later than the third Tuesday of November in said odd-
18 numbered year. Four members of the Board shall constitute a quorum
19 and a majority vote of the quorum shall be necessary for the Board
20 to act.

21 B. Any change in judicial compensation, ~~unless rejected or~~
22 ~~amended as provided for in Section 2 of this act~~ if approved, or
23 amended and approved, by the Legislature as provided in Section 3.2
24 of this title, shall become effective on July 1 of the following

1 calendar year. Any amendment passed by a majority vote of each
2 house of the Legislature shall become effective as provided by ~~said~~
3 such amendment unless vetoed by the Governor.

4 SECTION 4. AMENDATORY 20 O.S. 2011, Section 30.2A, is
5 amended to read as follows:

6 Section 30.2A. A. Except as otherwise provided by the Board on
7 Judicial Compensation, the following judicial officers shall receive
8 compensation for their services, payable monthly as follows:

9 1. The Presiding Judge of the Court of Civil Appeals shall
10 receive an annual salary of ~~One Hundred Nine Thousand Seven Hundred~~
11 ~~Thirty one Dollars (\$109,731.00)~~ One Hundred Forty-eight Thousand
12 Seven Hundred Sixty-four Dollars (\$148,764.00); and

13 2. A Judge of the Court of Civil Appeals shall receive an
14 annual salary of ~~One Hundred Eight Thousand Three Hundred Thirty-six~~
15 ~~Dollars (\$108,336.00)~~ One Hundred Forty-six Thousand Fifty-nine
16 Dollars (\$146,059.00).

17 B. Any increase in salary provided for in subsection A of this
18 section must be paid from existing available funds.

19 SECTION 5. AMENDATORY 20 O.S. 2011, Section 31.2, is
20 amended to read as follows:

21 Section 31.2. A. Except as otherwise provided by the Board on
22 Judicial Compensation, the following judicial officers shall receive
23 compensation for their services, payable monthly as follows:

1 1. The Presiding Judge of the Court of Criminal Appeals shall
2 receive an annual salary of ~~One Hundred Seventeen Thousand Five~~
3 ~~Hundred Seventy-one Dollars (\$117,571.00)~~ One Hundred Fifty-nine
4 Thousand Five Hundred Eighty-three Dollars (\$159,583.00); and

5 2. A Judge of the Court of Criminal Appeals shall receive an
6 annual salary of ~~One Hundred Thirteen Thousand Five Hundred Seventy-~~
7 ~~one Dollars (\$113,571.00)~~ One Hundred Fifty-four Thousand One
8 Hundred Seventy-four Dollars (\$154,174.00).

9 B. Any increase in salary provided for in subsection A of this
10 section must be paid from existing available funds.

11 SECTION 6. This act shall become effective in accordance with
12 the provisions of Section 58 of Article V of the Oklahoma
13 Constitution.
