8 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

9 SECTION 1. AMENDATORY 74 O.S. 2011, Section 250.4, as
10 amended by Section 3 of Enrolled House Joint Resolution No. 1096 of
11 the 2nd Session of the 54th Oklahoma Legislature (74 O.S. Supp.
12 2014, Section 250.4), is amended to read as follows:

13 Section 250.4. Pursuant to provisions of the Constitution of
14 the State of Oklahoma from and after the beginning date of a term of
15 office which commences in, or after, ~~January 1999~~ January of 2016,
16 the following officers of the State of Oklahoma shall be annually
17 compensated for their services, payable monthly, as follows:

18 1. The Governor shall receive a salary ~~equal to the salary~~
19 ~~received by the Chief Justice of the Oklahoma Supreme Court;~~
20 ~~provided however, the Governor shall not receive any increase in~~
21 ~~salary as a result of the provisions of Section 1 of this resolution~~
22 of One Hundred Forty-seven Thousand Dollars (\$147,000.00);

23 2. The Lieutenant Governor shall receive a salary ~~equal to the~~
24 ~~salary received by an associate district judge in a county with a~~

1 ~~population greater than ten thousand (10,000) and less than thirty~~
2 ~~thousand (30,000); provided however, the Lieutenant Governor shall~~
3 ~~not receive any increase in salary as a result of the provisions of~~
4 ~~Section 1 of this resolution of One Hundred Fourteen Thousand Seven~~
5 ~~Hundred Thirteen Dollars (\$114,713.00);~~

6 3. The Attorney General shall receive a salary equal to the
7 salary received by the Presiding Judge of the Court of Civil
8 Appeals; provided however, the Attorney General shall not receive
9 any increase in salary as a result of Section 1 of this resolution
10 of One Hundred Thirty-two Thousand Eight Hundred Twenty-five Dollars
11 (\$132,825.00);

12 4. The State Superintendent of Public Instruction shall receive
13 a salary equal to the salary received by a district judge; provided
14 however, the State Superintendent of Public Instruction shall not
15 receive any increase in salary as a result of the provisions of
16 Section 1 of this resolution of One Hundred Twenty-four Thousand
17 Three Hundred Seventy-three Dollars (\$124,373.00);

18 5. Each member of the Corporation Commission shall receive a
19 salary equal to the salary received by an associate district judge
20 in a county with a population of over thirty thousand (30,000);
21 provided however, the Commissioners shall not receive any increase
22 in salary as a result of the provisions of Section 1 of this
23 resolution of One Hundred Fourteen Thousand Seven Hundred Thirteen
24 Dollars (\$114,713.00);

1 6. The State Treasurer shall receive a salary ~~equal to the~~
2 ~~salary received by an associate district judge in a county with a~~
3 ~~population of over thirty thousand (30,000); provided however, the~~
4 ~~State Treasurer shall not receive any increase in salary as a result~~
5 ~~of the provisions of Section 1 of this resolution~~ of One Hundred
6 Fourteen Thousand Seven Hundred Thirteen Dollars (\$114,713.00);

7 7. The State Auditor and Inspector shall receive a salary ~~equal~~
8 ~~to the salary received by an associate district judge in a county~~
9 ~~with a population of over thirty thousand (30,000); provided~~
10 ~~however, the State Auditor and Inspector shall not receive any~~
11 ~~increase in salary as a result of the provisions of Section 1 of~~
12 ~~this resolution~~ of One Hundred Fourteen Thousand Seven Hundred
13 Thirteen Dollars (\$114,713.00);

14 8. The State Insurance Commissioner shall receive a salary
15 ~~equal to the salary received by an associate district judge in a~~
16 ~~county with a population of over thirty thousand (30,000); provided~~
17 ~~however, the State Insurance Commissioner shall not receive any~~
18 ~~increase in salary as a result of the provisions of Section 1 of~~
19 ~~this resolution~~ of One Hundred Fourteen Thousand Seven Hundred
20 Thirteen Dollars (\$114,713.00); and

21 9. The Commissioner of Labor shall receive a salary ~~equal to~~
22 ~~the salary received by a special judge; provided however, the~~
23 ~~Commissioner of Labor shall not receive any increase in salary as a~~

1 ~~result of the provisions of Section 1 of this resolution of One~~
2 ~~Hundred Five Thousand Fifty-three Dollars (\$105,053.00).~~

3 SECTION 2. This act shall become effective in accordance with
4 the provisions of Section 58 of Article V of the Oklahoma
5 Constitution.
