3 27. <u>26.</u> A conspicuous warning that the application is executed 4 upon the sworn oath of the applicant and that any false or 5 misleading answer to any question or the submission of any false 6 information or documentation by the applicant is punishable by 7 criminal penalty as provided in paragraph 5 of Section 1290.12 of 8 this title;

9 28. 27. A signed verification that the contents of the
10 application are known to the applicant and are true and correct;
11 29. 28. Two separate places for the original signature of the
12 applicant;

13 30. 29. A place for attachment of a passport size photograph of 14 the applicant; and

15 <u>31.</u> <u>30.</u> A place for the signature and verification of the
16 identity of the applicant by the sheriff or the sheriff's designee.

Information provided by the person on an application for a handgun license shall be confidential except to law enforcement officers or law enforcement agencies.

SECTION 2. This act shall become effective November 1, 2015.
