2. The second Tuesday of January and February, the first
 Tuesday in March and April, the last Tuesday in June, the fourth
 Tuesday in August, and the first Tuesday after the first Monday in
 November of any even-numbered year.

D. In the event that a regular or special election date occurs on an official state holiday, the election shall be scheduled for the next following Tuesday. In the event that any day of a candidate filing period occurs on a Saturday, Sunday or any official state holiday, that day of the filing period shall be scheduled for the next business day.

11 Notwithstanding any other provision of law or any provision Ε. 12 of a municipal charter, any municipality, school district, 13 technology center district, county, rural fire protection district, 14 or any other entity seeking to hold a regular or special election to 15 be conducted by a county election board on the same date as a 16 regular or special federal or state election, shall file the 17 resolution calling for the election with the county election board 18 secretary no later than seventy-five (75) days prior to the election 19 date. A candidate filing period of three (3) days, if so required 20 by the resolution, shall begin no later than ten (10) days following 21 the deadline to file the resolution with the secretary of the county 22 election board; provided, the filing period for such municipal 23 office may be scheduled on the same dates as the filing period for 24 state or federal office to be filled at such election. \_ \_
