10 An Act relating to the Oklahoma Tax Commission;  
11 authorizing the Commission to contract with state  
12 agencies for the collection of certain funds;  
13 requiring the Commission to charge a certain fee for  
14 services; requiring the Commission to deposit fee  
15 revenues in the Tax Commission Reimbursement Fund;  
16 authorizing the Tax Commission to contract with the  
17 Oklahoma Employment Security Commission for the  
18 collection of certain funds; specifying terms of  
19 contract; providing for codification; and providing  
20 an effective date.

23 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

24 SECTION 1. NEW LAW A new section of law to be codified  
in the Oklahoma Statutes as Section 255.1A of Title 68, unless there  
is created a duplication in numbering, reads as follows:

In order to facilitate and expedite the collection of any state  
tax as authorized to be assessed and collected by any state agency,  
the Oklahoma Tax Commission may enter into a contract with any state

1 agency to assist in the collection of any state tax, penalties or  
2 interest in which that agency has the authority to collect and  
3 enforce. For providing such collection assistance, the Tax  
4 Commission shall charge the state agency a fee not to exceed ten  
5 percent (10%) of the total amount collected. All funds retained by  
6 the Tax Commission for collection services shall be deposited in the  
7 Tax Commission Reimbursement Fund in the State Treasury. The  
8 Oklahoma Tax Commission and the Oklahoma Employment Security  
9 Commission may enter into a contract whereby the Tax Commission  
10 shall have authority to collect and enforce the unemployment tax,  
11 penalties and interest thereon. Such collection and enforcement  
12 authority shall apply to any unemployment tax, penalties or interest  
13 where a determination that an employer owes delinquent  
14 contributions, penalties or interest has become final and therefor  
15 the Oklahoma Employment Security Commission shall be entitled to  
16 proceed by levy to collect any delinquent contribution and to  
17 collect any penalty or interest due and owing as a result of the  
18 delinquency. The contract shall provide for the collection and  
19 enforcement of the unemployment tax, interest and penalties in the  
20 same manner as the collection and enforcement of any state tax  
21 payable by any taxpayer subject to taxation under any state tax law.

22 SECTION 2. This act shall become effective November 1, 2021.
