15	SECTION 1. AMENDATORY 70 O.S. 2011, Section 5-139, is

17	Section 5-139. School A. Except as provided for in subsection
18	B of this section, school districts shall make payroll deductions
19	for either or both professional organization dues and political
20	contributions upon the request of any school employee and shall
21	transmit deducted funds to the organization designated by the school
22	district employee. Such deductions shall be on a ten-month basis
23	unless otherwise designated by the employee organization. However,
24	a school employee may request in writing at any time for the school

    a professional organization. Upon receipt of a request the school

    district shall within five (5) business days or by the next pay

    district shall notify the professional organization of the

B. 1. It shall be unlawful for any school district to make payroll deductions on behalf of a school administrator for membership dues in a statewide organization that represents public school administrators.

- 2. It shall also be unlawful for any school district to pay membership dues or any other participation fees on behalf of a school administrator for membership or participation in a statewide organization that represents public school administrators.
- 3. For the purposes of this subsection, "school administrator" shall include public school superintendents, principals and vice principals.

SECTION 2. This act shall become effective July 1, 2017.
