12	SECTION 1. AMENDATORY 21 O.S. 2021, Section 1111, as
13	last amended by Section 2, Chapter 260, O.S.L. 2022 (21 O.S. Supp.
14	2023, Section 1111), is amended to read as follows:
15	Section 1111. A. Rape is an act of sexual intercourse
16	involving vaginal or anal penetration accomplished with a male or
17	female who is not the spouse of the perpetrator and who may be of
18	the same or the opposite sex as the perpetrator under any of the
19	following circumstances:
20	1. Where the victim is under <del>sixteen (16)</del> eighteen (18) years
21	of age;
22	2. Where the victim is incapable through mental illness or any
23	other unsoundness of mind, whether temporary or permanent, of giving
24	legal consent;

 by apparent power of execution to the victim or to another person;
 4. Where the victim is intoxicated by a narcotic or anesthetic

4 agent, administered by or with the privity of the accused as a means 5 of forcing the victim to submit;

6 5. Where the victim is at the time unconscious of the nature of7 the act and this fact is known to the accused;

8 6. Where the victim submits to sexual intercourse under the 9 belief that the person committing the act is a spouse, and this 10 belief is induced by artifice, pretense, or concealment practiced by 11 the accused or by the accused in collusion with the spouse with 12 intent to induce that belief. In all cases of collusion between the 13 accused and the spouse to accomplish such act, both the spouse and 14 the accused, upon conviction, shall be deemed guilty of rape;

7. Where the victim is under the legal custody or supervision 15 of a state agency, a federal agency, a county, a municipality or a 16 political subdivision and engages in sexual intercourse with a 17 state, federal, county, municipal or political subdivision employee 18 or an employee of a contractor of the state, the federal government, 19 a county, a municipality or a political subdivision that exercises 20 authority over the victim, or the subcontractor or employee of a 21 subcontractor of the contractor of the state or federal government, 22 a county, a municipality or a political subdivision that exercises 23 authority over the victim; 24

8. Where the victim is at least sixteen (16) years of age and is less than twenty (20) years of age and is a student, or under the legal custody or supervision of any public or private elementary or secondary school, junior high or high school, or public vocational school, and engages in sexual intercourse with a person who is eighteen (18) years of age or older and is an employee of a school system;

9. Where the victim is nineteen (19) years of age or younger
and is in the legal custody of a state agency, federal agency or
tribal court and engages in sexual intercourse with a foster parent
or foster parent applicant; or

12 10. Where the victim is a student at a secondary school, is 13 concurrently enrolled at an institution of higher education, and 14 engages in acts pursuant to this subsection with a perpetrator who 15 is an employee of the institution of higher education of which the 16 victim is enrolled.

Β. "Employee of an institution of higher education", for 17 purposes of this section, means faculty, adjunct faculty, 18 instructors, volunteers, or an employee of a business contracting 19 with an institution of higher education who may exercise, at any 20 time, institutional authority over the victim. Employee of an 21 institution of higher education shall not include an enrolled 22 student who is not more than three (3) years of age or older than 23 the concurrently enrolled student and who is employed or 24

volunteering, in any capacity, for the institution of higher
 education.

3	C. Rape is an act of sexual intercourse accomplished with a
4	male or female who is the spouse of the perpetrator if force or
5	violence is used or threatened, accompanied by apparent power of
6	execution to the victim or to another person.
7	SECTION 2. This act shall become effective November 1, 2023.
