8 Bud Martin Memorial Bridge - Private Robert "Bob"  
9 Clark Memorial Bridge - Donald J. Trump Highway -  
funding of signage - markers - codification -  
noncodification - effective date ]

12 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

13 SECTION 1. NEW LAW A new section of law to be codified  
14 in the Oklahoma Statutes as Section 1698.308 of Title 69, unless  
15 there is created a duplication in numbering, reads as follows:

16 The section of U.S. Highway 64 beginning at the western  
17 municipal limits of the town of Buffalo in Harper County, extending  
18 to N1860 Road, shall be designated as the "William Charles 'Charley'  
19 Coen Memorial Highway". The Department of Transportation shall  
20 cause suitable permanent markers bearing that name to be placed on  
21 the highway.

22 SECTION 2. NEW LAW A new section of law to be codified  
23 in the Oklahoma Statutes as Section 1698.309 of Title 69, unless  
24 there is created a duplication in numbering, reads as follows:

1       The bridge over Turkey Creek in Woodward County approximately  
2 two (2) miles east of the Ellis and Woodward County border on  
3 Highway 15 shall be designated as the "Bud Martin Memorial Bridge".  
4 The Department of Transportation shall cause suitable permanent  
5 markers bearing that name to be placed on the bridge.

6       SECTION 3.       NEW LAW       A new section of law to be codified  
7 in the Oklahoma Statutes as Section 1698.310 of Title 69, unless  
8 there is created a duplication in numbering, reads as follows:

9       The bridge over the Cimarron River on Highway 15 approximately  
10 thirteen (13) miles north of Boise City shall be designated as the  
11 "Private Robert 'Bob' Clark Memorial Bridge". The Department of  
12 Transportation shall cause suitable permanent markers bearing that  
13 name to be placed on the bridge.

14       SECTION 4.       NEW LAW       A new section of law to be codified  
15 in the Oklahoma Statutes as Section 1698.311 of Title 69, unless  
16 there is created a duplication in numbering, reads as follows:

17       Notwithstanding any other provision of law, the section of State  
18 Highway 287 beginning at the municipal limits of Boise City and  
19 extending southeast to the Oklahoma-Texas border in Cimarron County  
20 shall be designated as the "President Donald J. Trump Highway". The  
21 Department of Transportation shall cause suitable permanent markers  
22 bearing that name to be placed on the highway.

23       SECTION 5.       NEW LAW       A new section of law not to be  
24 codified in the Oklahoma Statutes reads as follows:

1       The cost associated with signage related to Section 4 of this  
2 act shall be paid by the Senate and House of Representatives authors  
3 and coauthors of this act.

4       SECTION 6. This act shall become effective November 1, 2021.
