1 O.S.L. 2019 (69 O.S. Supp. 2020, Section 1698.296),
2 which relates to the Councilwoman Avalon Reese
3 Memorial Highway; modifying name of certain memorial
4 highway; providing for codification; providing for
5 noncodification; and providing an effective date.

6 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

7 SECTION 1. NEW LAW A new section of law to be codified
8 in the Oklahoma Statutes as Section 1698.308 of Title 69, unless
9 there is created a duplication in numbering, reads as follows:

10 The section of U.S. Highway 64 beginning at the western
11 municipal limits of the town of Buffalo in Harper County extending
12 to N1860 Road shall be designated as the "William Charles "Charley"
13 Coen Memorial Highway". The Department of Transportation shall
14 cause suitable permanent markers bearing that name to be placed on
15 the highway.

16 SECTION 2. NEW LAW A new section of law to be codified
17 in the Oklahoma Statutes as Section 1698.309 of Title 69, unless
18 there is created a duplication in numbering, reads as follows:

19 The bridge over Turkey Creek in Woodward County approximately
20 two (2) miles east of the Ellis and Woodward County border on
21 Highway 15 shall be designated as the "Bud Martin Memorial Bridge".
22 The Department of Transportation shall cause suitable permanent
23 markers bearing that name to be placed on the bridge.
24

1 SECTION 3. NEW LAW A new section of law to be codified
2 in the Oklahoma Statutes as Section 1698.310 of Title 69, unless
3 there is created a duplication in numbering, reads as follows:

4 The bridge over the Cimarron River on Highway 15 approximately
5 thirteen (13) miles north of Boise City shall be designated as the
6 "Private Robert "Bob" Clark Memorial Bridge". The Department of
7 Transportation shall cause suitable permanent markers bearing that
8 name to be placed on the bridge.

9 SECTION 4. NEW LAW A new section of law to be codified
10 in the Oklahoma Statutes as Section 1698.311 of Title 69, unless
11 there is created a duplication in numbering, reads as follows:

12 Notwithstanding any other provision of law, the section of State
13 Highway 287 beginning at the municipal limits of Boise City
14 extending southeast to the Oklahoma-Texas border in Cimarron County
15 shall be designated as the "President Donald J. Trump Highway". The
16 Department of Transportation shall cause suitable permanent markers
17 bearing that name to be placed on the highway.

18 SECTION 5. NEW LAW A new section of law not to be
19 codified in the Oklahoma Statutes reads as follows:

20 The cost associated with signage related to Section 4 of this
21 act shall be paid by the Senate and House of Representatives authors
22 and coauthors of this act.

1 SECTION 6. NEW LAW A new section of law to be codified
2 in the Oklahoma Statutes as Section 1698.312 of Title 69, unless
3 there is created a duplication in numbering, reads as follows:

4 The section of State Highway 17 beginning at the east municipal
5 limits of Elgin extending to the intersection with NE Miller Street
6 in Comanche County shall be designated as the "Speaker Pro Tempore
7 Jim R. Glover Memorial Highway". The Department of Transportation
8 shall cause suitable permanent markers bearing that name to be
9 placed on the highway.

10 SECTION 7. NEW LAW A new section of law to be codified
11 in the Oklahoma Statutes as Section 1698.313 of Title 69, unless
12 there is created a duplication in numbering, reads as follows:

13 The bridge over Western Avenue on Interstate 240 within the
14 municipal limits of Oklahoma City shall be designated as the "Medal
15 of Honor Recipient Sergeant John R. Crews Memorial Bridge". The
16 Department of Transportation shall cause suitable permanent markers
17 bearing that name to be placed on the bridge.

18 SECTION 8. NEW LAW A new section of law to be codified
19 in the Oklahoma Statutes as Section 1698.314 of Title 69, unless
20 there is created a duplication in numbering, reads as follows:

21 The portion of State Highway 271 beginning south of the
22 municipal limits of Hugo and ending north of the municipal limits of
23 Grant shall be designated as the "Trooper J.C. Magar Memorial
24

1 Highway". The Department of Transportation shall cause suitable
2 permanent markers bearing that name to be placed on the highway.

3 SECTION 9. NEW LAW A new section of law to be codified
4 in the Oklahoma Statutes as Section 1698.315 of Title 69, unless
5 there is created a duplication in numbering, reads as follows:

6 The bridge over Coal Creek located on U.S. Route 75 Business
7 within the municipal limits of Henryetta shall be designated as the
8 "Congressional Medal of Honor Recipient Edward A. DeVore, Jr.
9 Memorial Bridge". The Department of Transportation shall cause
10 suitable permanent markers bearing that name to be placed on the
11 bridge.

12 SECTION 10. NEW LAW A new section of law to be codified
13 in the Oklahoma Statutes as Section 1698.316 of Title 69, unless
14 there is created a duplication in numbering, reads as follows:

15 The portion of State Highway 56 beginning just west of North
16 Wood Drive extending approximately one (1) mile west through the
17 municipal limits of Okmulgee shall be designated as the "Navy Cross
18 Recipient CPL Russell Keck Memorial Highway". The Department of
19 Transportation shall cause suitable permanent markers bearing that
20 name to be placed on the highway.

21 SECTION 11. NEW LAW A new section of law to be codified
22 in the Oklahoma Statutes as Section 1698.317 of Title 69, unless
23 there is created a duplication in numbering, reads as follows:

24

1 The section of State Highway 20 beginning at the junction of
2 State Highway 20 and N 145th E Avenue in Owasso extending east to
3 the junction of State Highway 20 and S 4080 Road in Rogers County
4 shall be designated as the "TSgt Marshal D. Roberts Memorial
5 Highway". The Department of Transportation shall cause suitable
6 permanent markers bearing that name to be placed on the highway.

7 SECTION 12. NEW LAW A new section of law to be codified
8 in the Oklahoma Statutes as Section 1698.318 of Title 69, unless
9 there is created a duplication in numbering, reads as follows:

10 The section of State Highway 30 beginning at the southern
11 municipal limits of the town of Sweetwater in Beckham County
12 extending south to the intersection of State Highway 30 and County
13 Road 1140 in Beckham County shall be designated as the "Sweetwater
14 Veterans Memorial Highway". The Department of Transportation shall
15 cause suitable permanent markers bearing that name to be placed on
16 the highway.

17 SECTION 13. NEW LAW A new section of law to be codified
18 in the Oklahoma Statutes as Section 1698.319 of Title 69, unless
19 there is created a duplication in numbering, reads as follows:

20 The bridge over Interstate 35 on State Highway 74 within the
21 municipal limits of Purcell in McClain County shall be designated as
22 the "SSGT Cecil Wellman Memorial Bridge". The Department of
23 Transportation shall cause suitable permanent markers bearing that
24 name to be placed on the bridge.

1 SECTION 14. NEW LAW A new section of law to be codified
2 in the Oklahoma Statutes as Section 1698.320 of Title 69, unless
3 there is created a duplication in numbering, reads as follows:

4 The bridge over Little Skin Bayou on U.S. Highway 64 in Sequoyah
5 County shall be designated as the "Officer Michael Bruce Keen
6 Memorial Bridge". The Department of Transportation shall cause
7 suitable permanent markers bearing that name to be placed on the
8 bridge.

9 SECTION 15. NEW LAW A new section of law to be codified
10 in the Oklahoma Statutes as Section 1698.321 of Title 69, unless
11 there is created a duplication in numbering, reads as follows:

12 The bridge over Chouteau Creek on U.S. Highway 77 in Cleveland
13 County shall be designated as the "Tommy Wayne Haley Memorial
14 Bridge". The Department of Transportation shall cause suitable
15 permanent markers bearing that name to be placed on the bridge.

16 SECTION 16. NEW LAW A new section of law to be codified
17 in the Oklahoma Statutes as Section 1698.322 of Title 69, unless
18 there is created a duplication in numbering, reads as follows:

19 The bridge located on Interstate 44 over State Highway 49 within
20 Comanche County shall be designated as the "MSGT Michael Werdehoff
21 Vietnam MIA Memorial Bridge". The Department of Transportation
22 shall cause suitable permanent markers bearing that name to be
23 placed on the bridge.

24

1 SECTION 17. NEW LAW A new section of law to be codified
2 in the Oklahoma Statutes as Section 1698.323 of Title 69, unless
3 there is created a duplication in numbering, reads as follows:

4 The portion of State Highway 30 beginning at the northern
5 municipal limits of the town of Sweetwater extending north to the
6 intersection of State Highway 30 and E 1060 Road in Roger Mills
7 County shall be designated as the "SP4 Alfred Dean Hildebrand
8 Memorial Highway". The Department of Transportation shall cause
9 suitable permanent markers bearing that name to be placed on the
10 highway.

11 SECTION 18. NEW LAW A new section of law to be codified
12 in the Oklahoma Statutes as Section 1698.324 of Title 69, unless
13 there is created a duplication in numbering, reads as follows:

14 The bridge located on State Highway 34 over the Salt Fork of the
15 Red River, south of Mangum, in Greer County shall be designated as
16 the "James Amos Callins Memorial Bridge". The Department of
17 Transportation shall cause suitable permanent markers bearing that
18 name to be placed on the bridge.

19 SECTION 19. NEW LAW A new section of law to be codified
20 in the Oklahoma Statutes as Section 1698.325 of Title 69, unless
21 there is created a duplication in numbering, reads as follows:

22 The portion of State Highway 51B beginning one-half (0.5) mile
23 west of the western municipal limits of Porter and ending one-half
24 (0.5) //mile east of the eastern municipal limits of Porter shall be

1 designated as the "Lieutenant Eugene Smith Memorial Highway". The
2 Department of Transportation shall cause suitable permanent markers
3 bearing that name to be placed on the highway.

4 SECTION 20. NEW LAW A new section of law to be codified
5 in the Oklahoma Statutes as Section 1698.326 of Title 69, unless
6 there is created a duplication in numbering, reads as follows:

7 The bridge over Elk Creek on State Highway 9 located
8 approximately one (1) mile west of Hobart in Kiowa County shall be
9 designated as the "WWII Doolittle Raider - Bombardier Sgt. Robert
10 James "R.J." Stephens Memorial Bridge". The Department of
11 Transportation shall cause suitable permanent markers bearing that
12 name to be placed on the bridge.

13 SECTION 21. NEW LAW A new section of law to be codified
14 in the Oklahoma Statutes as Section 1698.327 of Title 69, unless
15 there is created a duplication in numbering, reads as follows:

16 The bridge over Flat Creek on State Highway 34 located
17 approximately one-half (0.5) mile north of West Madison Avenue near
18 the town of Carter in Beckham County shall be designated as the
19 "U.S. Army PFC Keith N. Cantrell Memorial Bridge". The Department
20 of Transportation shall cause suitable permanent markers bearing
21 that name to be placed on the bridge.

22 SECTION 22. NEW LAW A new section of law to be codified
23 in the Oklahoma Statutes as Section 1698.328 of Title 69, unless
24 there is created a duplication in numbering, reads as follows:

1 The section of State Highway 82 beginning at the intersection of
2 U.S. Highway 62 and extending southeasterly to the intersection of
3 East Flournory Road south of Tahlequah in Cherokee County shall be
4 designated as the "Paul Blevins, Jr., and Michael Rogers Memorial
5 Highway". The Department of Transportation shall cause suitable
6 permanent markers bearing that name to be placed on the highway.

7 SECTION 23. NEW LAW A new section of law to be codified
8 in the Oklahoma Statutes as Section 1698.329 of Title 69, unless
9 there is created a duplication in numbering, reads as follows:

10 The bridge over Muddy Boggy Creek on State Highway 43 located
11 approximately one (1) mile east of the town of Coalgate in Coal
12 County shall be designated as the "Stiles Brothers Vietnam Veteran
13 Memorial Bridge". The Department of Transportation shall cause
14 suitable permanent markers bearing that name to be placed on the
15 bridge.

16 SECTION 24. NEW LAW A new section of law to be codified
17 in the Oklahoma Statutes as Section 1698.330 of Title 69, unless
18 there is created a duplication in numbering, reads as follows:

19 The section of U.S. Highway 69 in Ottawa County beginning at the
20 intersection of Newman Road then extending north to the intersection
21 of Commerce Street in the City of Commerce shall be designated as
22 "South Mickey Mantle Boulevard". The Department of Transportation
23 shall cause suitable permanent markers bearing that name to be
24 placed on the highway.

1 SECTION 25. NEW LAW A new section of law to be codified
2 in the Oklahoma Statutes as Section 1698.331 of Title 69, unless
3 there is created a duplication in numbering, reads as follows:

4 The section of State Highway 18 beginning at Deep Rock Road and
5 extending north three (3) miles in Payne County shall be designated
6 as the "Terry L. Hoggatt Memorial Highway". The Department of
7 Transportation shall cause suitable permanent markers bearing that
8 name to be placed on the highway.

9 SECTION 26. NEW LAW A new section of law to be codified
10 in the Oklahoma Statutes as Section 1698.332 of Title 69, unless
11 there is created a duplication in numbering, reads as follows:

12 Notwithstanding any other provision of law, the bridge over
13 South 129th Avenue on State Highway 51, also known as the Broken
14 Arrow Expressway, in Broken Arrow, Tulsa County, shall be designated
15 as the "Jennifer McClendon Memorial Bridge". The Department of
16 Transportation shall cause suitable permanent markers bearing that
17 name to be placed on the bridge.

18 SECTION 27. NEW LAW A new section of law to be codified
19 in the Oklahoma Statutes as Section 1698.333 of Title 69, unless
20 there is created a duplication in numbering, reads as follows:

21 Notwithstanding any other provision of law, the bridge over Lee
22 Boulevard on Interstate 44 in the City of Lawton in Comanche County
23 shall be designated as the "Maj. Charles E. Stiles Memorial Bridge".
24

1 The Department of Transportation shall cause suitable permanent
2 markers bearing that name to be placed on the bridge.

3 SECTION 28. NEW LAW A new section of law to be codified
4 in the Oklahoma Statutes as Section 1698.334 of Title 69, unless
5 there is created a duplication in numbering, reads as follows:

6 Notwithstanding any other provision of law, the section of State
7 Highway 28A beginning at the intersection of State Highway 66 near
8 the Town of Foyil extending east to the intersection of Interstate
9 44 in Rogers County shall be designated as the "CSM Junior H.
10 Honeycutt Memorial Highway". The Department of Transportation shall
11 cause suitable permanent markers bearing that name to be placed on
12 the highway.

13 SECTION 29. NEW LAW A new section of law to be codified
14 in the Oklahoma Statutes as Section 1698.335 of Title 69, unless
15 there is created a duplication in numbering, reads as follows:

16 The bridge crossing over the Washita River on U.S. Highway 62
17 located three-tenths (0.3) of a mile east of the H.E. Bailey
18 Turnpike near Chickasha in Grady County shall be designated as the
19 "Ada Lois Sipuel Fisher Memorial Bridge". The Department of
20 Transportation shall cause suitable permanent markers bearing that
21 name to be placed on the bridge.

22 SECTION 30. NEW LAW A new section of law to be codified
23 in the Oklahoma Statutes as Section 1698.336 of Title 69, unless
24 there is created a duplication in numbering, reads as follows:

1 Notwithstanding any other provision of law, the bridge crossing
2 over the Washita River on State Highway 8 north of the city of
3 Anadarko in Caddo County shall be designated as the "Joe W. McBride
4 Memorial Bridge". The Department of Transportation shall cause
5 suitable permanent markers bearing that name to be placed on the
6 bridge.

7 SECTION 31. NEW LAW A new section of law to be codified
8 in the Oklahoma Statutes as Section 1698.337 of Title 69, unless
9 there is created a duplication in numbering, reads as follows:

10 The section of the U.S. Highway 70 Bypass beginning just south
11 of U.S. 70 and extending south and west to the intersection of
12 McLean Drive on the west side of the city of Durant in Bryan County
13 shall be designated as the "Deputy Jarid Taylor Memorial Highway".
14 The Department of Transportation shall cause suitable permanent
15 markers bearing that name to be placed on the highway.

16 SECTION 32. NEW LAW A new section of law to be codified
17 in the Oklahoma Statutes as Section 1698.338 of Title 69, unless
18 there is created a duplication in numbering, reads as follows:

19 The section of State Highway 78 beginning just north of the
20 intersection of State Highway 22 extending northwesterly to the
21 eastern municipal limits of Milburn in Johnston County shall be
22 designated as the "USAF Capt. Nick Karpis Vietnam Veteran Memorial
23 Highway". The Department of Transportation shall cause suitable
24 permanent markers bearing that name to be placed on the highway.

1 SECTION 33. NEW LAW A new section of law to be codified
2 in the Oklahoma Statutes as Section 1698.339 of Title 69, unless
3 there is created a duplication in numbering, reads as follows:

4 The section of State Highway 7 beginning at the north municipal
5 limits of Mill Creek in Johnston County then extending northerly to
6 the Murray County line shall be designated as the "Sgt. Clyde Runyan
7 Memorial Highway". The Department of Transportation shall cause
8 suitable permanent markers bearing that name to be placed on the
9 highway.

10 SECTION 34. NEW LAW A new section of law to be codified
11 in the Oklahoma Statutes as Section 1698.340 of Title 69, unless
12 there is created a duplication in numbering, reads as follows:

13 The causeway over Old Spiro Lake on State Highway 9 in LeFlore
14 County shall be designated as the "Sgt. Maj. Marvail Lewis Memorial
15 Causeway". The Department of Transportation shall cause suitable
16 permanent markers bearing that name to be placed on the causeway.

17 SECTION 35. NEW LAW A new section of law to be codified
18 in the Oklahoma Statutes as Section 1698.341 of Title 69, unless
19 there is created a duplication in numbering, reads as follows:

20 The section of U.S. Highway 64 beginning at the intersection of
21 E1040 Road extending northerly to the intersection of E. 128th
22 Street in Muskogee County shall be designated as the "County
23 Commissioner Roy Rains Memorial Highway". The Department of
24

1 Transportation shall cause suitable permanent markers bearing that
2 name to be placed on the highway.

3 SECTION 36. NEW LAW A new section of law to be codified
4 in the Oklahoma Statutes as Section 1698.342 of Title 69, unless
5 there is created a duplication in numbering, reads as follows:

6 The section of State Highway 20 beginning at the intersection of
7 U.S. Highway 75 extending east two (2) miles to the intersection of
8 N. Memorial Road in Tulsa County shall be designated as the "PFC
9 Richard Tafoya Gurule Memorial Highway". The Department of
10 Transportation shall cause suitable permanent markers bearing that
11 name to be placed on the highway.

12 SECTION 37. NEW LAW A new section of law to be codified
13 in the Oklahoma Statutes as Section 1698.343 of Title 69, unless
14 there is created a duplication in numbering, reads as follows:

15 The section of State Highway 9 beginning at the intersection of
16 Interstate 35 extending west to the intersection of U.S. Highway 62
17 in McClain County shall be designated as the "Capt. David Arthur
18 Peters Memorial Highway". The Department of Transportation shall
19 cause suitable permanent markers bearing that name to be placed on
20 the highway.

21 SECTION 38. NEW LAW A new section of law to be codified
22 in the Oklahoma Statutes as Section 1698.344 of Title 69, unless
23 there is created a duplication in numbering, reads as follows:

24

1 The intersection of State Highway 66 and Banner Road in Canadian
2 County shall be designated as the "Ray Davis Memorial Intersection".
3 The Department of Transportation shall cause suitable permanent
4 markers bearing that name to be placed at the intersection.

5 SECTION 39. NEW LAW A new section of law to be codified
6 in the Oklahoma Statutes as Section 1698.345 of Title 69, unless
7 there is created a duplication in numbering, reads as follows:

8 The section of State Highway 25 beginning at the intersection of
9 State Highway 2 extending east to the western municipal limits of
10 Bluejacket in Craig County shall be designated as the "Robert L.
11 Horton Memorial Highway". The Department of Transportation shall
12 cause suitable permanent markers bearing that name to be placed on
13 the highway.

14 SECTION 40. NEW LAW A new section of law to be codified
15 in the Oklahoma Statutes as Section 1698.346 of Title 69, unless
16 there is created a duplication in numbering, reads as follows:

17 The section of State Highway 3 West beginning at the west side
18 of the State Highway 19 interchange extending west to the
19 intersection of County Road 1510 in Pontotoc County shall be
20 designated as the "John L. Hayden Memorial Highway". The Department
21 of Transportation shall cause suitable permanent markers bearing
22 that name to be placed on the highway.
