16	BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:
17	SECTION 1. NEW LAW A new section of law to be codified
18	in the Oklahoma Statutes as Section 3120 of Title 74, unless there
19	is created a duplication in numbering, reads as follows:
20	This act shall be known and may be cited as the "Governor's
21	Transparency Act of 2017".
22	SECTION 2. NEW LAW A new section of law to be codified
23	in the Oklahoma Statutes as Section 3121 of Title 74, unless there
24	is created a duplication in numbering, reads as follows:

A. For purposes of the Governor's Transparency Act of 2017,
"state agency" shall have the same meaning pursuant to Section 3301
of Title 74 of the Oklahoma Statutes.

Upon the effective date of this act, an appropriated state 4 Β. 5 agency entering into a Memorandum of Understanding or Memorandum of Agreement with any agency, department or any organization receiving 6 7 appropriated money, grants, contracts from the State of Oklahoma or any other state or funds from the government of the United States 8 9 shall publish a report on its website and the documents.ok.gov 10 website of all Memorandums of Understanding or Memorandums of 11 Agreement within fifteen (15) business days of the Memorandum's 12 effective date. The report shall contain a detailed accounting of 13 each Memorandum of Understanding or Memorandum of Agreement which shall include: 14

The effective date of the Memorandum of Understanding or

The entities subject to the Memorandum of Understanding or

5. The constitutional or statutory provisions allowing for the

When any state agency enters into a Memorandum of 4 С. 5 Understanding or Memorandum of Agreement, and when the state Legislature is in session, the state agency shall provide the chair 6 7 and committee members of the appropriate legislative committee, based on the subject matter or agency executing the document, with a 8 9 copy of the Memorandum of Understanding or Memorandum of Agreement. 10 D. Provided, the state agency may not publish any such report 11 on a Memorandum of Understanding or Memorandum of Agreement that is 12 privileged under law pursuant to the Oklahoma Open Records Act. However, a report shall still be published to indicate what entities 13 are subject to the privileged Memorandum of Understanding or 14 Memorandum of Agreement and its duration. 15

Memorandums of Understanding or Memorandums of Agreement 16 Е. solely between departments or agencies of this state shall cite the 17 state constitutional or statutory authority granted for the subject 18 addressed in the Memorandum of Understanding or Memorandum of 19 Agreement. Memorandums of Understanding or Memorandums of Agreement 20 between any agencies, departments and any organizations receiving 21 appropriated money, grants, contracts from the State of Oklahoma, or 22 any other state or funds from the government of the United States 23 shall cite the authority granted by federal or state statute and/or 24
