1 "SECTION 1. NEW LAW A new section of law to be codified
2 in the Oklahoma Statutes as Section 1698.251 of Title 69, unless
3 there is created a duplication in numbering, reads as follows:

4 Notwithstanding any other section of statute and due to the
5 untimely and sudden passing of State Representative David Brumbaugh,
6 a proud and dedicated leader for House District 76 and a
7 distinguished and decorated veteran of the United States Army who is
8 worthy of such recognition, the bridge over North Aspen Avenue on
9 the Broken Arrow Expressway shall be designated as the
10 "Representative David Brumbaugh Memorial Bridge" as soon as
11 practical after the effective date of this legislation. The
12 Department of Transportation is hereby directed to cause suitable
13 permanent markers bearing that name to be placed on the bridge."

11 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

12 SECTION 2. NEW LAW A new section of law to be codified
13 in the Oklahoma Statutes as Section 1698.250 of Title 69, unless
14 there is created a duplication in numbering, reads as follows:

15 The section of Interstate 44 from Southwest 119th Street
16 extending south to Southwest 149th Street within the municipal
17 limits of Oklahoma City shall be designated as the "LCPL Trevor A.
18 Roberts Memorial Highway". The Department of Transportation shall
19 cause suitable permanent markers bearing that name to be placed on
20 the highway.

21 SECTION 3. This act shall become effective November 1, 2017.
