8 privilege - reinstatement fees - Impaired Driver  
9 Accountability Program (IDAP) - administration of  
10 tests - noncodification - repealer - effective date ]

11 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

12 SECTION 1. NEW LAW A new section of law not to be  
13 codified in the Oklahoma Statutes reads as follows:

14 This act shall be known and may be cited as the "Impaired  
15 Driving Elimination Act 2" (IDEA2).

16 SECTION 2. NEW LAW A new section of law not to be  
17 codified in the Oklahoma Statutes reads as follows:

18 The purpose of the Impaired Driving Elimination Act and its  
19 amendments is to recognize that it is in the best interests of the  
20 citizens of the State of Oklahoma to have effective and meaningful  
21 administrative monitoring by the Department of Public Safety of  
22 impaired driving offenders. An accelerated process to hold these  
23 offenders immediately accountable through the restriction of their  
24 driving privileges, and the restoration of those driving privileges

1 through compliance criteria developed by the Department of Public  
2 Safety, will help ensure the safety of all citizens who utilize the  
3 roads, streets and highways of the State of Oklahoma.

4 SECTION 3. AMENDATORY 47 O.S. 2011, Section 2-116, is  
5 amended to read as follows:

6 Section 2-116. Whenever the Department of Public Safety is  
7 authorized or required to give any notice ~~under this act or other~~  
8 ~~law regulating the operation of vehicles~~, unless a different method  
9 of giving such notice is otherwise expressly prescribed, or agreed  
10 upon in writing by the Department and the person receiving notice,  
11 such notice shall be given either by personal delivery thereof to  
12 the person to be so notified or by deposit in the United States mail  
13 of such notice in an envelope with first class postage prepaid,  
14 addressed to such person at the mailing address as shown by the  
15 records of the Department. The giving of notice by mail is complete  
16 upon the expiration of ten (10) days after ~~such~~ deposit of ~~said~~ the  
17 notice in the United States mail. Proof of the giving of notice in  
18 either such manner may be made by the certificate of any officer or  
19 employee of the Department or affidavit of any person over eighteen  
20 (18) years of age, naming the person to whom such notice was given  
21 and specifying the ~~time~~ date, place and manner of the giving ~~thereof~~  
22 of notice. Failure of the person to receive notice because of  
23 failure to notify the Department of a change in his or her current  
24 mailing address, as required by Section 6-116 of this title, or as

1 required by the rules of the Department, shall not be sufficient  
2 grounds ~~for the person to protest the~~ to invalidate the giving of  
3 notice.

4 SECTION 4. AMENDATORY 47 O.S. 2011, Section 6-204, is  
5 amended to read as follows:

6 Section 6-204. A. Whenever any person is convicted of, or  
7 receives a deferred sentence for any offense for which this title  
8 makes mandatory the revocation of the driving privilege of such  
9 person by the Department as provided in Section 6-205 of this title,  
10 the court in which ~~such~~ the conviction or deferred sentence occurred  
11 may require the surrender to it of all ~~driver licenses~~ proof of  
12 driving privileges then held by the person so convicted or sentenced  
13 and the court shall thereupon forward the same together with a  
14 record of such conviction or deferred sentence to the Department  
15 within five (5) days after the conviction or deferred sentence  
16 occurred.

17 B. Every court, including courts not of record, having  
18 jurisdiction over offenses committed under this act, or any other  
19 law of this state or municipal ordinance regulating the operation of  
20 motor vehicles on highways, shall forward to the Department a record  
21 of the conviction of any person in such court for a violation of any  
22 such laws other than regulations governing standing or parking, and  
23 may recommend the suspension of the driving privileges of the person  
24 so convicted.

1 C. Whenever a person arrested for any offense for which this  
2 title makes mandatory the revocation of the driving privilege of  
3 such person by the Department of Public Safety as provided in  
4 Section 6-205 of this title, and enters into a deferred prosecution  
5 agreement related to such offense, the prosecutor shall forward to  
6 the Department of Public Safety notice of the deferred prosecution  
7 agreement. The notice of a deferred prosecution agreement provided  
8 to the Department of Public Safety shall not be a violation of  
9 Section 305.5 of Title 22 of the Oklahoma Statutes.

10 D. For the purposes of Section 6-101 et seq. of this title, the  
11 term "conviction" shall mean a final conviction or shall mean a  
12 forfeiture of bail or collateral deposited to secure a defendant's  
13 appearance in court, which forfeiture has not been vacated.

14 SECTION 5. AMENDATORY 47 O.S. 2011, Section 6-205, as  
15 amended by Section 1, Chapter 279, O.S.L. 2013 (47 O.S. Supp. 2016,  
16 Section 6-205), is amended to read as follows:

17 Section 6-205. A. The Department of Public Safety shall  
18 ~~immediately~~ revoke the driving privilege of any person, whether  
19 adult or juvenile, ~~upon receiving a record of conviction who,~~ in any  
20 municipal, state or federal court within the United States, receives  
21 a deferred sentence, or a conviction, when such conviction has  
22 become final, or a deferred prosecution, for ~~of~~ any of the following  
23 offenses, ~~when such conviction has become final:~~

1           1. Manslaughter or negligent homicide resulting from the  
2 operation of a motor vehicle;

3           2. Driving, operating or being in actual physical control of a  
4 motor vehicle while under the influence of alcohol, any other  
5 intoxicating substance, or the combined influence of alcohol and any  
6 other intoxicating substance, ~~any violation of paragraph 1, 2, 3 or~~  
7 ~~4 of~~ or any offense in subsection A of Section 11-902 of this title  
8 ~~or any violation of~~ any offense in Section 11-906.4 of this title.  
9 ~~However, the Department shall not additionally revoke the driving~~  
10 ~~privileges of the person pursuant to this subsection if the driving~~  
11 ~~privilege of the person has been revoked because of a test result or~~  
12 ~~test refusal pursuant to Section 753 or 754 of this title arising~~  
13 ~~from the same circumstances which resulted in the conviction unless~~  
14 ~~the revocation because of a test result or test refusal is set~~  
15 ~~aside;~~

16           3. Any felony during the commission of which a motor vehicle is  
17 used;

18           4. Failure to stop and render aid as required under the laws of  
19 this state in the event of a motor vehicle accident resulting in the  
20 death or personal injury of another;

21           5. Perjury or the making of a false affidavit or statement  
22 under oath to the Department under the Uniform Vehicle Code or under  
23 any other law relating to the ownership or operation of motor  
24 vehicles;

1           6. A misdemeanor or felony conviction for unlawfully  
2 possessing, distributing, dispensing, manufacturing, trafficking,  
3 cultivating, selling, transferring, attempting or conspiring to  
4 possess, distribute, dispense, manufacture, traffic, sell, or  
5 transfer of a controlled dangerous substance as defined in the  
6 Uniform Controlled Dangerous Substances Act while using a motor  
7 vehicle;

8           7. Failure to pay for gasoline pumped into a vehicle pursuant  
9 to Section 1740 of Title 21 of the Oklahoma Statutes;

10          8. A misdemeanor conviction for a violation of Section 1465 of  
11 Title 21 of the Oklahoma Statutes;

12          9. A misdemeanor conviction for a violation of Section 609 of  
13 Title 37 of the Oklahoma Statutes;

14          10. Failure to obey a traffic control device as provided in  
15 Section 11-202 or 11-803 of this title ~~or a stop sign~~ when such  
16 failure results in great bodily injury to any other person; or

17          11. Failure to stop or to remain stopped for school bus loading  
18 or unloading of children pursuant to Section 11-705 or 11-705.1 of  
19 this title.

20          B. The first license revocation under any provision of this  
21 section, except for paragraph 2, 6, 7 or 11 of subsection A of this  
22 section, shall be for a period of one (1) year. Such period shall  
23 not be modified.

1 C. A license revocation under any provision of this section,  
2 except for paragraph 2, 6, or 7 of subsection A of this section,  
3 shall be for a period of three (3) years if a prior revocation under  
4 this section, except under paragraph 2 of subsection A of this  
5 section, commenced within the preceding five-year period as shown by  
6 the records of the Department. Such period shall not be modified.

7 D. The period of license revocation under paragraph 2 or 6 of  
8 subsection A of this section shall be governed by the provisions of  
9 Section 6-205.1 of this title.

10 E. The first license revocation under paragraph 7 of subsection  
11 A of this section shall be for a period of six (6) months. A second  
12 or subsequent license revocation under paragraph 7 of subsection A  
13 of this section shall be for a period of one (1) year. Such periods  
14 shall not be modified.

15 F. The first license revocation under paragraph 11 of  
16 subsection A of this section shall be for a period of one (1) year.  
17 Such period may not be modified. Any appeal of the revocation of  
18 driving privilege under paragraph 11 of subsection A of this section  
19 shall be governed by Section 6-211 of this title, ~~provided any~~  
20 ~~modification under this subsection shall apply to Class D motor~~  
21 ~~vehicles only.~~

22 G. As used in this section, "great bodily injury" means bodily  
23 injury which creates a substantial risk of death or which causes  
24

1 serious, permanent disfigurement or protracted loss or impairment of  
2 the function of any bodily member or organ.

3 SECTION 6. AMENDATORY 47 O.S. 2011, Section 6-205.1, as  
4 amended by Section 1, Chapter 393, O.S.L. 2013 (47 O.S. Supp. 2016,  
5 Section 6-205.1), is amended to read as follows:

6 Section 6-205.1. A. The driving privilege of a person who is  
7 convicted of, or receives a deferred sentence, or deferred  
8 prosecution agreement for any offense as provided in paragraph 2 of  
9 subsection A of Section 6-205 of this title, ~~or a person who has~~  
10 ~~refused to submit to a test or tests as provided in Section 753 of~~  
11 ~~this title, or a person whose alcohol concentration is subject to~~  
12 ~~the provisions of Section 754 of this title, unless the person has~~  
13 successfully completed, or is currently participating in, the  
14 Impaired Driver Accountability Program (IDAP) in accordance with  
15 paragraph E of Section 6-212 of this title, shall be revoked or  
16 denied by the Department of Public Safety for the following period,  
17 as applicable:

18 1. The first license revocation pursuant to paragraph 2 of  
19 subsection A of Section 6-205 of this title ~~or to Section 753 or 754~~  
20 ~~of this title~~ shall be for ~~one hundred eighty (180) days~~ a minimum  
21 period of one (1) year, which ~~may~~ shall be modified; provided, any  
22 modification under this paragraph shall apply to Class D motor  
23 vehicles only. Modification requires the issuance of a modified  
24 driver license and the continuous installation of an ignition



1 interlock device or devices pursuant to Section 754.1 of this title  
2 for a period of not less than one (1) year immediately preceding  
3 reinstatement of the license. If the Department receives notice of  
4 any verified ignition interlock violations, as determined by the  
5 Board of Tests for Alcohol and Drug Influence, occurring within the  
6 last one hundred eighty (180) days of the revocation period, the  
7 revocation period shall be extended until such time the person  
8 completes a violation free one hundred eighty (180) day period;

9       2. A revocation pursuant to paragraph 2 of subsection A of  
10 Section 6-205 of this title, ~~or to Section 753 or 754 of this title~~  
11 shall be for a minimum period of ~~one (1) year or longer if driving~~  
12 ~~privileges are modified pursuant to the provisions of this paragraph~~  
13 twenty-four (24) months, if within ten (10) years preceding the date  
14 of arrest relating thereto, as shown by the records of the  
15 Department:

- 16           a. a prior revocation commenced pursuant to paragraph 2  
17           or 6 of subsection A of Section 6-205 of this title,  
18           ~~or to Section 753 or 754 of this title~~ a revocation  
19           because of a test result or test refusal, or previous  
20           enrollment and/or completion of the Impaired Driving  
21           Accountability Program pursuant to Section 6-212 of  
22           this title, or  
23           b. the record of the person reflects a prior conviction  
24           in another jurisdiction which did not result in a

1 revocation of Oklahoma driving privileges, for a  
2 violation substantially similar to paragraph 2 of  
3 subsection A of Section 6-205 of this title, and the  
4 person was not a resident or a licensee of Oklahoma at  
5 the time of the offense resulting in the conviction.

6 Such ~~one-year~~ twenty-four-month period of revocation ~~may~~ shall  
7 be modified; provided, any modification under this paragraph shall  
8 apply to Class D motor vehicles only. ~~For any modification, the~~  
9 ~~person shall be required to install~~ Modification shall require the  
10 issuance of a modified driver license and the installation of an  
11 ignition interlock device or devices, pursuant to Section 754.1 of  
12 this title. The period of revocation and the period of interlock  
13 installation shall run concurrently and each shall be for no less  
14 than one (1) year for a continuous period of not less than twenty-  
15 four (24) months immediately preceding reinstatement of the license.  
16 If the Department receives notice of any verified ignition interlock  
17 violations, as determined by the Board of Tests for Alcohol and Drug  
18 Influence, occurring within the last twelve (12) months of the  
19 revocation period, the revocation period shall be extended until  
20 such time the person completes a violation free twelve-month period;  
21 or

22 3. A revocation pursuant to paragraph 2 of subsection A of  
23 Section 6-205 of this title, or ~~to Section 753 or 754 of this title~~  
24 a revocation because of a test result or test refusal shall be for a

1 minimum period of ~~three (3) years or longer~~ forty-eight (48) months  
2 ~~if driving privileges are modified pursuant to the provisions of~~  
3 ~~this paragraph~~ if within ten (10) years preceding the date of arrest  
4 relating thereto, as shown by the records of the Department:

5 a. two or more prior revocations commenced pursuant to  
6 paragraph 2 or 6 of subsection A of Section 6-205 of  
7 this title, or revocations because of a test result or  
8 test refusal to Section 753 or 754 of this title, or  
9 previous completion(s) of the Impaired Driving  
10 Accountability Program pursuant to Section 6-212 of  
11 this title,

12 b. the record of the person reflects two or more prior  
13 convictions in another jurisdiction which did not  
14 result in a revocation of Oklahoma driving privileges,  
15 for a violation substantially similar to paragraph 2  
16 of subsection A of Section 6-205 of this title, and  
17 the person was not a resident or a licensee of  
18 Oklahoma at the time of the offense resulting in the  
19 conviction, or

20 c. any combination of two or more prior revocations, or  
21 previous completions of the Impaired Driving  
22 Accountability Program, or convictions as described in  
23 subparagraphs a and b of this paragraph.  
24

1       Such ~~three-year~~ forty-eight-month period of revocation ~~may~~ shall  
2 be modified; provided, any modification under this paragraph shall  
3 apply to Class D motor vehicles only. ~~For any modification, the~~  
4 ~~person shall be required to install~~ Modification requires the  
5 issuance of a modified driver license and the installation of an  
6 ignition interlock device or devices, pursuant to Section 754.1 of  
7 this title. The period of revocation and the period of interlock  
8 installation shall run concurrently and each shall be for no less  
9 than three (3) years for a continuous period of not less than forty-  
10 eight (48) months immediately preceding reinstatement of the  
11 license. If the Department receives notice of any verified ignition  
12 interlock violations, as determined by the Board of Tests for  
13 Alcohol and Drug Influence, occurring within the last twenty-four  
14 (24) months of the revocation period, the revocation period shall be  
15 extended until such time the person completes a violation free  
16 twenty-four-month period.

17       B. The driving privilege of a person who is convicted of any  
18 offense as provided in paragraph 6 of subsection A of Section 6-205  
19 of this title shall be revoked or denied by the Department of Public  
20 Safety for the following period, as applicable:

21       1. The first license revocation shall be for one hundred eighty  
22 (180) days, which may be modified; provided, for license revocations  
23 for a misdemeanor charge of possessing a controlled dangerous  
24 substance, the provisions of this paragraph shall apply to any such

1 revocations by the Department on or after January 1, 1993; provided  
2 further, any modification under this paragraph shall apply to Class  
3 D motor vehicles only;

4 2. A revocation shall be for a period of one (1) year if within  
5 ten (10) years preceding the date of arrest relating thereto, as  
6 shown by the records of the Department:

7 a. a prior revocation commenced pursuant to paragraph 2  
8 or 6 of subsection A of Section 6-205 of this title,  
9 or ~~under Section 753 or 754 of this title~~ a revocation  
10 because of a test result or test refusal, previous  
11 participation and/or completion of the Impaired  
12 Driving Accountability Program pursuant to Section 6-  
13 212 of this title, or

14 b. the record of the person reflects a prior conviction  
15 in another jurisdiction which did not result in a  
16 revocation of Oklahoma driving privileges, for a  
17 violation substantially similar to paragraph 2 or 6 of  
18 subsection A of Section 6-205 of this title, and the  
19 person was not a resident or a licensee of Oklahoma at  
20 the time of the offense resulting in the conviction.

21 Such period shall not be modified; or

22 3. A revocation shall be for a period of three (3) years if  
23 within ten (10) years preceding the date of arrest relating thereto,  
24 as shown by the records of the Department:

- 1 a. two or more prior revocations commenced pursuant to  
2 paragraph 2 or 6 of subsection A of Section 6-205 of  
3 this title, or ~~under Section 753 or 754 of this title~~  
4 a revocation because of a test result or test refusal,  
5 previous participation and/or completion of the  
6 Impaired Driving Accountability Program pursuant to  
7 Section 6-212 of this title,
- 8 b. the record of the person reflects two or more prior  
9 convictions in another jurisdiction which did not  
10 result in a revocation of Oklahoma driving privileges,  
11 for a violation substantially similar to paragraph 2  
12 or 6 of subsection A of Section 6-205 of this title,  
13 and the person was not a resident or licensee of  
14 Oklahoma at the time of the offense resulting in the  
15 conviction, or
- 16 c. any combination of two or more prior revocations as  
17 described in subparagraphs a and b or this paragraph.

18 Such period shall not be modified.

19 The revocation of the driving privilege of any person under this  
20 subsection shall not run concurrently with any other withdrawal of  
21 driving privilege resulting from a different incident and which  
22 requires the driving privilege to be withdrawn for a prescribed  
23 amount of time. A denial based on a conviction of any offense as  
24 provided in paragraph 6 of subsection A of Section 6-205 of this

1 title shall become effective on the first day the convicted person  
2 is otherwise eligible to apply for and be granted driving privilege  
3 if the person was not eligible to do so at the time of the  
4 conviction.

5 C. For the purposes of this subsection:

6 1. The term "conviction" includes a juvenile delinquency  
7 adjudication by a court or any notification from a court pursuant to  
8 Section 6-107.1 of this title; and

9 2. The term "revocation" includes a denial of driving  
10 privileges by the Department.

11 D. Each period of revocation not subject to modification shall  
12 be mandatory and neither the Department nor any court ~~shall~~ may  
13 grant driving privileges ~~based upon hardship or otherwise~~ for the  
14 duration of that period. Each period of revocation, subject to  
15 modification as provided for in this section, ~~may~~ shall be modified  
16 as provided for in Section 754.1 ~~or 755~~ of this title; provided, any  
17 modification under this paragraph shall apply to Class D motor  
18 vehicles only.

19 E. Any appeal of a revocation or denial of driving privileges  
20 shall be governed by Section 6-211 of this title.

21 SECTION 7. AMENDATORY 47 O.S. 2011, Section 6-212, as  
22 last amended by Section 3, Chapter 97, O.S.L. 2015 (47 O.S. Supp.  
23 2016, Section 6-212), is amended to read as follows:

24

1 Section 6-212. A. The Department of Public Safety shall not  
2 assess and collect multiple reinstatement fees when reinstating the  
3 driving privilege of any person having more than one suspension or  
4 revocation affecting the person's driving privilege at the time of  
5 reinstatement.

6 B. The Department shall:

7 1. Suspend or revoke a person's driving privilege ~~for each~~  
8 ~~basis~~ as delineated within the Oklahoma Statutes; and

9 2. Require any person having more than one suspension or  
10 revocation affecting the person's driving privilege to meet the  
11 statutory requirements for each action as a condition precedent to  
12 the reinstatement of any driving privilege. Provided, however,  
13 reinstatement fees shall not be cumulative, and a single  
14 reinstatement fee, as provided for in subsection C of this section,  
15 shall be paid for all suspensions or revocations as shown by the  
16 Department's records at the time of reinstatement.

17 C. Whenever a person's privilege to operate a motor vehicle is  
18 suspended or revoked pursuant to any provision as authorized by the  
19 Oklahoma Statutes, the license or privilege to operate a motor  
20 vehicle shall remain under suspension or revocation and shall not be  
21 reinstated until:

22 1. The expiration of each such revocation or suspension order  
23 and the satisfaction of all terms and conditions of the revocation;

24 2. The person has paid to the Department:



1 a. if such privilege is suspended or revoked pursuant to  
2 Section 1115.5 of Title 22 of the Oklahoma  
3 Statutes or pursuant to any provisions of this  
4 title, except as provided in subparagraph b of  
5 this paragraph, a processing fee of Twenty-five  
6 Dollars (\$25.00) for each such suspension or  
7 revocation as shown by the Department's records,  
8 or

9 b. (1) if such privilege is suspended or revoked because  
10 of a test result or test refusal, or pursuant to  
11 the provisions of Section 6-205, 6-205.1, 7-612,  
12 ~~753, 754~~ or 761 of this title or pursuant to  
13 subsection A of Section 7-605 of this title for a  
14 conviction for failure to maintain the mandatory  
15 motor vehicle insurance required by law or  
16 pursuant to subsection B of Section 6-206 of this  
17 title for a suspension other than for points  
18 accumulation, a processing fee of Seventy-five  
19 Dollars (\$75.00) for each such suspension or  
20 revocation as shown by the Department's records,  
21 and a special assessment trauma-care fee of Two  
22 Hundred Dollars (\$200.00) to be deposited into  
23 the Trauma Care Assistance Revolving Fund created  
24 in Section 1-2530.9 of Title 63 of the Oklahoma

1 Statutes, for each suspension or revocation as  
2 shown by the records of the Department, and  
3 (2) in addition to any other fees required by this  
4 section, if such privilege is suspended or  
5 revoked pursuant to an arrest on or after  
6 November 1, 2008, under the provisions of  
7 paragraph 2 or 6 of subsection A of Section 6-205  
8 of this title or of Section ~~753, 754, or~~ 761 of  
9 this title or because of a test result or test  
10 refusal, a fee of Fifteen Dollars (\$15.00), which  
11 shall be apportioned pursuant to the provisions  
12 of Section 3-460 of Title 43A of the Oklahoma  
13 Statutes; and

14 3. The person has paid to the Department a single reinstatement  
15 fee of:

16 a. beginning on August 26, 2011, through June 30, 2013,  
17 Fifty Dollars (\$50.00), of which Twenty-five Dollars  
18 (\$25.00) shall be deposited by the Commissioner to the  
19 credit of the Department of Public Safety Revolving  
20 Fund and, in addition to other purposes authorized by  
21 law, the expenditures from that fund of monies derived  
22 from the Twenty-five Dollars (\$25.00) pursuant to this  
23 subparagraph shall be used to fund any Oklahoma  
24 Highway Patrol Trooper Academy provided by the

1 Department. Any remaining funds shall be used for  
2 operational expenses of the Oklahoma Highway Patrol,  
3 and

4 b. beginning on July 1, 2013, and any year thereafter,  
5 Twenty-five Dollars (\$25.00).

6 D. The Department of Public Safety is hereby authorized to  
7 enter into agreements with persons whose license to operate a motor  
8 vehicle or commercial motor vehicle has been suspended or revoked,  
9 ~~except as to those suspensions, revocations, cancellations or~~  
10 ~~denials made pursuant to paragraph 1 or 2 of subsection A of Section~~  
11 ~~6-205 of this title or to Section 753 or 754 of this title, for~~  
12 issuance of a provisional licenses license that ~~would allow~~ allows  
13 such persons to drive:

14 1. Between their place of residence and their place of  
15 employment or potential employment;

16 2. During the scope and course of their employment;

17 3. Between their place of residence and a college, university  
18 or technology center;

19 4. Between their place of residence and their child's school or  
20 day care provider;

21 5. Between their place of residence and a place of worship; or

22 6. Between their place of residence and any court-ordered  
23 treatment program,  
24

1 with the condition that such persons pay a minimum of Twenty-  
2 five Dollars (\$25.00) per month toward the satisfaction of all  
3 outstanding driver license or commercial driver license  
4 reinstatement fees. The Department shall develop rules and  
5 procedures to establish such a provisional driver license program  
6 and such rules and procedures shall include, but not be limited to,  
7 eligibility criteria, proof of insurance, proof of enrollment or  
8 employment, and any provisional license fees. Any violation of law  
9 by the person holding the provisional license that would result in

11 2. A report, test result or other documentation indicating the  
12 test was performed after the installation of a dry gas cylinder by  
13 the Board of Tests for Alcohol and Drug Influence and before the  
14 expiration date of the cylinder;

15 3. A report, test result or other documentation reflecting the  
16 results of two breath samples within 0.03g/2101 of each other; or

17 4. A report, test result or other documentation reflecting a  
18 control test within 0.01g/2101 of the target value of the control.

19 E. Results of the test of a person's breath or blood, if  
20 admissible, shall be admitted without reference to measurement  
21 uncertainty.

22 F. Whatever the source, documents retained by the Board of  
23 Tests of Alcohol and Drug Influence to reflect maintenance on an  
24 instrument maintained by the Board for the measurement of alcohol



1 concentration in a person's breath shall be admissible in any  
2 proceeding.

3 SECTION 16. REPEALER 47 O.S. 2011, Section 755, is  
4 hereby repealed.
