15	BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:
16	SECTION 1. AMENDATORY 21 O.S. 2011, Section 51.1, is
17	amended to read as follows:
18	Section 51.1. A. Except as otherwise provided in the Elderly
19	and Incapacitated Victim's Protection Program and Section $\frac{3 \text{ of this}}{3 \text{ of this}}$
20	act 51.1a of this title, every person who, having been convicted of
21	any <del>offense punishable by imprisonment in the State Penitentiary</del>
22	felony, commits any crime after such conviction, within ten (10)
23	years of the date following the completion of the execution of the
24	sentence, and against whom the <del>District Attorney</del> <u>district attorney</u>

3 If the offense for which the person is subsequently 1. convicted is an offense enumerated in Section 571 of Title 57 of the 4 5 Oklahoma Statutes and the offense is punishable by imprisonment in the State Penitentiary custody of the Department of Corrections for 6 a term exceeding five (5) years, such person is punishable by 7 imprisonment in the State Penitentiary custody of the Department of 8 9 Corrections for a term in the range of ten (10) years to life 10 imprisonment.

11 2. If the offense of which such person is subsequently 12 convicted is such that upon a first conviction an offender would be punishable by imprisonment in the State Penitentiary custody of the 13 Department of Corrections for any term exceeding five (5) years, 14 15 such person is punishable by imprisonment in the State Penitentiary custody of the Department of Corrections for a term in the range of 16 twice the minimum term for a first time offender to life 17 imprisonment. If the subsequent felony offense does not carry a 18 minimum sentence as a first time offender, such person is punishable 19 by imprisonment in the State Penitentiary custody of the Department 20 of Corrections for a term in the range of two (2) years to life 21 imprisonment. 22

3. If such subsequent offense is such that upon a firstconviction the offender would be punishable by imprisonment in the

State Penitentiary <u>custody of the Department of Corrections</u> for five (5) years, or any less term, then the person convicted of such subsequent offense is punishable by imprisonment in the <del>State</del> <del>Penitentiary</del> <u>custody of the Department of Corrections</u> for a term not exceeding ten (10) years.

4. If such subsequent conviction is for petit larceny, as
<u>defined pursuant to Section 1704 of this title</u>, the person convicted
of such subsequent offense is punishable by imprisonment in the
<u>State Penitentiary custody of the Department of Corrections</u> for a
term not exceeding five (5) years.

11 B. Every person who, having been twice convicted of felony 12 offenses, commits a subsequent felony offense which is an offense enumerated in Section 571 of Title 57 of the Oklahoma Statutes, 13 within ten (10) years of the date following the completion of the 14 execution of the sentence, and against whom the District Attorney 15 16 district attorney seeks to enhance punishment pursuant to this section of law, is punishable by imprisonment in the State 17 Penitentiary custody of the Department of Corrections for a term in 18 the range of twenty (20) years to life imprisonment. Felony 19 offenses relied upon shall not have arisen out of the same 20 transaction or occurrence or series of events closely related in 21 time and location. Nothing in this section shall abrogate or affect 22 the punishment by death in all crimes now or hereafter made 23 punishable by death. 24

Every person who, having been twice convicted of felony 2 offenses, commits a subsequent felony offense within ten (10) years 3 of the date following the completion of the execution of the sentence, and against whom the District Attorney district attorney 4 5 seeks to enhance punishment pursuant to this section of law, is punishable by imprisonment in the State Penitentiary custody of the 6 7 Department of Corrections for a term in the range of three times the minimum term for a first time offender to life imprisonment. 8 If the 9 subsequent felony offense does not carry a minimum sentence as a 10 first time offender, the person is punishable by imprisonment in the 11 State Penitentiary custody of the Department of Corrections for a 12 term in the range of four (4) years to life imprisonment. Felony offenses relied upon shall not have arisen out of the same 13 transaction or occurrence or series of events closely related in 14 15 time and location. Nothing in this section shall abrogate or affect the punishment by death in all crimes now or hereafter made 16 punishable by death. 17

18D. A previous conviction for possession of a controlled19dangerous substance pursuant to Section 2-402 of Title 63 of the20Oklahoma Statutes, or the equivalent law for possession of a21controlled dangerous substance from any other jurisdiction, may not22be used to enhance punishment pursuant to this section of law.23E. Notwithstanding subsections A, B and C of this section,24every person who, having previously been convicted of a felony other

1 than a felony enumerated in Section 571 of Title 57 of the Oklahoma 2 Statutes, is convicted of a second or subsequent felony other than a 3 felony enumerated in Section 571 of Title 57 of the Oklahoma 4 Statutes, is punishable by imprisonment in the custody of the 5 Department of Corrections for a term of not more than the maximum sentence plus one-fourth (1/4) of the sentence that could have been 6 imposed for a first conviction of the current offense. 7 SECTION 2. AMENDATORY 21 O.S. 2011, Section 51.2, is 8 9 amended to read as follows: 10 Section 51.2. Except as provided in Section 3 of this act 51.1a 11 of this title, no person shall be sentenced as a second and 12 subsequent offender under Section 51.1 of this title, or any other section of the Oklahoma Statutes, when a period of ten (10) years 13 has elapsed since the completion of the sentence imposed on the 14 15 former conviction; provided, said the person has not, in the meantime, been convicted of a misdemeanor involving moral turpitude 16 or a felony. Nothing in this section shall prohibit the use of a 17 prior conviction for physical or sexually related child abuse as a 18 prior conviction for second and subsequent offender purposes if the 19 person is presently charged with a felony crime involving physical 20 or sexually related child abuse. 21
