| 17 | BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA: |
| 18 | SECTION 1. NEW LAW A new section of law to be codified |
| 19 | in the Oklahoma Statutes as Section 509.2b of Title 70, unless there |
| 20 | is created a duplication in numbering, reads as follows: |
| 21 | A. Beginning August 30, 2019, and each August 30 thereafter, an |
| 22 | employee organization established pursuant to the provisions of |
| 23 | Section 509.2 of Title 70 of the Oklahoma Statutes shall submit to a |
| 24 27 | school district board of education the percentage of employees, as |

B. 1. A school district board of education shall hold a secret
ballot election to determine whether the organization retains
support of a majority of all employees in the organization.

7 2. The school district board of education shall determine
8 whether elections shall be conducted in person, by mail, by
9 telephone, by Internet-based systems or by any other means
10 determined by the board of education to be fair, confidential and
11 reliable. The board of education shall allow employees to cast
12 ballots for a period of five (5) business days.

13 3. The school district board of education may establish a fee 14 schedule, consistent with the provisions of Section 509.2 of Title 15 70 of the Oklahoma Statutes, for employee organizations subject to 16 elections conducted pursuant to the provisions of this section for 17 the purpose of funding the election.

C. If a majority of all employees vote in favor of retaining the employee organization, the organization shall remain the representative of employees in the organization pursuant to the provisions of Section 509.2 of Title 70 of the Oklahoma Statutes. If a majority of all employees do not vote in favor of retaining the existing employee organization, the organization shall be considered decertified, the school district board of education shall no longer

¹ recognize the organization as the representative of employees in the ² unit and the employees shall be unrepresented.

D. When an existing employee organization is no longer recognized, the terms of any pre-existing contract between the employee organization and the employees represented by the organization shall continue and remain in effect for the remaining contract term.

E. A school district board of education may recognize a new employee organization in accordance with the provisions of Section 509.2 of Title 70 of the Oklahoma Statutes, but the new employee organization may not be substantially similar to or affiliated with an employee organization that has lost recognition pursuant to the provisions of subsection C of this section for twelve (12) months from the date of the loss of recognition.

15 F. A school district board of education subject to the 16 provisions of subsection B of this section shall hold an election to 17 certify majority support of an existing employee organization no 18 later than December 31, 2019, and every third year thereafter. 19 SECTION 2. This act shall become effective July 1, 2019. 20 SECTION 3. It being immediately necessary for the preservation 21 of the public peace, health or safety, an emergency is hereby 22 23 24 _ _
