12	BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:
13	SECTION 1. AMENDATORY 59 O.S. 2011, Section 567.3a, is
14	amended to read as follows:
15	Section 567.3a. As used in the Oklahoma Nursing Practice Act:
16	1. "Board" means the Oklahoma Board of Nursing;
17	2. "The practice of nursing" means the performance of services
18	provided for purposes of nursing diagnosis and treatment of human
19	responses to actual or potential health problems consistent with
20	educational preparation. Knowledge and skill are the basis for
21	assessment, analysis, planning, intervention, and evaluation used in
22	the promotion and maintenance of health and nursing management of
23	illness, injury, infirmity, restoration or optimal function, or
24	death with dignity. Practice is based on understanding the human

1 who has acquired advanced clinical knowledge and с. 2 skills in preparation for providing both direct and 3 indirect care to patients; however, the defining factor for all Advanced Practice Registered Nurses is 4 5 that a significant component of the education and practice focuses on direct care of individuals, 6 7 d. whose practice builds on the competencies of Registered Nurses by demonstrating a greater depth and 8 9 breadth of knowledge, a greater synthesis of data, and 10 increased complexity of skills and interventions, and 11 e. who has obtained a license as an Advanced Practice 12 Registered Nurse in one of the following roles: Certified Registered Nurse Anesthetist, Certified 13 Nurse-Midwife, Clinical Nurse Specialist, or Certified 14 15 Nurse Practitioner.


Only those persons who hold a license to practice advanced 16 practice registered nursing in this state shall have the right to 17 use the title "Advanced Practice Registered Nurse" and to use the 18 abbreviation "APRN". Only those persons who have obtained a license 19 in the following disciplines shall have the right to fulfill the 20 roles and use the applicable titles: Certified Registered Nurse 21 Anesthetist and the abbreviation "CRNA", Certified Nurse-Midwife and 22 the abbreviation "CNM", Clinical Nurse Specialist and the 23

1 abbreviation "CNS", and Certified Nurse Practitioner and the 2 abbreviation "CNP".

3 It shall be unlawful for any person to assume the role or use the title Advanced Practice Registered Nurse or use the abbreviation 4 5 "APRN" or use the respective specialty role titles and abbreviations or to use any other titles or abbreviations that would reasonably 6 lead a person to believe the user is an Advanced Practice Registered 7 Nurse, unless permitted by this act. Any individual doing so shall 8 9 be guilty of a misdemeanor, which shall be punishable, upon 10 conviction, by imprisonment in the county jail for not more than one 11 (1) year or by a fine of not less than One Hundred Dollars (\$100.00) 12 nor more than One Thousand Dollars (\$1,000.00), or by both such 13 imprisonment and fine for each offense;

14 6. "Certified Nurse Practitioner" is an Advanced Practice
15 Registered Nurse who performs in an expanded role in the delivery of
16 health care:



1 A Certified Nurse Practitioner shall be eligible, in accordance 2 with the scope of practice of the Certified Nurse Practitioner, to obtain recognition as authorized by the Board to prescribe, as 3 defined by the rules promulgated by the Board pursuant to this 4 5 section and subject to the medical direction of a supervising physician. This authorization shall not include dispensing drugs, 6 but shall not preclude, subject to federal regulations, the receipt 7 of, the signing for, or the dispensing of professional samples to 8 9 patients.

10 The Certified Nurse Practitioner accepts responsibility, 11 accountability, and obligation to practice in accordance with usual 12 and customary advanced practice registered nursing standards and 13 functions as defined by the scope of practice/role definition 14 statements for the Certified Nurse Practitioner;

15	7.	a.	"Clinical Nurse Specialist" is an Advanced Practice

3		deemed to be a Clinical Nurse Specialist under
4		the provisions of the Oklahoma Nursing Practice
5		Act.
6	b.	In the expanded role, the Clinical Nurse Specialist
7		performs at an advanced practice level which shall
8		include, but not be limited to:
9		(1) practicing as an expert clinician in the
10		provision of direct nursing care to a selected
11		population of patients or clients in any setting,
12		including private practice,
13		(2) managing the care of patients or clients with
14		complex nursing problems,
15		(3) enhancing patient or client care by integrating
16		the competencies of clinical practice, education,
17		consultation, and research, and
18		(4) referring patients or clients to other services.
19	с.	A Clinical Nurse Specialist in accordance with the
20		scope of practice of such Clinical Nurse Specialist
21		shall be eligible to obtain recognition as authorized
22		by the Board to prescribe, as defined by the rules
23		promulgated by the Board pursuant to this section, and
24		subject to the medical direction of a supervising

1 physician. This authorization shall not include 2 dispensing drugs, but shall not preclude, subject to federal regulations, the receipt of, the signing for, 3 or the dispensing of professional samples to patients. 4 5 d. The Clinical Nurse Specialist accepts responsibility, accountability, and obligation to practice in 6 accordance with usual and customary advanced practice 7 nursing standards and functions as defined by the 8 9 scope of practice/role definition statements for the 10 Clinical Nurse Specialist;

8. "Nurse-Midwife" is a qualified registered nurse who has
 received a certificate of recognition from the Oklahoma Board of
 Nursing who possesses evidence of certification according to the
 requirements of the American College of Nurse-Midwives.

A Certified Nurse-Midwife in accordance with the scope of 15 practice of such Certified Nurse-Midwife shall be eligible to obtain 16 recognition as authorized by the Board to prescribe, as defined by 17 the rules promulgated by the Board pursuant to this section and 18 subject to the medical direction of a supervising physician. 19 This authorization shall not include the dispensing of drugs, but shall 20 not preclude, subject to federal regulations, the receipt of, the 21 signing for, or the dispensing of professional samples to patients. 22 The Certified Nurse-Midwife accepts responsibility, 23

24 accountability, and obligation to practice in accordance with usual

1 and customary advanced practice registered nursing standards and 2 functions as defined by the scope of practice/role definition 3 statements for the Certified Nurse-Midwife;

9. "Nurse-midwifery practice" means providing management of 4 5 care of normal newborns and women, antepartally, intrapartally, postpartally and gynecologically, occurring within a health care 6 7 system which provides for medical consultation, medical management or referral, and is in accord with the standards for nurse-midwifery 8 9 practice as defined by the American College of Nurse-Midwives; 10 provided, a Certified Nurse-Midwife shall not provide services 11 relating to a Vaginal Birth After Cesarean (VBAC) unless such 12 services are delivered in a hospital licensed by the State Department of Health or are delivered when medically necessary to 13 preserve the life and health of the mother or child in a non-14 15 hospital setting; 10. "Certified Registered Nurse Anesthetist" is an 16 a. Advanced Practice Registered Nurse who: 17 is certified by the Council on Certification of 18 (1)Nurse Anesthetists as a Certified Registered 19 Nurse Anesthetist within one (1) year following 20 completion of an approved certified registered 21 nurse anesthetist education program, and 22 continues to maintain such recertification by the 23

Council on Recertification of Nurse Anesthetists, and

(2) administers anesthesia under the supervision of a medical doctor, an osteopathic physician, a podiatric physician or a dentist licensed in this state and under conditions in which timely onsite consultation by such doctor, osteopath, podiatric physician or dentist is available.

9 b. A Certified Registered Nurse Anesthetist, under the 10 supervision of a medical doctor, osteopathic 11 physician, podiatric physician or dentist licensed in 12 this state, and under conditions in which timely, on-13 site consultation by such medical doctor, osteopathic physician, podiatric physician or dentist is 14 15 available, shall be authorized, pursuant to rules adopted by the Oklahoma Board of Nursing, to order, 16 select, obtain and administer legend drugs, Schedules 17 II through V controlled substances, devices, and 18 medical gases only when engaged in the preanesthetic 19 preparation and evaluation; anesthesia induction, 20 maintenance and emergence; and postanesthesia care. 21 Α Certified Registered Nurse Anesthetist may order, 22 select, obtain and administer drugs only during the 23 perioperative or periobstetrical period. 24

- c. A Certified Registered Nurse Anesthetist who applies
   for authorization to order, select, obtain and
   administer drugs shall:
  - (1) be currently recognized as a Certified RegisteredNurse Anesthetist in this state,
- (2) provide evidence of completion, within the two-6 year period immediately preceding the date of 7 application, of a minimum of fifteen (15) units 8 9 of continuing education in advanced pharmacology related to the administration of anesthesia as 10 11 recognized by the Council on Recertification of Nurse Anesthetists or the Council on 12 13 Certification of Nurse Anesthetists, and
- 14 (3) complete and submit a notarized application, on a
  15 form prescribed by the Board, accompanied by the
  16 application fee established pursuant to this
  17 section.
- 18 d. The authority to order, select, obtain and administer
  19 drugs shall be terminated if a Certified Registered
  20 Nurse Anesthetist has:

## (1) ordered, selected, obtained or administered drugs outside of the Certified Registered Nurse Anesthetist scope of practice or ordered,

1 selected, obtained or administered drugs for 2 other than therapeutic purposes, or (2) 3 violated any provision of state laws or rules or federal laws or regulations pertaining to the 4 5 practice of nursing or the authority to order, select, obtain and administer drugs. 6 The Oklahoma Board of Nursing shall notify the Board 7 e. of Pharmacy after termination of or a change in the 8 9 authority to order, select, obtain and administer 10 drugs for a Certified Registered Nurse Anesthetist. 11 f. The Board shall provide by rule for biennial 12 application renewal and reauthorization of authority 13 to order, select, obtain and administer drugs for Certified Registered Nurse Anesthetists. At the time 14 of application renewal, a Certified Registered Nurse 15 Anesthetist shall submit documentation of a minimum of 16 eight (8) units of continuing education, completed 17 during the previous two (2) years, in advanced 18 pharmacology relating to the administration of 19 anesthesia, as recognized by the Council on 20 Recertification of Nurse Anesthetists or the Council 21 on Certification of Nurse Anesthetists. 22 This paragraph shall not prohibit the administration 23 q.

of local or topical anesthetics as now permitted by

1 law. Provided further, nothing in this paragraph 2 shall limit the authority of the Board of Dentistry to 3 establish the qualifications for dentists who direct 4 the administration of anesthesia;

5 11. "Supervising physician" means an individual holding a current license to practice as a physician from the State Board of 6 Medical Licensure and Supervision or the State Board of Osteopathic 7 Examiners, who supervises a Certified Nurse Practitioner, a Clinical 8 9 Nurse Specialist, or a Certified Nurse-Midwife, and who is not in 10 training as an intern, resident, or fellow. To be eligible to 11 supervise such Advanced Practice Registered Nurse, such physician 12 shall remain in compliance with the rules promulgated by the State 13 Board of Medical Licensure and Supervision or the State Board of Osteopathic Examiners; 14

15 12. "Supervision of an Advanced Practice Registered Nurse with 16 prescriptive authority" means overseeing and accepting 17 responsibility for the ordering and transmission by a Certified 18 Nurse Practitioner, a Clinical Nurse Specialist, or a Certified 19 Nurse-Midwife of written, telephonic, electronic or oral 20 prescriptions for drugs and other medical supplies, subject to a 21 defined formulary; and

13. "Advanced Unlicensed Assistant" means any person who has
successfully completed a certified training program approved by the
Board that trains the Advanced Unlicensed Assistant to perform

1	specified technical skills identified by the Board in acute care
2	settings under the direction and supervision of the Registered Nurse
3	or Licensed Practical Nurse.
4	SECTION 2. This act shall become effective November 1, 2017.
