1 care services or an officer, employee or agent thereof acting in the 2 course and scope of employment; and

4. "Health care services" means acts of diagnosis, treatment,
medical evaluation or advice or such other acts as may be
permissible under the health care licensing statutes of this state.

B. An action based on tort, contract or otherwise, for damages 6 7 for injury or death against a health care provider for alleged professional negligence, for the performance of health care services 8 9 without consent, or for error or omission in the practice of the 10 health care provider's profession, which occurs on or after the 11 effective date of this act, shall be commenced within two (2) years 12 of the act, omission or failure complained of or of the last treatment where there was continuous treatment for the same illness, 13 injury or condition which gave rise to the said act, omission or 14 15 failure. Where the action is based upon the discovery of a foreign object in the patient's body which is not discovered and could not 16 have reasonably been discovered within such two-year period, the 17 action may be commenced within one year of the date of such 18 discovery or of the date of discovery of facts which would 19 reasonably lead to such discovery, whichever is earlier. The time 20 within which an action shall be commenced shall not be extended by 21 any of the provisions of this section, including those relating to 22 the discovery of foreign objects, beyond four (4) years after the 23 date of the act, omission or failure giving rise to such action. 24

1	C. This act applies to all persons regardless of minority or
2	other legal disability, except that a minor who was less than eight
3	(8) years old at the time of the act, omission, or failure, shall
4	commence such action within two (2) years of the date on which the
5	minor becomes ten (10) years old. Furthermore, for a minor who was
6	less than eight (8) years old at the time of the act, omission, or
7	failure, the time within which such action shall be commenced shall
8	not be extended by any provision of this section beyond four (4)
9	years after the date on which the minor becomes ten (10) years old.
