13	BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:		
14	SECTION 1. AMENDATORY 40 O.S. 2011, Section 3-114, is		
15	amended to read as follows:		
16	Section 3-114. ESTIMATE OF FINANCIAL CONDITION OF FUND -		
17	SURCHARGE. Prior to the beginning of each calendar quarter, the		
18	Oklahoma Employment Security Commission shall prepare an estimate of		
19	the financial condition of the fund for the quarter. Effective July		
20	1, 1992, if If the estimate for any quarter shows a balance at any		
21	time during the quarter of less than Twenty-five Million Dollars		
22	(\$25,000,000.00), the Commission shall assess and collect a		
23	surcharge for that calendar quarter in an amount sufficient to keep

1	the balance a	t Twenty-five Million Dollars (\$25,000,000.00), except	
2	as otherwise	provided in this section.	
3	The surch	arge shall be charged to each employer in proportion to	
4	the employer'	s total tax liability as of the last completed quarter	
5	for the curre	nt calendar year and shall not exceed thirty-three and	
6	one-third per	cent (33 1/3%) per taxable year.	
7	<u>In a stat</u>	e of emergency declared by the Governor, the Oklahoma

16	be in full force from and after its passage and approval.
