20	SECTION 1. AMENDATORY 59 O.S. 2011, Section 1306, as		
21	last amended by Section 3, Chapter 203, O.S.L. 2016 (59 O.S. Supp.		
22	2020, Section 1306), is amended to read as follows:		
23	Section 1306. A. 1. An applicant for a cash bondsman license		
24	shall meet all requirements set forth in Section 1305 of this title		

1 with exception of the one-year residence requirement. An applicant 2 for a cash bondsman license shall affirmatively show that the 3 applicant has been a bona fide resident of the state for six (6) 4 months.

5 2. In addition to the requirements prescribed in Section 1305 of this title, an applicant for a professional bondsman license 6 7 shall have been continually licensed as a surety, cash or property bondsman in the State of Oklahoma for a minimum of two (2) years 8 9 immediately prior to the date of application and shall submit to the 10 Insurance Commissioner an audited financial statement prepared by an 11 accounting firm or individual holding a permit to practice public accounting in this state in accordance with the Statements on 12 Auditing Standards promulgated by the Auditing Standards Board of 13 the American Institute of Certified Public Accountants setting forth 14 the total assets of the bondsman less liabilities and debts as 15 follows: For all applications made prior to November 1, 2006, and 16 17 the subsequent renewals of a license issued upon the application when continuously maintained in effect as required by law, the 18 statement shall show a net worth of at least Fifty Thousand Dollars 19 (\$50,000.00). For all applications made on and after November 1, 20 2006, and the subsequent renewals of a license issued upon the 21 application when continuously maintained in effect as required by 22 law, or for the renewal or reinstatement of any license that is 23 expired pursuant to subsection D of Section 1309 of this title, 24

1 suspended or revoked, the statement shall show a net worth of at 2 least One Hundred Fifty Thousand Dollars (\$150,000.00), the 3 statements to be current as of a date not earlier than ninety (90) 4 days prior to submission of the application and the statement shall 5 be attested to by an unqualified opinion of the accountant.

Professional bondsman applicants shall make a deposit with 6 3. the Insurance Commissioner in the same manner as required of 7 domestic insurance companies of an amount to be determined by the 8 9 Commissioner. For all applications made prior to November 1, 2006, 10 and the subsequent renewals of a license issued upon the application 11 when continuously maintained in effect as required by law, the 12 deposit shall not be less than Twenty Thousand Dollars (\$20,000.00). For all applications made on and after November 1, 2006, and the 13 subsequent renewals of a license issued upon the application when 14 continuously maintained in effect as required by law, or for the 15 renewal or reinstatement of any license that is expired pursuant to 16 17 subsection D of Section 1309 of this title, suspended or revoked, the deposit shall not be less than Fifty Thousand Dollars 18 (\$50,000.00). The deposits shall be subject to all laws, rules and 19 regulations as deposits by domestic insurance companies but in no 20 instance shall a professional bondsman write bonds which equal more 21 than ten times the amount of the deposit which the bondsman has 22 submitted to the Commissioner. Such deposit shall require the 23 review and approval of the Insurance Commissioner prior to exceeding 24

1 the maximum amount of Federal Deposit Insurance Corporation basic 2 deposit coverage for any one bank or financial institution. In 3 addition, a professional bondsman may make the deposit by purchasing an annuity through a licensed domestic insurance company in the 4 5 State of Oklahoma. The annuity shall be in the name of the bondsman as owner with legal assignment to the Insurance Commissioner. 6 The assignment form shall be approved by the Commissioner. If a 7 bondsman exceeds the above limitation, the bondsman shall be 8 9 notified by the Commissioner that the excess shall be reduced or the 10 deposit increased within ten (10) days of notification, or the 11 license of the bondsman shall be suspended immediately after the 12 ten-day period, pending a hearing on the matter. The limitation may be exceeded with Commissioner approval when a state of emergency or 13 disaster is declared by the Governor, the Oklahoma Legislature or by 14 the United States Presidential Declaration of a Federal Emergency or 15 16 Major Disaster.

The deposit provided for in this section shall constitute a
 reserve available to meet sums due on forfeiture of any bonds or
 recognizance executed by the bondsman.

5. Any deposit made by a professional bondsman pursuant to this section shall be released and returned by the Commissioner to the professional bondsman only upon extinguishment of all liability on outstanding bonds. Provided, however, the Commissioner shall have the authority to review specific financial circumstances and history

of a professional bondsman, on a case-by-case basis, and may release
 a portion of the deposit if warranted. The Commissioner may
 promulgate rules to effectuate the provisions of this paragraph.

6. No release of deposits to a professional bondsman shall be
made by the Commissioner except upon written application and the
written order of the Commissioner. The Commissioner shall have no
liability for any such release to a professional bondsman provided
the release was made in good faith.

9 в. The deposit provided in this section shall be held in 10 safekeeping by the Insurance Commissioner and shall only be used if 11 a bondsman fails to pay an order and judgment of forfeiture after being properly notified or shall be used if the license of a 12 professional bondsman has been revoked. The deposit shall be held 13 in the name of the Insurance Commissioner and the bondsman. 14 The bondsman shall execute an assignment or pledge of the deposit to the 15 Insurance Commissioner for the payment of unpaid bond forfeitures. 16

When a bail bondsman or managing general agent accepts collateral, the bail bondsman or managing general 13 agent shall give a written receipt for same, and this receipt shall 14 15 give in detail a full description of the collateral received. A description of the collateral shall be listed on the undertaking by 16 affidavit. All property taken as collateral, whether personal, 17 intangible or real, shall be receipted for and deemed, for all 18 purposes, to be in the name of, and for the use and benefit of, the 19 insurer. Every receipt, encumbrance, mortgage or other evidence of 20 the custody, possession or claim shall facially indicate that it has 21 been taken or made on behalf of the insurer through its authorized 22 agent, the individual licensed bondsman or managing general agent 23 who has transacted the undertaking with the bond principal. Any 24

1 mortgage or other encumbrance against real property taken under the provisions of this section which does not indicate beneficial 2 3 ownership of the claim to be in favor of the insurer shall be deemed to constitute a cloud on the title to real estate and shall subject 4 5 the person filing, or causing same to be filed, in the real estate records of the county, to a penalty of treble damages or One 6 Thousand Dollars (\$1,000.00), whichever is greater, in an action 7 brought by the person, organization or corporation injured thereby. 8 9 For collateral taken, or liens or encumbrances taken or made 10 pursuant to the provisions of this section, the individual bondsman 11 or managing general agent taking possession of the property or 12 making the lien, claim or encumbrance shall do so on behalf of the insurer, and the individual licensed bondsman shall be deemed to act 13 in the capacity of fiduciary in relation to both: 14

The principal or other person from whom the property is
 taken or claimed against; and

17 2. The insurer whose agent is the licensed bondsman.

As fiduciary and bailee for hire, the individual bondsman shall be liable in criminal or civil actions at law for failure to properly receipt or account for, maintain or safeguard, release or deliver possession upon lawful demand, in addition to any other penalties set forth in this subsection. No person who takes possession of property as collateral pursuant to this section shall use or otherwise dissipate the asset, or do otherwise with the

property than to safeguard and maintain its condition pending its return to its lawful owner, or deliver to the insurer, upon lawful demand pursuant to the terms of the bailment.

4 <u>When collateral security is received in the form of cash or</u>
5 <u>check or other negotiable instrument, the bondsman shall deposit the</u>
6 <u>cash or instrument within two (2) business days after receipt in an</u>
7 <u>established, separate non-interest-bearing trust account in any bank</u>
8 <u>located in Oklahoma. The trust account funds required under this</u>
9 <u>section shall not be commingled with other operating funds.</u>

B. Every licensed bondsman shall file monthly electronically with the Insurance Commissioner and on forms approved by the Commissioner as follows:

A monthly report showing every bond written, amount of bond,
 whether released or revoked during each month, showing the court and
 county, and the style and number of the case, premiums charged and
 collateral received; and

2. Professional bondsmen and multicounty agent bondsmen shall 17 submit electronic monthly Monthly reports showing total current 18 liabilities, all bonds written during the month by the professional 19 bondsman or multicounty agent bondsman and by any licensed bondsman 20 who may countersign for the professional bondsman or multicounty 21 agent bondsman, all bonds terminated during the month, and the total 22 liability and a list of all bondsmen currently employed by the 23 professional bondsman or multicounty agent bondsman. 24

Monthly reports shall be submitted electronically to the
 Insurance Commissioner by the fifteenth day of each month. The
 records shall be maintained by the Commissioner as public records.

C. Every licensee shall keep at the place of business of the 4 5 licensee the usual and customary records pertaining to transactions authorized by the license. All of the records shall be available 6 7 and open to the inspection of the Commissioner at any time during business hours during the three (3) years immediately following the 8 9 date the liability of the bondsman on the bond is discharged by the 10 court or the date collateral is returned by the bondsman to its lawful owner, whichever is later. If an appearance bond is never 11 12 executed and filed with the court, then all records shall be maintained for three (3) years immediately following the date the 13 documents were prepared. The Commissioner may require a financial 14 examination or market conduct survey during any investigation of a 15 licensee. 16

D. Each bail bondsman shall submit each month with the monthly
report of the bondsman, a reviewal fee equal to two-tenths of one
percent (2/10 of 1%) of the new liability written for that month.
The fee shall be payable to the Insurance Commissioner who shall
deposit same with the State Treasurer.

22 SECTION 3. AMENDATORY Section 1, Chapter 212, O.S.L. 23 2015 (59 O.S. Supp. 2020, Section 1315.1), is amended to read as 24 follows:

1 Section 1315.1. A. On and after the effective date of this act 2 November 1, 2015, as an exception to the provisions in paragraph 8, 9, 10 or 11 of subsection A of Section 1315 of Title 59 of the 3 Oklahoma Statutes this title prohibiting a person from being a bail 4 5 bondsman or receiving any benefit from the execution of any bail bond, a person who holds an ownership interest in a restaurant 6 establishment where alcoholic beverages are lawfully sold incidental 7 to the sale of food or who is an officer, director or stockholder of 8 9 a corporation that owns or operates a restaurant where alcoholic 10 beverages are lawfully sold incidental to the sale of food, may be a 11 licensed bail bondsman. For purposes of this section, "incidental to the sale of food" means the sale of all alcoholic beverages is 12 not more than fifty percent (50%) of the monthly gross sales of the 13 establishment, and "alcoholic beverages" means all beverages 14 15 containing more than three and two-tenths percent (3.2%) alcohol by weight, and all mixed beverage coolers, as defined by Section 506 of 16 17 Title 37 of the Oklahoma Statutes, regardless of percent of alcohol content, and all beverages containing more than one-half of one 18 percent (1/2 of 1%) alcohol by volume and not more than three and 19 two-tenths percent (3.2%) alcohol by weight. 20

B. No licensed bondsman who holds any license issued from the
ABLE Commission or any permit issued from any governmental
subdivision or who has any ownership interest, employment or
interest in any business identified by the provisions of paragraph

8, 9, 10 or 11 <u>of subsection A</u> of Section 1315 of <del>Title 59 of the</del>
 <del>Oklahoma Statutes</del> <u>this title</u> may execute the duties of a bondsman or
 have a bondsman office on the premises of such establishment.

C. No exception authorized in this section for a licensed
bondsman to additionally hold a license issued by the ABLE
Commission or a permit issued by a governmental subdivision pursuant
to paragraph 8, 9, 10 or 11 <u>of subsection A</u> of Section 1315 of <del>Title</del>
<del>59 of the Oklahoma Statutes</del> <u>this title</u> shall apply to or be
construed as an exception for a bail enforcer.

10 D. The ABLE Commission shall be authorized to investigate all 11 provisions authorized by this section and shall certify in writing 12 to the Insurance Commissioner, upon written request, that a person is eligible for an exception to the prohibitions of Section 1315 of 13 Title 59 of the Oklahoma Statutes this title. The ABLE Commission 14 15 shall immediately notify the Insurance Commissioner, in writing, if a person becomes disqualified for an exception to the prohibitions 16 of paragraph 8, 9, 10 or 11 of subsection A of Section 1315 of Title 17 59 of the Oklahoma Statutes this title. If, after an investigation 18 of a violation of the provisions of this section, the bail bondsman 19 is found to be disqualified to be licensed as a bail bondsman, the 20 ABLE Commission shall be entitled to reimbursement for all costs, 21 expenses and attorney fees and in addition, the person shall have 22 the bail bondsman license permanently revoked by the Insurance 23 Commissioner. 24

Section 1327. A. At any time before there has been a breach of 4 5 the undertaking in any type of bail provided herein, the surety or bondsman or a licensed bail enforcer pursuant to a client contract 6 7 authorized by the Bail Enforcement and Licensing Act may surrender the defendant, or the defendant may surrender himself or herself, to 8 9 the official to whose custody the defendant was committed at the 10 time bail was taken, or to the official into whose custody the 11 defendant would have been given had he or she been committed. The 12 defendant may be surrendered without the return of premium for the bond if he or she has been guilty of nonpayment of premium, changes 13 address without notifying his or her bondsman, conceals himself or 14 15 herself, leaves the jurisdiction of the court without the permission of his or her bondsman, or violates his or her contract with the 16 bondsman in any way that does harm to the bondsman, or the surety, 17 or violates his or her obligation to the court. When a bondsman or 18 surety, or a licensed bail enforcer, surrenders a defendant pursuant 19 to this subsection, the bondsman or surety shall file written 20 notification of the surrender. After surrender, and upon filing of 21 written notification of the surrender with the court clerk, the bond 22 shall be exonerated and the clerk shall enter a minute in the case 23 exonerating the bond. 24

1 B. 1. If the defendant has been placed in custody of another 2 jurisdiction, the district attorney shall direct a hold order to the 3 official, judge or law enforcement agency where the defendant is in custody. All reasonable expenses accrued in returning the defendant 4 to the original court shall be borne by the bondsman who posted the 5 bond with that court; provided, however, except for instances 6 whereby the defendant is transported by a contracted transport 7 company, reasonable expenses shall mean the actual miles traveled in 8 9 transporting the defendant at a rate equal to the current Internal 10 Revenue Service standard mileage rate. Upon application, the bond 11 in the original court shall be exonerated when the hold order is 12 placed and upon proof of payment of expenses by the bondsman. 2. Except as provided for in paragraph 3 of this subsection, 13 the premium for a bail bond shall be considered earned by the 14 bondsman or the insurer, as applicable, when the defendant on the 15 16 bond is released from custody and is not incarcerated in any capacity. If the bond premium has not been earned pursuant to the 17 terms of this section, the payor of the premium or the depositor of 18 any collateral, as applicable, may request the return of the premium 19 or collateral given to the bondsman for the bond. The bondsman 20 shall return any premium and collateral without delay. If a 21 bondsman returns the premium to the payor pursuant to this section, 22 he or she may charge a usual, customary, and reasonable fee for his 23 or her services provided in the transaction. 24

<u>3. The premium for a bail bond shall be considered earned by</u>
 <u>the bondsman, regardless of whether the defendant on the bond is</u>
 <u>released from custody, if the bondsman and the payor of the bond</u>
 <u>premium have agreed in writing that the purpose of the bond is to</u>
 <u>secure the transfer of the defendant to another jurisdiction and the</u>
 <u>defendant is in fact transferred to that jurisdiction.</u>

C. If the defendant has been arrested on new charges and is in 7 the custody of the same jurisdiction in which the bondsman or surety 8 9 has posted an appearance bond or bonds for the defendant, and the 10 bond or bonds have not been exonerated, and certified copies of bonds are not reasonably available, the bondsman or surety may 11 12 recommit the defendant to be held in custody on the charges for which the bondsman or surety has previously posted appearance bonds 13 thereon, in accordance with the following procedure: 14

On a Recommitment of Defendant by Bondsman form approved by
 the Administrative Office of the Courts, the bondsman or surety
 shall personally affix his or her signature to an affidavit
 attesting to the following:

a. the defendant is presently in the custody of the
jurisdiction in which the bondsman or surety has
posted a bond or bonds,

b. the case number, if any, assigned to each bond,
c. that the bond or bonds have not been exonerated, and
d. the specific charges and bond amount or amounts;

The bondsman or surety shall present the Recommitment of Defendant by Bondsman form to the official in whose custody the defendant is being held, and the official shall detain the defendant in his or her custody, thereon, as upon a commitment, and by a certificate in writing acknowledging the surrender; and

When a bondsman or surety recommits a defendant pursuant to 7 this subsection, the bondsman or surety shall file a written 8 notification thereof to the court, and after such notification, the 9 bond or bonds shall be exonerated, and the clerk shall enter a 10 minute in the case exonerating the bond or bonds.

D. <u>1.</u> When a defendant does appear before the court as required by law and enters a plea of guilty or nolo contendere, is sentenced or a deferred sentence is granted as provided for in Section 991c of Title 22 of the Oklahoma Statutes, or deferred prosecution is granted as provided by law, in such event the undertaking and bondsman and insurer shall be exonerated from further liability.

18 <u>2. A bond posted for a petition for revocation of a suspended</u> 19 <u>sentence, a petition for acceleration of a deferred sentence or any</u> 20 <u>violation of a probationary term shall be exonerated by operation of</u> 21 law when:

5 Ε. The bond shall be exonerated by operation of law in any case in which the defendant has been arrested on new charges in the same 6 jurisdiction in which the bondsman or insurer has posted the 7 appearance bond or bonds for the defendant, and the defendant has 8 9 been subsequently released on his or her own personal recognizance. 10 F. The bond shall be exonerated by operation of law in any case 11 in which the defendant has been arrested and there is an added 12 charge to a case that would result in a higher fine or longer term of sentence if convicted, or an amendment to a charge that would 13 result in a higher fine or longer term of sentence if convicted; 14 provided, however, any premium paid by the defendant to the bondsman 15 or insurer from the original charge shall be at the same premium 16 17 rate and shall be credited to the defendant if the same bondsman or

18 insurer posts the appearance bond or bonds on the added or amended 19 charge.

<u>G. For purposes of this section, a "usual, customary, and</u>
<u>reasonable fee" means a charge to the payor that is based on the</u>
<u>amount of time spent by the bondsman or his or her employees</u>
<u>researching, drafting, and executing the bail bond. Such fee shall</u>
be detailed in a written document provided to the payor.

 last amended by Section 11, Chapter 203, O.S.L. 2016 (59 O.S. Supp.
 2020, Section 1328), is amended to read as follows:

Section 1328. A. The bondsman or insurer, or a licensed bail 4 5 enforcer pursuant to a client contract authorized by the Bail Enforcement and Licensing Act, desiring to make a surrender of the 6 defendant shall procure or have in his or her possession a certified 7 copy of the undertakings and deliver such documents together with 8 9 the defendant to the official in whose custody the defendant was at 10 the time bail was taken, or to the official into whose custody he or she would have been given had he or she been committed, who shall 11 12 detain the defendant in custody thereon, as upon a commitment, and by a certificate in writing acknowledge the surrender. 13

Upon the presentation of a certified copy of the undertaking and 14 the certificate of the official, the court before which the 15 defendant has been held to answer, or the court in which the 16 preliminary examination, indictment, information or appeal is 17 pending, shall upon notice of three (3) days given by the person 18 making the surrender to the prosecuting officer of the court having 19 jurisdiction of the offense, together with a copy of the 20 undertakings and certificate, order that the obligors be exonerated 21 from liability on their undertakings; and, if money has been 22 deposited as bail, that such money or bonds be refunded. 23 Ιf property pledged, a certificate of exoneration be issued and the 24

possession and shall present the license to any law enforcement
officer immediately upon request.
