7	An Act relating to schools; providing definitions;
8	prohibiting public schools and charter schools from teaching or training students to believe certain
9	divisive concepts; allowing a teacher to be dismissed or not reemployed for teaching or training students
10	to believe certain divisive concepts; providing certain construction; providing for promulgation of
11	rules; providing for codification; providing an effective date; and declaring an emergency.

14	BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:
15	SECTION 1. NEW LAW A new section of law to be codified
16	in the Oklahoma Statutes as Section 11-103.12 of Title 70, unless
17	there is created a duplication in numbering, reads as follows:
18	A. As used in this section:
19	1. "Divisive concepts" means the concepts that:
20	a. one race or sex is inherently superior to another race
21	or sex,
22	b. the United States is fundamentally racist or sexist,

- c. an individual, by virtue of his or her race or sex, is inherently racist, sexist or oppressive, whether consciously or unconsciously,
- 4 d. an individual should be discriminated against or
 5 receive adverse treatment solely or partly because of
 6 his or her race or sex,
- 7 e. members of one race or sex cannot and should not 8 attempt to treat others without respect to race or 9 sex,
- 10 f. an individual's moral character is necessarily 11 determined by his or her race or sex,
- 12 g. an individual, by virtue of his or her race or sex, 13 bears responsibility for actions committed in the past 14 by other members of the same race or sex,
- h. any individual should feel discomfort, guilt, anguish
 or any other form of psychological distress on account
 of his or her race or sex,
- i. meritocracy or traits such as a hard work ethic are
 racist or sexist or were created by a particular race
 to oppress another race, or
 - j. any other form of race or sex stereotyping or any other form of race or sex scapegoating;

1 2. "Race or sex stereotyping" means ascribing character traits, 2 values, moral and ethical codes, privileges, status or beliefs to a 3 race or sex, or an individual because of his or her race or sex; and

3. "Race or sex scapegoating" means assigning fault, blame or
bias to a race or sex or to members of a race or sex because of
their race or sex. It also includes any claim that consciously or
unconsciously and by virtue of his or her race or sex, members of
any race are inherently racist or are inherently inclined to oppress
others, or that members of a sex are inherently sexist or inclined
to oppress others.

B. Public school districts and public charter schools in this state shall be prohibited from teaching, instructing or training any student to believe any of the divisive concepts set forth in subsection A of this section.

C. Subject to the provisions of the Teacher Due Process Act of
 1990, a teacher may be dismissed or not reemployed for teaching,
 instructing or training any student to believe any of the divisive
 concepts set forth in subsection A of this section.

D. Nothing in this section shall be construed to prohibit discussing, as part of a larger course of academic instruction, the divisive concepts provided for in subsection A of this section in an objective manner and without endorsement.

E. The State Board of Education may promulgate rules to implement and monitor compliance with the provisions of this act.
