1 The State of Oklahoma is hereby divided into five (5) 2 Congressional Districts as described in this section. The following 3 delineation of areas to be included in each Congressional District 4 is based on the official Counties, Voting Tabulation Districts (VTD) 5 and Census Blocks (Block) as defined in 2020 by the United States 6 Bureau of the Census. The five (5) Congressional Districts shall 7 consist of the Counties, Voting Tabulation Districts (VTD) and 8 Census Blocks (Block) described as follows: POPULATION .

9 SECTION 3. NEW LAW A new section of law to be codified 10 in the Oklahoma Statutes as Section 6.8 of Title 14, unless there is 11 created a duplication in numbering, reads as follows:

The Oklahoma Congressional Redistricting Act of 2021 shall not affect the operation of any board, commission or other entity whose membership is based upon Congressional Districts previously created by law.

SECTION 4. NEW LAW A new section of law to be codified in the Oklahoma Statutes as Section 6.9 of Title 14, unless there is created a duplication in numbering, reads as follows:

The Congressional Districts described in the Oklahoma Congressional Redistricting Act of 2021 shall become effective at the beginning of the terms of the members of the United States House of Representatives elected at the General Election in November 2022; provided, however, the State Election Board shall conduct the
