1 ENGROSSED SENATE BILL NO. 852 By: David and Fields of the 2 Senate 3 and Osborn (Leslie) and Wallace 4 of the House 5 6 7 An Act relating to appropriations; making an appropriation to the State Board of Education; stating purpose; providing lapse dates; requiring and 8 prohibiting certain budget procedures; providing an 9 effective date; and declaring an emergency. 10 11 12 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA: 13 SECTION 1. There is hereby appropriated to the State Board of Education from any monies not otherwise appropriated from the 14 15 Constitutional Reserve Fund of the State Treasury, the sum of Thirty-three Million Dollars (\$33,000,000.00) or so much thereof as 16 may be necessary for the financial support of public schools. 17 SECTION 2. Appropriations made by this act, not including 18 appropriations made for capital outlay purposes, may be budgeted for 19 the fiscal year ending June 30, 2018 (hereafter FY-18), or may be 20 budgeted for the fiscal year ending June 30, 2019 (hereafter FY-19). 21 Funds budgeted for FY-18 may be encumbered only through June 30, 22 2018, and must be expended by November 15, 2018. Any funds 23

remaining after November 15, 2018, and not budgeted for FY-19, shall

1 lapse to the credit of the proper fund for the then current fiscal year. Funds budgeted for FY-19 may be encumbered only through June 2 30, 2019. Any funds remaining after November 15, 2019, shall lapse 3 4 to the credit of the proper fund for the then current fiscal year. 5 These appropriations may not be budgeted in both fiscal years simultaneously. Funds budgeted in FY-18, and not required to pay 6 obligations for that fiscal year, may be budgeted for FY-19, after 7 the agency to which the funds have been appropriated has prepared 9 and submitted a budget work program revision removing these funds 10 from the FY-18 budget work program and after such revision has been 11 approved by the Office of Management and Enterprise Services. SECTION 3. This act shall become effective July 1, 2017. 12

SECTION 4. It being immediately necessary for the preservation of the public peace, health or safety, an emergency is hereby declared to exist, by reason whereof this act shall take effect and be in full force from and after its passage and approval.
