Supp. 2020, Section 500.18), which relates to exemptions; adding the Oklahoma Military Department; 8 and providing an effective date. 9 10 11 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA: 74 O.S. 2011, Section 500.18, as 12 SECTION 1. AMENDATORY last amended by Section 10, Chapter 269, O.S.L. 2016 (74 O.S. Supp. 13 2020, Section 500.18), is amended to read as follows: 14 15 Section 500.18. A. Except for members of the Legislature, the Governor and the Lieutenant Governor, provisions of Sections 500.1 16 through 500.18 of this title shall be mandatory for all officials 17 and employees of all departments, boards, commissions and 18 institutions of the state, regardless of the provisions of any other 19 act of the Legislature, except as provided by this section. 20 The enactment of any measure in the future providing for travel 21 reimbursement of state officers and employees on the basis of 22 "actual and necessary" expenses or in any other manner inconsistent 23 with Sections 500.1 through 500.18 of this title shall be deemed to 24

1 provide for reimbursement in accordance with Sections 500.1 through 2 500.18 of this title unless a contrary intent is explicitly expressed in this section. Sections 500.1 through 500.18 of this 3 title shall not apply, however, to travel reimbursements made by 4 5 political subdivisions of this state, except as otherwise provided by law. 6

7 The agencies listed below are authorized certain exceptions Β. and/or exemptions to the provisions of Sections 500.1 through 500.18 8 9 of this title to the extent specified:

1. Oklahoma Department of Agriculture, Food, and Forestry: 11 a. The actual and reasonable expenses of travel and 12 subsistence in pursuing and developing markets for Oklahoma agricultural products incurred by the 13 Commissioner, Deputy Commissioner and such employees 14 15 designated by the State Board of Agriculture within the marketing development programs of the Oklahoma 16 Department of Agriculture, Food, and Forestry shall be 17 reimbursed to the employee incurring such expenses. 18 Reimbursement of such expenses shall be in accordance 19 with rules adopted by the Board. Expenses claimed 20 shall, prior to reimbursement, be reviewed by the 21 Board at a regular meeting and individually approved 22 or disapproved. 23

b. The actual and necessary expenses of out-of-state
travel and subsistence incurred by employees of the
Forestry Division authorized to evaluate and acquire
federal excess property or surplus property in other
states for use in its fire protection program, shall
be reimbursed to the employee incurring such expenses.

7 2. Department of Public Safety:

8 When traveling with the Governor or at the Governor's request, 9 personnel assigned by the Commissioner for executive security and 10 pilots on executive assignment shall be allowed their actual and 11 necessary traveling expenses, upon claims approved by the 12 Commissioner.

13 3. Department of Corrections:

The Department of Corrections shall be exempt from limitations of reimbursement for rented automobiles, as set forth in Section 500.5 of this title, when the rental is by a Correctional Officer or Transportation Officer for the limited purpose of transporting inmates. Reimbursement for the expense shall be on the basis of actual cost.

20 4. Oklahoma Tourism and Recreation Department:

The Oklahoma Tourism and Recreation Commission and Department staff who promote in-state and out-of-state business for Oklahoma's state-operated or state-owned parks, lodges, and golf courses and the tourism and recreation industry, may be reimbursed for the

1 actual and necessary expense of travel, subsistence and entertainment for this purpose. The Director of the Oklahoma 2 3 Tourism and Recreation Department may reimburse the Publisher of Oklahoma Today magazine and its staff for expenses for meals and 4 5 other entertainment in order to gain advertising and promotion for Oklahoma Today magazine. The Oklahoma Tourism and Recreation 6 Department may reimburse the Director of the Office of the Oklahoma 7 Film and Music Commission and staff for the actual and necessary 8 9 expenses for meals and other entertainment in order to promote the film and music industries in this state. Reimbursement of all 10 11 actual and necessary expenses shall be in accordance with rules 12 adopted by the Oklahoma Tourism and Recreation Commission. 13 5. Oklahoma Department of Commerce:

The actual and necessary expenses incurred by the 14 a. Director and other employees of the Department 15 authorized by the Director for the purpose of business 16 recruitment shall be reimbursed. Reimbursement of 17 expenses shall be in accordance with rules adopted by 18 the Director of the Oklahoma Department of Commerce. 19 Expenses claimed shall, prior to reimbursement, be 20 reviewed by the Director and individually approved or 21 disapproved. 22

b. The Department, at the discretion of the Director, may
 charter aircraft for the purposes of carrying out its

1 duties and responsibilities related to business 2 recruitment and performing the duties of the Director. 3 The cost of such charter shall be exempt from the provisions of Section 500.6 of this title. Claims 4 5 filed with the Office of Management and Enterprise Services shall bear the following certification: 6 The best interests of the citizens of Oklahoma were 7 better served in that conventional ground 8 9 transportation was not practical or feasible for this 10 trip, aircraft from the Department of Public Safety 11 were not available for this trip, and no other claim 12 has been or will be filed as a payment for the cost of 13 transportation in connection with this trip.

14 6. Office of Management and Enterprise Services:

15 The actual and necessary expenses of travel and subsistence incurred by the Director, any state employee approved by his or her 16 17 appointing authority, or state officials, for travel outside the state in performance of duties related to bond financing shall be 18 reimbursed to the employee or state official incurring such 19 expenses. Reimbursement for lodging expenses shall be supported by 20 three telephone bids from hotels within a reasonable distance of the 21 activity for which the travel was approved. 22

23 7. Oklahoma Futures:

1 The actual and necessary expenses incurred by the members of 2 Oklahoma Futures in the performance of their duties shall be 3 reimbursed to the members incurring such expenses. Reimbursement of 4 all actual and necessary expenses shall be in accordance with rules 5 adopted by Oklahoma Futures.

6

8. Oklahoma Development Finance Authority:

7 The actual and necessary expenses incurred by the members and 8 employees of the Oklahoma Development Finance Authority in the 9 performance of their duties shall be reimbursed to the person 10 incurring such expenses. Reimbursement of all actual and necessary 11 expenses shall be in accordance with the bylaws of the Authority.

9. Oklahoma Center for the Advancement of Science andTechnology:

The actual and necessary expenses incurred by the members and employees of the Oklahoma Center for the Advancement of Science and Technology in the performance of their duties shall be reimbursed to the person incurring such expenses. Reimbursement of all actual and necessary expenses shall be in accordance with the bylaws of the Center.

20 10. Center for International Trade Development:

The actual and necessary expenses of travel, lodging and subsistence incurred by the Director and authorized employees of the Center for International Trade Development for performance of their duties for the purpose of business recruitment and assistance shall

1 be reimbursed to the person incurring such expenses. Reimbursement of such expenses shall be in accordance with the rules adopted by 2 the Director of the Center for International Trade Development. 3 Expenses claimed shall be reviewed and individually approved or 4 5 disapproved, prior to reimbursement, first by the Director, and finally by either the Vice President, Business and Finance of 6 Oklahoma State University or the President of Oklahoma State 7 University. 8

Oklahoma State Bureau of Investigation: 10 The actual and necessary expenses incurred by the Director and 11 other employees of the Bureau authorized by the Director as a result of conducting investigations shall be reimbursed to each such 12 13 employee incurring the expenses. Reimbursement of the expenses shall be in accordance with rules adopted by the Director of the 14 Oklahoma State Bureau of Investigation. Prior to reimbursement, 15 expenses claimed shall be reviewed by the Director and individually 16 approved or disapproved. 17

Department of Human Services: 18 12.

The actual and necessary expenses of travel, lodging 19 a. and subsistence incurred by employees of the Legal 20 Division in the performance of their duties for the 21 purpose of representing the Department of Human 22 Services or any of its officials, employees, 23 institutions or hospitals at any proceeding, including 24

1 depositions, held before any court, administrative 2 body or representative thereof, shall be reimbursed to 3 the employee incurring such expenses. Expenses claimed shall be approved by the General Counsel and 4 5 the Director of Human Services prior to reimbursement. The Department, at the discretion of the Director, may 6 b. 7 charter aircraft when determined by the Director such charter would be more practical or less expensive than 8 9 normal modes of transportation and when aircraft of 10 the Department of Public Safety are unavailable. The costs of such charter shall be exempt from the 11 provisions of Section 500.6 of this title. 12

13 13. Oklahoma Health Care Authority:

The actual and necessary expenses of travel, lodging and 14 15 subsistence incurred by employees of the Legal Division in the performance of their duties for the purpose of representing the 16 17 Authority or any of its officials or employees, at any proceeding, including depositions, held before any court, administrative body or 18 representative thereof, shall be reimbursed to the employee 19 20 incurring such expenses. Expenses claimed shall be approved by the Administrator prior to reimbursement. 21

22 14. Oklahoma State Bureau of Narcotics and Dangerous Drugs 23 Control:

1 The actual and necessary expenses incurred by the Director and other employees of the Bureau authorized by the Director as a result 2 3 of conducting investigations shall be reimbursed to each employee incurring the expenses. Reimbursement of the expenses shall be in 4 5 accordance with rules adopted by the Director of the Oklahoma State Bureau of Narcotics and Dangerous Drugs Control. Prior to 6 reimbursement, expenses claimed shall be reviewed by the Director 7 and individually approved or disapproved. 8

15. University Hospitals:

10 The actual and necessary expenses of travel, lodging and 11 subsistence incurred by employees of the Legal Office in the 12 performance of their duties for the purpose of representing the 13 University Hospitals or any of its officials, employees, institutions or hospitals at any proceeding, including depositions, 14 held before any court, administrative body or representative 15 thereof, shall be reimbursed to the employee incurring such 16 expenses. Expenses shall be approved by the Chief Executive Officer 17 of the University Hospitals or by the University Hospitals 18 Authority. 19

20 16. Oklahoma Historical Society:

The actual and necessary expenses of travel, subsistence and entertainment incurred by the Executive Director, Deputy Director and any employees designated by the Executive Committee of the Oklahoma Historical Society Board of Directors in pursuing and

developing programs and projects for the preservation and marketing of Oklahoma history shall be reimbursed to the person incurring the expenses. Reimbursement of expenses shall be in accordance with rules adopted by the Oklahoma Historical Society Board of Directors. Prior to reimbursement, expenses claimed shall be reviewed by the Executive Committee at a regularly scheduled meeting and each claim shall be individually approved or disapproved.

17. The Oklahoma Department of Mines:

9 The actual and necessary expenses of travel, lodging and 10 subsistence incurred by employees of the Department in the 11 performance of their duties for the purpose of representing the 12 Department or any of its officials or employees, at any proceeding, 13 hearing or meeting with federal agencies, boards, commissions, congressional representatives, congressional committees or staff, 14 shall be reimbursed to the employee incurring such expenses. 15 Expenses claimed shall be approved by the Executive Director prior 16 to reimbursement. 17

18 18. The Office of Attorney General:

19 The actual and necessary expenses of travel, lodging and 20 subsistence incurred by its employees in the performance of their 21 duties for the purpose of representing the state, the Legislature, 22 any state board, agency or commission, or any employee or official 23 of the state entitled to representation, at any proceeding, 24 including depositions, held before any court, administrative body or

any representative thereof, and the actual and necessary expenses
 incurred by employees as a result of conducting investigations shall
 be reimbursed to the employee incurring the expenses. The expenses
 shall be approved by the Attorney General prior to reimbursement.

19. District Attorneys Council:

The actual and necessary expenses of travel, lodging and 6 7 subsistence incurred by each district attorney and other employees of the district attorney authorized by the district attorney in the 8 9 performance of their duties for any district other than the district 10 for which they are employed for the purpose of representing the state, any county, or any employee or official of the state entitled 11 12 to representation at any proceeding, including depositions held before any court, administrative body or any representative of a 13 court or administrative body, and the actual and necessary expenses 14 incurred as a result of conducting investigations shall be 15 reimbursed to each employee incurring the expenses. Reimbursement 16 of the expenses shall be in accordance with rules adopted by the 17 District Attorneys Council. Prior to reimbursement, expenses 18 claimed shall be reviewed by the Council and individually approved 19 or disapproved. 20

21 20. The Department of Securities:

The actual and necessary expenses of travel, lodging and subsistence incurred by the Administrator and other employees of the Department of Securities in the performance of their duties for the

purpose of representing the Department of Securities, at any proceeding, including depositions, held before any court, administrative body or any representative thereof, conducting onsite examinations, or conducting investigations, shall be reimbursed to each employee incurring the expenses. The expenses shall be approved by the Administrator of the Department of Securities prior to reimbursement.

8 21. Corporation Commission:

9 The actual and necessary travel expenses incurred by the staff 10 of the Public Utility Division as a result of conducting audits 11 and/or reviews of utility service providers shall be reimbursed to 12 each such employee incurring the expense. Reimbursement of the 13 expenses shall be as set forth in procedures established by the 14 appointing authority.

15 22. The Department of Human Services:

Employees of the Department of Human Services shall be reimbursed for their actual and necessary expenses of travel, lodging and subsistence incurred in the performance of their duties for the purpose of escorting and transporting children or adults in the care or custody of the Department:

- a. for out-of-state visitation, care, treatment and
 placement of a child welfare client,
- b. for out-of-state treatment for or placement of anadult protective services client,

- c. for out-of-state treatment for or placement of a
 resident of a state resource center, or
- 3 d. for out-of-state treatment for or placement of an
 4 individual with a developmental disability who is
 5 living in the community in community residential
 6 services.

7 Expenses claimed shall be approved by the appropriate Division8 Administrator or Associate Director prior to reimbursement.

9

23. The Banking Department:

10 The actual and necessary expenses of travel and lodging incurred 11 by the Commissioner and other employees of the Banking Department in 12 the performance of their duties for the Banking Department shall be 13 paid or reimbursed by the Banking Department to each employee 14 incurring the expenses. The expenses shall be approved by the 15 Banking Commissioner prior to payment or reimbursement.

16 24. Oklahoma Office of Homeland Security:

17 The actual and necessary expenses of travel, lodging, and 18 subsistence incurred by the Oklahoma Homeland Security Director, as 19 a result of the duties and responsibilities of the Director, shall 20 be paid or reimbursed by the Oklahoma Office of Homeland Security.

21

25. The Grand River Dam Authority:

The actual and necessary expenses of travel and lodging incurred by the Board of Directors and other employees of the district in the performance of their duties for the Grand River Dam Authority shall be paid or reimbursed by the district to each Director or employee incurring the expenses. The expenses shall be approved by the General Manager of the Grand River Dam Authority prior to payment or reimbursement.

5 26. The Native American Cultural and Educational Authority:
6 The actual and necessary expenses incurred by the Directors and
7 employees of the Native American Cultural and Educational Authority
8 in performances of duties. The expenses shall be approved by the
9 Director prior to payment or reimbursement.

10 27. Oklahoma Department of Career and Technology Education: 11 The actual and necessary expenses incurred by the Director and other employees of the Department, authorized by the Director, for 12 13 the purpose of business recruitment, training, and the provision of technical assistance shall be reimbursed. Reimbursement of expenses 14 15 shall be in accordance with rules adopted by the State Board of Career and Technology Education. Expenses claimed, prior to the 16 reimbursement, will be reviewed by the Board and individually 17 approved or disapproved. 18

28. Oklahoma Military Department:

20 <u>The actual and necessary travel expenses incurred by the</u>
21 <u>Director, other employees of the Department and persons performing</u>
22 <u>substantial and necessary services to the state in support of the</u>

7	House of Representatives. The report shall be submitted no later
8	than the first day of September following the end of each fiscal
9	year.
