BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

EDUCATION

SECTION 1. There is hereby appropriated to the Oklahoma  
Education Lottery Trust Fund from any monies not otherwise  
appropriated from the Special Cash Fund of the State Treasury, the  
sum of Ten Million One Hundred Forty-four Thousand One Hundred

1 Seventy-one Dollars (\$10,144,171.00) or so much thereof as may be  
2 necessary pursuant to the provisions of subsection E of Section 713  
3 of Title 3A of the Oklahoma Statutes.

4 SECTION 2. There is hereby appropriated to the State Board of  
5 Education from any monies not otherwise appropriated from the  
6 General Revenue Fund of the State Treasury for the fiscal year  
7 ending June 30, 2018, the sum of One Billion Thirty-six Million Four  
8 Hundred Twenty-nine Thousand Four Hundred Thirty-seven Dollars  
9 (\$1,036,429,437.00) or so much thereof as may be necessary for the  
10 financial support of public schools.

11 SECTION 3. There is hereby appropriated to the State Board of  
12 Education from any monies not otherwise appropriated from the  
13 Education Reform Revolving Fund created in Section 34.89 of Title 62  
14 of the Oklahoma Statutes, the sum of Six Hundred Ninety-five Million  
15 Four Hundred Seven Thousand One Hundred Thirty-eight Dollars  
16 (\$695,407,138.00) or so much thereof as may be necessary for the  
17 financial support of public schools.

18 SECTION 4. The State Board of Education is hereby authorized to  
19 expend during the fiscal year ending June 30, 2018, from the Common  
20 Education Technology Revolving Fund of the State Treasury, the sum  
21 of Forty-seven Million Three Hundred Seventy-two Thousand Two  
22 Hundred Ninety-nine Dollars (\$47,372,299.00) or so much thereof as  
23 may be necessary for the financial support of public schools.

1 SECTION 5. There is hereby appropriated to the State Board of  
2 Education from any monies not otherwise appropriated from the  
3 Mineral Leasing Fund of the State Treasury for the fiscal year  
4 ending June 30, 2018, the sum of Four Million Two Hundred Seventy-  
5 five Thousand Dollars (\$4,275,000.00) or so much thereof as may be  
6 necessary for the financial support of public schools.

7 SECTION 6. There is hereby appropriated to the State Board of  
8 Education from any monies not otherwise appropriated from the  
9 Mineral Leasing Fund of the State Treasury for the fiscal year  
10 ending June 30, 2016, the sum of Two Million Six Hundred Twenty-four  
11 Thousand Thirty-eight Dollars (\$2,624,038.00) or so much thereof as  
12 may be necessary for the financial support of public schools.

13 SECTION 7. There is hereby appropriated to the State Board of  
14 Education from any monies not otherwise appropriated from the  
15 Oklahoma Education Lottery Trust Fund of the State Treasury for the  
16 fiscal year ending June 30, 2018, the sum of Twenty-five Million  
17 Nine Hundred Thirty-nine Thousand Nine Hundred Ten Dollars  
18 (\$25,939,910.00) or so much thereof as may be necessary for the  
19 financial support of public schools.

20 SECTION 8. There is hereby appropriated to the State Board of  
21 Education from any monies not otherwise appropriated from the  
22 Oklahoma Education Lottery Trust Fund of the State Treasury for the  
23 fiscal year ending June 30, 2016, the sum of Five Million Four  
24 Hundred Twenty-nine Thousand Eight Hundred Forty-four Dollars

1 (\$5,429,844.00) or so much thereof as may be necessary for the  
2 financial support of public schools.

3 SECTION 9. Notwithstanding any other provision of law, the  
4 State Board of Education is hereby authorized to expend during the  
5 fiscal year ending June 30, 2018, from the School Consolidation  
6 Assistance Fund (260 Fund), the sum of Two Million Five Hundred  
7 Thousand Dollars (\$2,500,000.00) or so much thereof as may be  
8 necessary for the financial support of public schools.

9 SECTION 10. There is hereby appropriated to the State Board of  
10 Education from any monies not otherwise appropriated from the  
11 General Revenue Fund of the State Treasury for the fiscal year  
12 ending June 30, 2018, the sum of Ninety-two Million Seventy-four  
13 Thousand Thirty-three Dollars (\$92,074,033.00) or so much thereof as  
14 may be necessary for the support of public schools activities.

15 SECTION 11. There is hereby appropriated to the State Board of  
16 Education from any monies not otherwise appropriated from the  
17 General Revenue Fund of the State Treasury for the fiscal year  
18 ending June 30, 2018, the sum of Two Hundred Ninety-nine Million  
19 Three Hundred Twenty Thousand Three Hundred Forty Dollars  
20 (\$299,320,340.00) or so much thereof as may be necessary for the  
21 Certified Employee Health Benefit Allowance.

22 SECTION 12. There is hereby appropriated to the State Board of  
23 Education from any monies not otherwise appropriated from the  
24 General Revenue Fund of the State Treasury for the fiscal year

1 ending June 30, 2018, the sum of One Hundred Sixty-three Million  
2 Three Hundred Seventy-five Thousand Six Hundred Twenty-seven Dollars  
3 (\$163,375,627.00) so much thereof as may be necessary for the  
4 Support Personnel Health Benefit Allowance.

5 SECTION 13. There is hereby appropriated to the State Board of  
6 Education from any monies not otherwise appropriated from the  
7 General Revenue Fund of the State Treasury for the fiscal year  
8 ending June 30, 2018, the sum of Fifteen Million Six Hundred Eighty-  
9 one Thousand One Hundred Five Dollars (\$15,681,105.00) or so much  
10 thereof as may be necessary for administrative and support functions  
11 of the State Department of Education.

12 SECTION 14. There is hereby appropriated to the State Board of  
13 Education from any monies not otherwise appropriated from the  
14 Oklahoma Education Lottery Trust Fund of the State Treasury for the  
15 fiscal year ending June 30, 2018, the sum of Two Million Eight  
16 Hundred Eighty-two Thousand Two Hundred Thirteen Dollars  
17 (\$2,882,213.00) or so much thereof as may be necessary for transfer  
18 to the School Consolidation Assistance Fund.

19 SECTION 15. There is hereby appropriated to the State Board of  
20 Education from any monies not otherwise appropriated from the  
21 Oklahoma Education Lottery Trust Fund of the State Treasury for the  
22 fiscal year ending June 30, 2016, the sum of Six Hundred Three  
23 Thousand Three Hundred Sixteen Dollars (\$603,316.00) or so much  
24

1 thereof as may be necessary for transfer to the School Consolidation  
2 Assistance Fund.

3 SECTION 16. There is hereby appropriated to the State Board of  
4 Education from any monies not otherwise appropriated from the  
5 Oklahoma Education Lottery Trust Fund of the State Treasury for the  
6 fiscal year ending June 30, 2018, the sum of Two Million Eight  
7 Hundred Eighty-two Thousand Two Hundred Thirteen Dollars  
8 (\$2,882,213.00) or so much thereof as may be necessary for transfer  
9 to the Teachers' Retirement System Dedicated Revenue Revolving Fund.

10 SECTION 17. There is hereby appropriated to the State Board of  
11 Education from any monies not otherwise appropriated from the  
12 Oklahoma Education Lottery Trust Fund of the State Treasury for the  
13 fiscal year ending June 30, 2016, the sum of Six Hundred Three  
14 Thousand Three Hundred Sixteen Dollars (\$603,316.00) or so much  
15 thereof as may be necessary for transfer to the Teachers' Retirement  
16 System Dedicated Revenue Revolving Fund.

17 SECTION 18. There is hereby appropriated to the Oklahoma Arts  
18 Council from any monies not otherwise appropriated from the General  
19 Revenue Fund of the State Treasury for the fiscal year ending June  
20 30, 2018, the sum of Two Million Seven Hundred Ninety-five Thousand  
21 One Hundred Eighty-one Dollars (\$2,795,181.00) or so much thereof as  
22 may be necessary to perform the duties imposed upon the Oklahoma  
23 Arts Council by law.

1 SECTION 19. There is hereby appropriated to the State Board of  
2 Career and Technology Education from any monies not otherwise  
3 appropriated from the General Revenue Fund of the State Treasury for  
4 the fiscal year ending June 30, 2018, the sum of One Hundred Eight  
5 Million One Hundred Eighty-one Thousand Four Hundred Seventy-seven  
6 Dollars (\$108,181,477.00) or so much thereof as may be necessary to  
7 perform the duties imposed upon the State Board of Career and  
8 Technology Education by law.

9 SECTION 20. There is hereby appropriated to the State Board of  
10 Career and Technology Education from any monies not otherwise  
11 appropriated from the Oklahoma Education Lottery Trust Fund of the  
12 State Treasury for the fiscal year ending June 30, 2018, the sum of  
13 Three Million One Hundred Seventy Thousand Four Hundred Thirty-three  
14 Dollars (\$3,170,433.00) pursuant to paragraph 2 of subsection C of  
15 Section 713 of Title 3A of the Oklahoma Statutes for allocation by  
16 the State Board of Career and Technology Education for the education  
17 and general operating budgets of the institutions and for other  
18 programs, construction, renovations or repairs administered by the  
19 State Board of Career and Technology Education.

20 SECTION 21. There is hereby appropriated to the State Board of  
21 Career and Technology Education from any monies not otherwise  
22 appropriated from the Oklahoma Education Lottery Trust Fund of the  
23 State Treasury for the fiscal year ending June 30, 2016, the sum of  
24 Six Hundred Sixty-three Thousand Six Hundred Forty-eight Dollars



1 (\$663,648.00) pursuant to paragraph 2 of subsection C of Section 713  
2 of Title 3A of the Oklahoma Statutes for allocation by the State  
3 Board of Career and Technology Education for the education and  
4 general operating budgets of the institutions and for other  
5 programs, construction, renovations or repairs administered by the  
6 State Board of Career and Technology Education.

7 SECTION 22. Notwithstanding any other provision of law, the  
8 State Board of Career and Technology Education is hereby authorized  
9 to expend during the fiscal year ending June 30, 2018, from the  
10 State Board of Career and Technology Education Revolving Fund (200  
11 Fund), the sum of Five Hundred Thousand Dollars (\$500,000.00) or so  
12 much thereof as may be necessary to perform the duties imposed upon  
13 the State Board of Career and Technology Education by law.

14 SECTION 23. There is hereby appropriated to the Office of  
15 Educational Quality and Accountability from any monies not otherwise  
16 appropriated from the General Revenue Fund of the State Treasury for  
17 the fiscal year ending June 30, 2018, the sum of One Million One  
18 Hundred Nineteen Thousand Eight Hundred Ninety-eight Dollars  
19 (\$1,119,898.00) or so much thereof as may be necessary to perform  
20 the duties imposed upon the Office of Educational Quality and  
21 Accountability by law.

22 SECTION 24. There is hereby appropriated to the Office of  
23 Educational Quality and Accountability from any monies not otherwise  
24 appropriated from the Special Cash Fund of the State Treasury the

1 sum of Five Hundred Thousand Dollars (\$500,000.00) or so much  
2 thereof as may be necessary to perform the duties imposed upon the  
3 Office of Educational Quality and Accountability by law.

4 SECTION 25. There is hereby appropriated to the Oklahoma  
5 Educational Television Authority from any monies not otherwise  
6 appropriated from the General Revenue Fund of the State Treasury for  
7 the fiscal year ending June 30, 2018, the sum of Two Million Six  
8 Hundred Ninety-nine Thousand Nine Hundred Twenty-seven Dollars  
9 (\$2,699,927.00) or so much thereof as may be necessary to perform  
10 the duties imposed upon the Oklahoma Educational Television  
11 Authority by law.

12 SECTION 26. There is hereby appropriated to the Oklahoma State  
13 Regents for Higher Education from any monies not otherwise  
14 appropriated from the General Revenue Fund of the State Treasury for  
15 the fiscal year ending June 30, 2018, the sum of Six Hundred Forty-  
16 six Million Six Hundred Eighty-two Thousand Three Hundred Ninety-six  
17 Dollars (\$646,682,396.00) or so much thereof as may be necessary for  
18 allocation by the Oklahoma State Regents for Higher Education  
19 pursuant to the provisions of Article XIII-a of the Oklahoma  
20 Constitution for the education and general operating budgets of the  
21 institutions and for other programs, construction, renovations or  
22 repairs administered by the Oklahoma State Regents for Higher  
23 Education. Of those funds appropriated, the sum of Three Million  
24 Thirteen Thousand One Hundred Thirty-nine Dollars (\$3,013,139.00)

1 shall be transferred to the Oklahoma Tuition Equalization Grant  
2 Trust Fund to implement the provisions of the Oklahoma Tuition  
3 Equalization Grant Act.

4 SECTION 27. The Oklahoma State Regents for Higher Education are  
5 hereby authorized to expend during the fiscal year ending June 30,  
6 2018, the sum of Forty-seven Million Three Hundred Seventy-two  
7 Thousand Two Hundred Ninety-nine Dollars (\$47,372,299.00) from the  
8 Higher Education Capital Revolving Fund of the State Treasury for  
9 allocation by the Oklahoma State Regents for Higher Education  
10 pursuant to the provisions of Article XIII-a of the Oklahoma  
11 Constitution for the education and general operating budgets of the  
12 institutions and for other programs, construction, renovations or  
13 repairs administered by the Oklahoma State Regents for Higher  
14 Education.

15 SECTION 28. The Oklahoma State Regents for Higher Education are  
16 hereby authorized to expend during the fiscal year ending June 30,  
17 2018, the sum of Forty-seven Million Three Hundred Seventy-two  
18 Thousand Two Hundred Ninety-nine Dollars (\$47,372,299.00) from the  
19 Oklahoma Student Aid Revolving Fund of the State Treasury for  
20 allocation by the Oklahoma State Regents for Higher Education  
21 pursuant to the provisions of Article XIII-a of the Oklahoma  
22 Constitution for the education and general operating budgets of the  
23 institutions and for other programs, construction, renovations or  
24

1 repairs administered by the Oklahoma State Regents for Higher  
2 Education.

3 SECTION 29. There is hereby appropriated to the Oklahoma State  
4 Regents for Higher Education from any monies not otherwise  
5 appropriated from the General Revenue Fund of the State Treasury for  
6 the fiscal year ending June 30, 2018, the sum Nine Hundred Seventy  
7 Thousand Nine Hundred Forty Dollars (\$970,940.00) or so much thereof  
8 as may be necessary for expenditures for concurrent enrollment  
9 pursuant to Section 628.13 of Title 70 of the Oklahoma Statutes.

10 SECTION 30. There is hereby appropriated to the Oklahoma State  
11 Regents for Higher Education from any monies not otherwise  
12 appropriated from the Oklahoma Education Lottery Trust Fund of the  
13 State Treasury for the fiscal year ending June 30, 2018, the sum of  
14 Twenty-two Million Seven Hundred Sixty-nine Thousand Four Hundred  
15 Seventy-seven Dollars (\$22,769,477.00) pursuant to paragraph 2 of  
16 subsection C of Section 713 of Title 3A of the Oklahoma Statutes for  
17 allocation by the Oklahoma State Regents for Higher Education  
18 pursuant to the provisions of Article XIII-a of the Oklahoma  
19 Constitution for construction, renovations or repairs administered  
20 by the Oklahoma State Regents for Higher Education or for any other  
21 purpose authorized by paragraph 2 of subsection C of Section 713 of  
22 Title 3A of the Oklahoma Statutes.

23 SECTION 31. There is hereby appropriated to the Oklahoma State  
24 Regents for Higher Education from any monies not otherwise

1 appropriated from the Oklahoma Education Lottery Trust Fund of the  
2 State Treasury for the fiscal year ending June 30, 2016, the sum of  
3 Four Million Seven Hundred Sixty-six Thousand One Hundred Ninety-  
4 seven Dollars (\$4,766,197.00) pursuant to paragraph 2 of subsection  
5 C of Section 713 of Title 3A of the Oklahoma Statutes for allocation  
6 by the Oklahoma State Regents for Higher Education pursuant to the  
7 provisions of Article XIII-a of the Oklahoma Constitution for  
8 construction, renovations or repairs administered by the Oklahoma  
9 State Regents for Higher Education or for any other purpose  
10 authorized by paragraph 2 of subsection C of Section 713 of Title 3A  
11 of the Oklahoma Statutes.

12 SECTION 32. There is hereby appropriated to the Oklahoma State  
13 Regents for Higher Education from any monies not otherwise  
14 appropriated from the General Revenue Fund of the State Treasury for  
15 the fiscal year ending June 30, 2018, the sum of Three Million Six  
16 Hundred Sixty-four Thousand Fifty-two Dollars (\$3,664,052.00) or so  
17 much thereof as may be necessary for the general operating budget of  
18 the Administrative Offices of the Oklahoma State Regents for Higher  
19 Education.

20 SECTION 33. There is hereby appropriated to the Commissioners  
21 of the Land Office from any monies not otherwise appropriated from  
22 the Commissioners of the Land Office Fund of the State Treasury for  
23 the fiscal year ending June 30, 2018, the sum of Eight Million Five  
24 Hundred Thirty-eight Thousand Six Hundred Dollars (\$8,538,600.00) or

1 so much thereof as may be necessary to perform the duties imposed  
2 upon the Commissioners of the Land Office by law.

3 SECTION 34. There is hereby appropriated to the Oklahoma  
4 Department of Libraries from any monies not otherwise appropriated  
5 from the General Revenue Fund of the State Treasury for the fiscal  
6 year ending June 30, 2018, the sum of Four Million Three Hundred  
7 Eighty-six Thousand Seven Hundred Eighty Dollars (\$4,386,780.00) or  
8 so much thereof as may be necessary to perform the duties imposed  
9 upon the Oklahoma Department of Libraries by law.

10 SECTION 35. There is hereby appropriated to the Physician  
11 Manpower Training Commission from any monies not otherwise  
12 appropriated from the General Revenue Fund of the State Treasury for  
13 the fiscal year ending June 30, 2018, the sum of Two Million Nine  
14 Hundred Fourteen Thousand Eight Hundred Forty Dollars  
15 (\$2,914,840.00) or so much thereof as may be necessary to perform  
16 the duties imposed upon the Physician Manpower Training Commission  
17 by law.

18 SECTION 36. There is hereby appropriated to the Physician  
19 Manpower Training Commission from any monies not otherwise  
20 appropriated from the Special Cash Fund of the State Treasury the  
21 sum of Four Hundred Thousand Dollars (\$400,000.00) or so much  
22 thereof as may be necessary to perform the duties imposed upon the  
23 Physician Manpower Training Commission by law.

1 SECTION 37. There is hereby appropriated to the Board of  
2 Trustees of the Oklahoma School of Science and Mathematics from any  
3 monies not otherwise appropriated from the General Revenue Fund of  
4 the State Treasury for the fiscal year ending June 30, 2018, the sum  
5 of Six Million One Hundred Twenty-one Thousand Seven Hundred Nine  
6 Dollars (\$6,121,709.00) or so much thereof as may be necessary to  
7 perform the duties imposed upon the Board of Trustees of the  
8 Oklahoma School of Science and Mathematics by law.

9 SECTION 38. There is hereby appropriated to the Oklahoma Center  
10 for the Advancement of Science and Technology from any monies not  
11 otherwise appropriated from the General Revenue Fund of the State  
12 Treasury for the fiscal year ending June 30, 2018, the sum of  
13 Thirteen Million Four Hundred Twenty-two Thousand Eight Hundred  
14 Ninety-two Dollars (\$13,422,892.00) or so much thereof as may be  
15 necessary to perform the duties imposed upon the Oklahoma Center for  
16 the Advancement of Science and Technology by law. Of those funds  
17 appropriated, the sum of Five Million Three Hundred Sixty-nine  
18 Thousand One Hundred Fifty-seven Dollars (\$5,369,157.00) shall be  
19 deposited in the Research Support Revolving Fund, created pursuant  
20 to Section 5060.11 of Title 74 of the Oklahoma Statutes. Of those  
21 funds appropriated, the sum of Two Million Nine Hundred Fifty-three  
22 Thousand Thirty-six Dollars (\$2,953,036.00) shall be deposited in  
23 the Seed-capital Revolving Fund, created pursuant to Section 5060.21  
24 of Title 74 of the Oklahoma Statutes.

1 GENERAL GOVERNMENT AND TRANSPORTATION

2 SECTION 39. There is hereby appropriated to the Office of the  
3 Attorney General from any monies not otherwise appropriated from the  
4 General Revenue Fund of the State Treasury for the fiscal year  
5 ending June 30, 2018, the sum of Nine Million One Hundred Sixty-four  
6 Thousand Four Hundred Fifty-nine Dollars (\$9,164,459.00) or so much  
7 thereof as may be necessary to perform the duties imposed upon the  
8 Office of the Attorney General by law.

9 SECTION 40. There is hereby appropriated to the Office of the  
10 Attorney General from any monies not otherwise appropriated from the  
11 General Revenue Fund of the State Treasury for the fiscal year  
12 ending June 30, 2018, the sum of Nine Hundred Four Thousand Seven  
13 Hundred Twenty-six Dollars (\$904,726.00) to transfer to the Legal  
14 Services Revolving Fund, created pursuant to subsection G of Section  
15 921.1 of Title 12 of the Oklahoma Statutes.

16 SECTION 41. REAPPROPRIATION AND REDESIGNATION The amount  
17 of One Million Nine Hundred Thousand Dollars (\$1,900,000.00) of the  
18 original appropriation of Five Million Dollars (\$5,000,000.00),  
19 appropriated to the Office of the Attorney General by Section 154,  
20 Chapter 311, O.S.L. 2012, from any monies not otherwise appropriated  
21 from the Special Cash Fund of the State Treasury, for the  
22 prosecution and defense of claims related to water and water rights  
23 in Oklahoma, is hereby reappropriated and redesignated to perform  
24 the duties imposed upon the Office of the Attorney General by law.



1 If, on the date this act is approved, any of the amount originally  
2 appropriated, as adjusted by expenditures, encumbrances and  
3 transfers, results in an unencumbered balance less than the  
4 reappropriated and redesignated amount, that reappropriated and  
5 redesignated amount is reduced to the unencumbered amount.

6 SECTION 42. For the fiscal year ending June 30, 2018, the  
7 Office of the Attorney General is authorized to transfer an amount  
8 not to exceed Three Hundred Twenty Thousand Four Hundred Thirty  
9 Dollars (\$320,430.00) from the Office of the Attorney General's  
10 Evidence Fund (700 Fund), created by Section 19 of Title 74 of the  
11 Oklahoma Statutes, to the Office of the Attorney General's Revolving  
12 Fund (200 Fund), created by Section 20 of Title 74 of the Oklahoma  
13 Statutes.

14 SECTION 43. There is hereby appropriated to the Office of the  
15 State Auditor and Inspector from any monies not otherwise  
16 appropriated from the General Revenue Fund of the State Treasury for  
17 the fiscal year ending June 30, 2018, the sum of Three Million One  
18 Hundred Thirty-eight Thousand Four Hundred Fifty-seven Dollars  
19 (\$3,138,457.00) or so much thereof as may be necessary to perform
