10 AMENDMENT NO. 1. Replace the stricken title, enacting clause and  
11 entire bill and insert

13 "An Act relating to law enforcement training;  
14 amending Section 3, Chapter 376, O.S.L. 2016 (70  
15 O.S. Supp. 2016, Section 3311.15), which relates to  
16 the assessment for meals; modifying certain fee; and  
17 providing an effective date.

18 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

19 SECTION 1. AMENDATORY Section 3, Chapter 376, O.S.L.  
20 2016 (70 O.S. Supp. 2016, Section 3311.15), is amended to read as  
21 follows:

22 Section 3311.15 Notwithstanding any other provision of law, the  
23 Council on Law Enforcement Education and Training (CLEET) is hereby  
24 authorized to assess a ~~charge~~ registration fee not to exceed ~~Twenty~~

1 ~~Dollars (\$20.00)~~ Thirty Dollars (\$30.00) per day to any Oklahoma Law  
2 Enforcement Agency ~~for payment of breakfast and lunch expenses,~~  
3 ~~incurred~~ to cover the costs of breakfast, lunch and dinner meals  
4 provided by CLEET, during the training of agency peace officers.  
5 Failure to timely pay these charges will preclude future  
6 participation of any employee of the law enforcement agency in the  
7 CLEET Basic Academy. All moneys from charges assessed for these  
8 purposes shall be deposited in the Peace Officer Revolving Fund  
9 created in Section 3311.7 of ~~Title 70 of the Oklahoma Statutes~~ this  
10 title.

11 SECTION 2. This act shall become effective November 1, 2017."
