17	BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:								
18	SECTION 1. AMENDATORY 26 O.S. 2021, Section 4-121, as								
19	amended by Section 20, Chapter 282, O.S.L. 2022 (26 O.S. Supp. 2022,								
20	Section 4-121), is amended to read as follows:								
21	Section 4-121. A. The Secretary of the State Election Board								
22	may join the State of Oklahoma as a member in one or more multistate								
23	voter list maintenance organizations including, but not limited to,								
24	the Electronic Registration Information Center (ERIC) or its								

- successor. The Secretary is authorized to expend funds as available
 for membership fees, dues and other expenses related to such
 membership. Prior to the State of Oklahoma joining a multistate

 voter list maintenance organization, the organization shall certify
 in writing to the Secretary of the State Election Board that
 membership in the organization meets the requirements of this
- B. Upon membership in an organization as provided in subsection 8 9 A of this section, the Secretary of the State Election Board may 10 provide voter registration data to the organization and Service Oklahoma may provide motor vehicle license data to the organization 11 12 if such data is required to be provided as a condition of membership. The voter registration data and motor vehicle license 13 data described in this subsection may include a person's name, 14 address, date of birth, driver license or state identification 15 number, last four digits of a Social Security number or any other 16 data required by the organization. Service Oklahoma shall not 17 provide motor vehicle license data for persons who are identified as 18 not being citizens of the United States or whose citizenship status 19 is unknown. The transmission and storage of such data shall be done 20 in a secure manner. 21
 - C. $\underline{1}$. If a multistate voter list maintenance organization of which this state is a member identifies Oklahoma residents who are citizens of the United States eligible to vote but not yet

- registered, the Secretary of the State Election Board may notify

 such citizens about the procedure for obtaining a voter registration

 application and becoming a registered voter in this state. The

 notification shall not include a voter registration application.
 - 2. The multistate voter list maintenance organization shall certify that, to the best of its knowledge, all persons it identifies as eligible to vote but not yet registered are citizens of the United States.
 - 3. The Secretary may delegate the contacting of such citizens to the secretary of the appropriate county election board.
 - D. If a multistate voter list maintenance organization of which this state is a member provides United States Postal Service

 National Change of Address data regarding registered voters who have changed their address of residence within the state, the Secretary of the State Election Board may use the data pursuant to the provisions of Section 4-118.1, 4-120.2 or 7-115.1 of Title 26 of the Oklahoma Statutes or the federal National Voter Registration Act.
 - E. A multistate voter list maintenance organization of which
 this state is a member shall not provide or release any voter
 registration data or motor vehicle license data received from this
 state to any other party. Provided, however, such organization may
 provide relevant matching information to a member state regarding
 duplicate registrations, deaths, or changes of residency involving
 persons identified in the data provided by this state. Any verified

evidence that indicates that any voter registration data or motor 1 vehicle license data for this state is being used for purposes 2 unrelated to voter roll maintenance or is being used for or is being 3 4 released to any third party, except as provided in this subsection, 5 shall result in the immediate withdrawal of this state from the multistate voter list maintenance organization. Verified evidence 6 may include Oklahoma Open Records Act documents reviewed during 7 investigation by the Legislature or the Secretary of the State 8 9 Election Board that indicate that such activity is occurring. F. The Oklahoma Attorney General shall have the authority to 10 bring a civil action against the multistate voter list maintenance 11 12 organization in a district court of this state for damages caused by 13 a violation of subsection E of this section. If the Attorney General declines to pursue action, the Secretary of the State 14 Election Board or the Legislature by a majority vote may initiate an 15

- H. The Secretary of the State Election Board shall cause to be published annually on the website of the State Election Board the following statistical information:
- 1. The number of voter registrations by county that are canceled on the basis of information received from the multistate voter list maintenance organization, and the reason for the cancellation;
- 2. The number of registered voters by county required to receive an address confirmation mailing on the basis of information received from the multistate voter list maintenance organization;
- 3. The number of mailings by county for persons identified in subsection C of this section; and
 - 4. Such other statistical information deemed appropriate by the Secretary of the State Election Board.

1	Section 7-103.2. A. 1. County election boards shall maintain

5	2. The list shall only be shared with a court system if that								
6	court system agrees to regularly provide the names of persons								
7	convicted of a felony in that court system to the Secretary of the

11	3. The publicly available voter list shall note any voter for								
12	whom a first-class mailing from the county election board or the
