16	is created a duplication in numbering, reads as follows:
17	A. There is hereby created until July 1, 2027, the Oklahoma
18	Commission on Chinese Foreign Influence, which shall consist of
19	seven (7) members and shall be comprised as follows:
20	1. The Governor, who shall serve as chairperson, or designee;
21	2. One member who has expertise in foreign policy in the Asian
22	region, appointed by the Governor;

- 3. One member who has expertise in military affairs related to United States Indo-Pacific Command (USINDOPACOM), appointed by the Governor;
  - 4. The Attorney General, or designee;
  - 5. The Commissioner of Public Safety, or designee;
  - The Homeland Security Advisor, or designee; and 6.
  - 7. The Director of the Department of Commerce, or designee.
- В. The Commission shall study, evaluate, and make recommendations for any changes to state policy, rules, or statutes to combat the influence of the Chinese Communist Party and government of China in Oklahoma.
- The Commission shall meet at least quarterly at the call of the chair and prepare and issue a report of its findings and recommendations to the Governor, President Pro Tempore of the Senate, and Speaker of the House of Representatives by July 1, 2023, and each year thereafter no later than July 1 of each year.
- Members of the Commission shall receive no compensation for D. serving on the Commission, but shall receive travel reimbursement as follows:
- State employees who are members of the Commission shall be reimbursed for necessary travel expenses incurred in the performance of their duties by their respective agencies in accordance with the State Travel Reimbursement Act; and

1	2. All other members of the Commission shall be reimbursed by
2	the Office of Management and Enterprise Services for necessary
3	travel expenses incurred in the performance of their duties in
4	accordance with the State Travel Reimbursement Act.
5	SECTION 2. It being immediately necessary for the preservation
6	of the public peace, health or safety, an emergency is hereby
7	declared to exist, by reason whereof this act shall take effect and
8	be in full force from and after its passage and approval.
