An Act relating to memorial bridge designations; designating the CPL Wilfred Flores Jr. Memorial Bridge; designating the SPC Cody Levi Cookson Memorial Bridge; requiring certain markers; providing for codification; and providing an effective date.

SUBJECT: Memorial bridge designations

BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

SECTION 1. NEW LAW A new section of law to be codified in the Oklahoma Statutes as Section 1698.250 of Title 69, unless there is created a duplication in numbering, reads as follows:

The bridge over Medicine Bluff Creek on Interstate 44 located approximately two and one-half (2 1/2) miles north of U.S. Highway 62 West shall be designated as the "CPL Wilfred Flores Jr. Memorial Bridge". The Department of Transportation shall cause suitable permanent markers bearing that name to be placed on the bridge.

SECTION 2. NEW LAW A new section of law to be codified in the Oklahoma Statutes as Section 1698.251 of Title 69, unless there is created a duplication in numbering, reads as follows: The bridge over Ross Lake on U.S. Highway 62 in Muskogee County shall be designated as the "SPC Cody Levi Cookson Memorial Bridge". The Department of Transportation shall cause suitable permanent markers bearing that name to be placed on the bridge.

SECTION 3. This act shall become effective November 1, 2017.
