7 (c) <u>3.</u> The officer shall thereupon release the cited person
8 from any custody.

9 (d) <u>4.</u> As soon as practicable, the officer shall file one copy
10 of the citation with the court specified therein and shall deliver
11 one copy to the prosecuting attorney.

12 (3) C. In any case in which the judicial officer finds sufficient grounds for issuing a warrant, he or she may issue a 13 summons commanding the defendant to appear in lieu of a warrant. 14 15 (4) D. If a person summoned fails to appear in response to the summons, a warrant for his arrest shall issue, and any person who 16 willfully fails to appear in response to a summons is guilty of a 17 misdemeanor; provided, however, any charges or warrant for failure 18 to appear shall be dismissed if the person can show the court that 19 the person was incarcerated or otherwise detained by law enforcement 20 at the time of the failure to appear. 21 SECTION 2. This act shall become effective November 1, 2019. 22
