18	Section 1406. Except as otherwise provided in Section 1 of this
19	act, every Every retailer or vendor maintaining places of business
20	both within and without this state and making sales of tangible
21	personal property from a place of business outside this state for
22	use in this state shall at the time of making such sales collect the
23	use <u>sales</u> tax levied by Section 1401 <u>Section 1350</u> et seq. of this

1 therefor in the manner and form prescribed by the Tax Commission, if 2 the Tax Commission shall, by regulation, require such receipt. Each 3 retailer or vendor shall list with the Tax Commission the name and 4 address of all the retailer's or vendor's agents operating in this 5 state and location of any and all distribution or sales houses or 6 offices or other places of business in this state. The retailer or 7 vendor shall not collect the use tax levied by Section 1402 of this 8 title from a purchaser who is a holder of a direct payment permit 9 issued pursuant to Section 1364.1 of this title. 10 SECTION 2. REPEALER 68 O.S. 2011, Sections 1406.1, 11 Section 4, Chapter 311, O.S.L. 2016, 1407, 1407.1, 1407.2, as 12 amended by Section 5, Chapter 311, O.S.L. 2016, 1407.3, as amended 13 by Section 6, Chapter 311, O.S.L. 2016, 1407.5 and 1408 (68 O.S. 14 Supp. 2018, Sections 1406.2, 1407.2 and 1407.3), are hereby 15 repealed. 16 SECTION 3.
